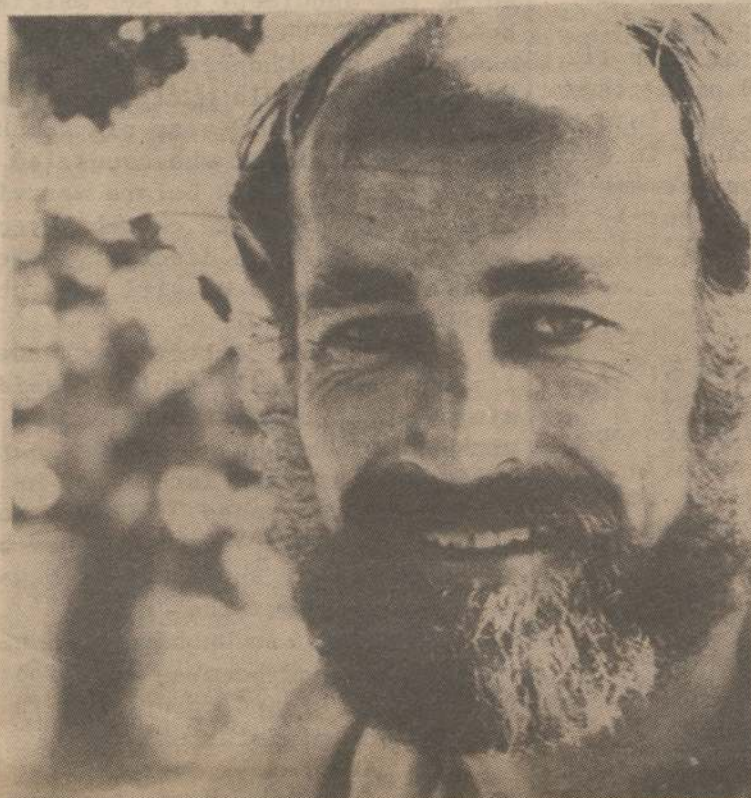


California Teacher Plans Suit Against Anti-Gay Group

HERALDSBURG, CA (GCN) - Teacher Larry Berner, who became a target of attacks by State Senator John Briggs and his group Defend Our Children during the recent campaign to pass the anti-Gay Proposition 6, is planning to sue that group, Heraldsburg school board president Lee Lee, and television station KNBC in Los Angeles. Although according to Berner and his attorney, Jerel McCray, Berner was subjected to a series of attacks in the media, the suit will be concerned mainly with a television commercial for Yes On 6 campaign.

In the ad, said Berner, "Mrs. Lee Lee said that in her school district there was a second-grade teacher who uses his status as a teacher to promote homosexuality. Then an announcer comes on and says, 'What they do in private is their own business, but when, like this teacher, they bring it into the classroom, it becomes everybody's business.'" Although Berner was not specifically mentioned or pictured in the ad, he claimed that his identity was obvious because "I'm the only openly Gay second-grade teacher in Heraldsburg; I'm the only male second-grade teacher in Heraldsburg, and they used the male pronoun. The ad was scheduled to appear on eight stations throughout Southern California, but it was withdrawn by seven of the stations after they were contacted by McCray, Berner said. The eighth station KNBC, refused to withdraw the ad, and so is being included in the suit.

Proceedings for the suit have not yet begun, since details have yet to be worked out, McCray explained. "It's conceivable that we might bring these suits separately, because there are many things that Lee Lee and Defend Our Children did, aside from what the television station ran. So we might end up with three different damage figures in three different suits.

Berner said that he was attacked directly as well as by implication. He quoted Lee as saying, "Larry Berner doesn't teach reading, writing and arithmetic in his classroom, he teaches reading, writing and homosexuality." "Briggs also - at one point stated to the *San Francisco Chronicle* that 'Larry Berner is the only teacher in this

Discrimination Against Gays Outlawed in Detroit

DETROIT, MI (GCN) - On Wednesday, January 24, the Detroit City Council passed a new city ordinance. The 34-page comprehensive Omnibus Human Rights Ordinance, with strong enforcement powers, was presented by the Human Rights Department. It had broad based community support, including the Gay support represented by the state-wide organization Michigan Organization for Human Rights (MOHR). The ordinance passed by a vote of 8 to 1, with council member Jack Kelly voting against it.

Earlier the Council took a roll call vote on a mutually exclusive ordinance. This short form measure, put forward by the law department with Mayor Coleman Young's support, was permanently postponed by a unanimous vote of 9 to 0. That proposed ordinance had no power of enforcement except in the area of city contract compliance. The passed ordinance makes Detroit, the fifth largest American city, the largest to specifically outlaw discrimination against sexual minorities. It also gives Detroit one of the most comprehensive sets of protections with strong powers of enforcement.

Don Mager, Project Facilitator of MOHR, was at the hearing almost seven years ago when the idea of sexual orientation protection was first incorporated into Chapter 10 of the City Charter. Speculating on why the measure passed now, Mager noted, "I think we have an unusually social-justice-minded City Council and they felt an urgency to register a strong check to efforts across the country to dismantle the civil rights gains of the sixties. I think the Council showed one of its better hours, because they are in full knowledge that this ordinance may take the city through a series of court litigations since the State Attorney General ruled in September, 1978 that cities have no valid role in anti-discrimination enforcements."

Commenting on the sexual orientation aspects of the ordinance, Mager said, "No one snuck anything through. The Council and the media have made it common knowledge that that this ordinance includes Gay rights sections. Ever since the Charter was passed, Detroit seems to be content with protecting Gay rights, since no major opposition has been mounted. Even the Archdiocese did not choose to oppose any sections this time." The ordinance passed in Detroit includes specific enforcement procedures against discrimination in the areas of equal access to educational opportunities, employment, medical care, housing, rentals, real estate purchases and equal access to places of resort and amusement. In each section of the new measure, "sexual orientation" is listed as an area against which discrimination is specifically outlawed.

state who goes around flaunting his homosexuality in the classroom'," Berner said. It's in the area of what's called slander *per se* - which means that if you're talking about an individual in his or her profession, and specifically indicate that they have done something unprofessional, then it's a different animal altogether from regular slander. You don't have to prove actual damages, because it's presumed that if you slander a person in their profession that's damage enough.

According to Berner the Heraldsburg community was solidly supportive of him. "Within school, 19 out of 21 teachers were firmly committed behind me, were with me solidly. A rather large group of parents campaigned against Proposition 6; got together because I had taught their children, now or in the past - and in fact, even printed up these really cute T-shirts. In the voters handbook, Briggs had said, 'If you don't think Proposition 6 is necessary, then ask the parents of Heraldsburg.' And so a bunch of women got together and had these T-shirts printed up, 'Ask a Heraldsburg Parent - No on 6.' Those were all over town."

TEXAS CHILD CUSTODY CASE

AUSTIN, TX (GCN) - Marie Parker, a lesbian mother of two, is being sued by her ex-husband for the custody of the daughters. The husband alleges that the children are living with their mother "in an atmosphere of complete homosexuality." The daughters, aged five and three years, have lived with their mother since their births. The father of the children did have custody for one year in violation of a court order and against Parker's wishes.

Those familiar with the case say that without question Parkers is the more able parent, "willing to provide a loving and nurturing environment for the two daughters and a home in which they will continue to grow in health and happiness." Observers note however, that determination of what is "in the best interests of the children," is likely to be made in a somewhat subjective manner. Texas is the only state in the country where child custody cases are decided by jury.

Contributions to Parker, who has hired an attorney and faces fees for psychological evaluations, depositions and witnesses, should be sent to Child Custody Fund, Box 49354, Austin, Texas.

TAKING OVER BARS

NEW YORK CITY (GCN) - Eleven persons were indicted in connection with an alleged organized crime conspiracy and with an attempt to take over after-hours Gay bars in Greenwich Village. During an 18-month investigation involving a task force of city, state and Federal authorities, the indicted people were also allegedly involved in counterfeiting and loansharking.

According to New York State assistant attorney general John Fine, the investigation led to the discovery of more than \$2 million in counterfeit bills and a major marijuana smuggling ring. Among those indicted were Stanley Levy, a teacher from Long Island, and Robert Bianco, an architect in the city's Dept. of Development. Allegedly Bianco helped in getting permits and certificates of occupancy for the Gay bars, one of which was owned by Levy.

TEEN FINDS HER SPOUSE IS A WOMAN

MEMPHIS, TN (UPI) - A teen-age girl is suing for annulment of her marriage because her "husband" turned out to be a woman. The Chancery Court suit filed by the 17-year-old girl charges she was deceived by her 19-year-old spouse. A Memphis minister who counseled the couple for 10 hours before marrying them in an elaborate church ceremony last year said the discovery came as a complete shock to he girl, church members and himself.

"I'm a certified sex therapist. I'm not that easily fooled," said the minister who asked that his name be withheld. "He had masculine characteristics. I learned later that he was taking male hormones." It was not until after the couple left for a new home in Atlanta that the minister began to hear rumors about the "groom." Later, the girl said her husband told her that he was deformed because of a football injury and refused to undress in front of her, the minister said.

About four months after the marriage, the girl heard her husband's parents refer to him by a girl's name when she was out of the room, the minister said.

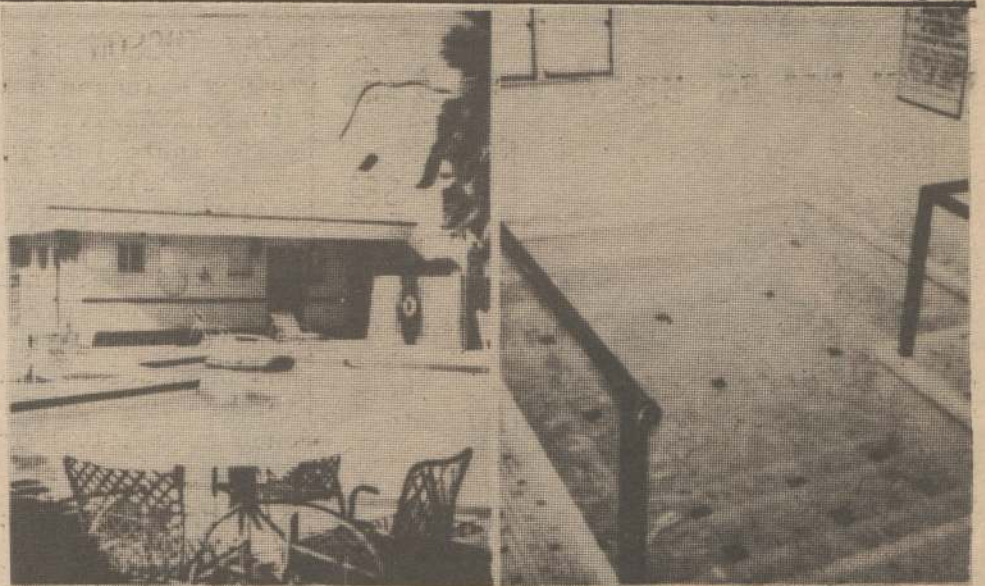
Anti-Gay Bill is Withdrawn in New Jersey

Trenton, NJ (GCN) - A New Jersey state senator, the sponsor of a bill which would criminalize sodomy in that state, reluctantly abandoned his fight on January 24, but warned Gays not to take their victory "out into the street." Sen. Joseph Maressa withdrew his bill before the Senate Judiciary Committee could vote on it. Maressa explained his action by saying "The courts have held these things are permissible in private and . . . to thrust this thing forward would be to ask my colleagues to vote for something that may be unconstitutional."

Maressa said he withdrew the bill because of a recent State Appeals Court decision which decried prosecution for homosexual activities as unconstitutional and an invasion of privacy. Attorney General John Denan, who contends that Maressa's bill is unconstitutional, does not plan to appeal the court ruling. According to Maressa, "There's no question that the judge addressed himself to all the facts and law that relates to this bill. . . . (The decision) clearly indicates that these activities are in the province of spiritual authorities. I don't agree however."

Maressa's bill would have made homosexual acts between consenting adults punishable by up to five years in jail and a \$7,500 fine. The bill, which did not apply to lesbians, was written in reaction to a clause in New Jersey's new penal code which repeals the crime of sodomy. Maressa's bill would have put it back on the books. "I want to keep their activities in the bedroom and not try to sell it to anyone. If that happens, I'm going to get back into the act," Maressa said.

New Jersey's new penal code and Maressa's bill have focused national attention on the State House. Last year, when the Senate adopted the new penal code, anti-Gay protestors called the lawmakers "perverts." Maressa blamed the press for some of the highly emotional opposition to the bill. "I never intended to put anyone in jail, break into anyone's bedroom or break down any doors," he protested. "It's not the homosexual's fault he's homosexual. I just want a stigma attached. I don't want them accepted."

GAY COUPLE WINS \$500 IN HOTEL DISCRIMINATION SUIT*by Jack Jones*

SAN DIEGO - A Gay couple from Los Angeles, Jack Jones and Ryan Hatch, recently won a \$500 settlement resulting from a lawsuit filed in the San Diego Municipal Court which alleged sex discrimination after they were refused admittance to the Pacific Beach Motel in San Diego on August 19, 1978. The lawsuit claimed reservations had been made and confirmed with the motel the previous week, but upon arrival at the motel the owners, an elderly married couple, realized that they had rented the room to two men. Jack and Ryan were then informed that it was against the owners policy to rent to two men. When questioned why, the owners stated that the rooms had closed-circuit adult movies, and of course every time they rent a room of this type to two men, they always bring in two women and destroy the room. Jack and Ryan, who were in San Diego celebrating their anniversary, assured the owners that was the furthest thing from their minds. After many attempts to persuade the owners however, they were still unable to secure the room for the night.

All other accommodations were full in San Diego due to the heavy summer tourist season, so the unfortunate couple were forced to return to their home in Los Angeles that night.

Shortly thereafter, they filed a lawsuit in the San Diego court with the help of a local attorney, G. Randolph Wright. The case used a novel application of the California Unruh Civil Rights Act which forbids public accommodation discrimination on the basis of sex as well as race, color, religion, ancestry, or national origin. It is somewhat questionable whether sexual orientation is covered although according to Attorney General Evelle Younger, "Specifically enumerated forms of discrimination in said Act are illustrative rather than restrictive." Since the motel owners, Mr. and Ms. Mann, apparently did not believe that the couple was Gay, the lawsuit charged the Manns with discrimination based on sex (or gender) rather than sexual orientation.

The Gay couple finally accepted a \$500 out-of-court settlement after it became apparent that legal precedent could not be set without the unlikely event of an Appellate Court hearing. They also declined pressing criminal charges against the hotel owners. According to California Penal Code 365, an innkeeper who refuses accommodations without just cause such as inability to pay, infectious disease or the like, is not only civilly liable, but is guilty of a criminal misdemeanor.

Maine Legislation Proposes to Neuter Convicted Child Molesters

AUGUSTA, ME (GCN) - A bill that proposes to surgically neuter convicted child molesters has been filed by a Maine state legislator. The measure filed by conservative Republican Joyce Lewis, is designed "to prevent child abuse." It is now under review by the state attorney general who is to decide whether the proposal violates the U.S. Constitution's guarantees against cruel and unusual punishment. The Lewis bill stipulates that surgical procedures would render both women and men found guilty under the statute incapable of sexual arousal without harm to the genitalia. It is aimed at people found guilty of gross sexual misconduct involving children under the age of 14.

Carolyn McTeague, program manager for the Maine Children's Protective Services Agency, has given some qualified support to the measure but doubts its effectiveness. She told the *Washington Post*, "Since the act is one of violence rather than sex, I'm not sure anyone could prove these people would stop attacking. The act would very probably result in murder rather than sexual child abuse if the bill is enacted," McTeague said. She has suggested longer prison terms for convicted sexual molesters of children.

Jean Sampson, executive director of the Maine ACLU, expressed vehement opposition to the bill in the *Post* article. "It seems very barbaric, like something out of the Dark Ages. The idea of a civilized society doing that to people is so abhorrent that it far outweighs the benefits to society," Sampson said. A long legislative fight is expected over the measure which observers believe may not pass. Questions have arisen concerning the effectiveness of the Lewis proposal and the constitutional rights of the offender.

John Martin, the Speaker of the House in the legislature, has predicted a long and stormy debate centered on the rights of both the children and the offenders. The bill will come to the floor of the legislature, because under state law, no measure can be killed in committee. "This is the 'Year Of The Child,'" Speaker Martin said to the *Post*, "a year in which a great deal of attention could result in increasing punishment for child sex abusers. But if the attorney general rules it unconstitutional, the bill is dead. It will not gain much support."

Rep. Lewis, who told the *Post* she could "not think of a better way to stop (child abuse)," added that her bill is the "only way I can think of to protect children." Arguing that the proposal to neuter convicted molesters was not cruel and unusual punishment as defined in the Constitution, Lewis said, "The only thing a man couldn't do is have sexual intercourse; it's not like he couldn't hold a job. And a person who thinks it might happen to him might be so scared it would be a deterrent," Lewis told the *Post*. "I only hope and pray some child will have a better weekend because a molester was afraid."

I've always taken good care of my health and, since I am sexually active, always had a VD checkup every 3 months. I haven't had one lately in Tucson because of where the VD clinic is held. Why do they have a clinic in such a "tacky" place?

Dear Cautious:

You sound to me like the type of person who still believes you can catch VD from toilet seats. The health and well-being of your body should be more important to you than the location of your health center. If you want to seem some "tacky" clinics, you should see the one's in Mexico or South America. I have visited the clinic at the MacArthur Hotel and the clinic is clean and efficiently run. The procedures for testing are correct and the staff is well trained.

As for the reason for the clinic's location; the Tucson Gay community should be thankful that Dave and Polly, the owners of the MacArthur, are concerned that the health problems of Gay people are taken care of. They have graciously given their time, money and place of business for the worthy endeavor. It would be nice to have a facility that resembles a medical clinic but so far not one Gay businessman or property owner has come forth to let the clinic use their facilities on a permanent basis.

I do hope you'll remember that your health is far more important than the place you have it taken care of.

Here is a letter I wrote to Bj Bud after her letter (which you reprinted recently) was published in Sunday's Childe Newsletter:

Dear Bj:

I normally believe that private discussion or silence are the best ways to handle differences of opinion among those of us who are attempting to further the cause of Human Rights. However, as a member of the CCR Steering Committee - fellow member with you for several months - I feel that your statement in the Feb. 1979 "Sunday Childe

Newsletter" requires some public response from me.

You write of a number of "...myths....perpetrated by CCR." I do not know what makes a myth, how they start or why they are important to you. CCR, however, has taken some actions - some good, some bad - some successful, some not. In its bylaws, CCR is organized to be a Political and Educational organization. It is against this charter and by its actions that CCR should be judged. All other activities of CCR exist only to support these ends.

In the educational arena, CCR performed some services that I believe to be useful:

- it repeatedly polled the legislators and the candidates in the election; bringing their positions to all we could reach.
- CCR volunteers worked - door to door - in many districts for candidates favorable to us. This included Dist. 25 (Mrs. Camping's). We believe that Mike Moore's work in Dist. 21 contributed significantly to the victory of Richard Kimball, the only non-incumbant favorable to Human Rights elected in Maricopa County.
- It informed Democratic Legislators and Candidates of the threat shown in California's Prop. 6 (Briggs) Over twenty of those contacted thanked CCR and promised to oppose such measures in Arizona.
- CCR secured Gov. Babbitt's promise to veto any Prop. 6 like legislation that reaches his desk.

However overall in Politics; WE LOST.

Almost note of the candidates who favored Human Rights won election to the 34th Legislature. (Outside of Tucson, that is, congratulations to them).

I say WE lost because the laws that you and I seek to change affect us as individuals, not our organizations. CCR, Sunday's Childe, TIN and the other organizations are only methods for achieving our human aims.

It matters not whether we like our various organizations or the people who comprise them. What matters is overcoming our differences and uniting in opposition to those who would deny our Human Rights.

Due to our lack of unity in 1978 and the general apathy of Democratic voters, a legislature has been elected in Arizona which is completely controlled by people who have publically stated that they deny our rights and favor laws which would suppress those rights.

This is a threat. Against it our differences of opinion, our personal piques, and rivalries should seem as childish as they really are.

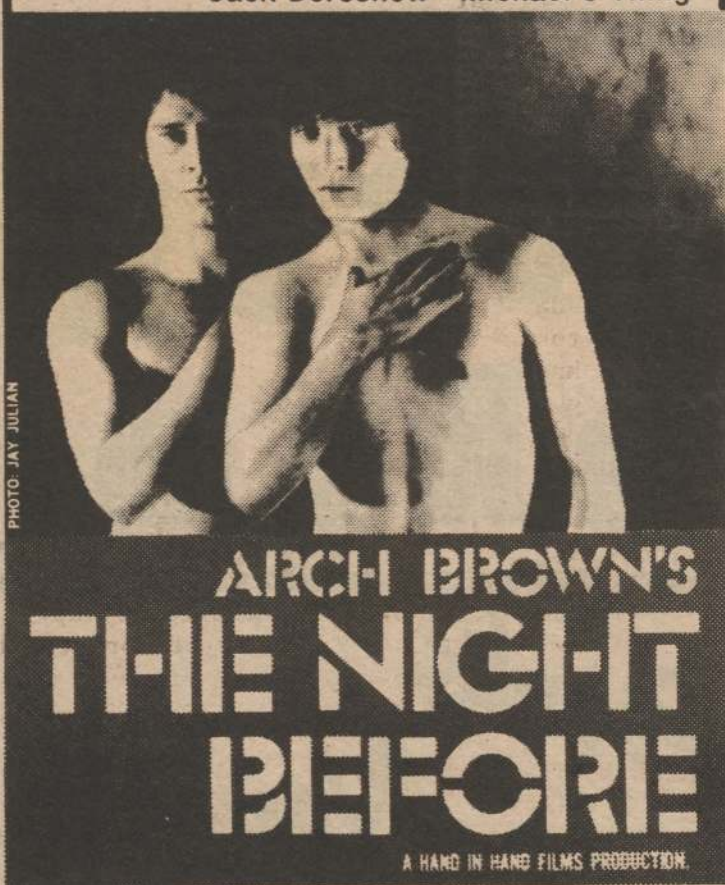

Let's start off this week with a quizzer: According to the Bell Telephone System, which single day of the year is the heaviest for phone calls? I'll confirm the truth to you later on.

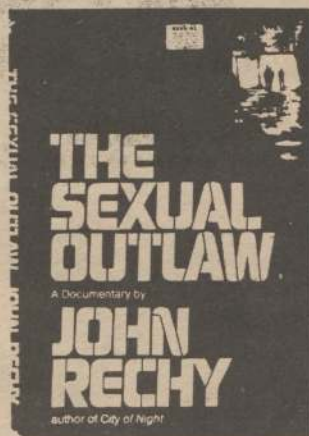



ADULTERY IN PAKISTAN IS BAD IDEA

ISLAMABAD, Pakistan - Adulterers in Pakistan will be publicly stoned to death from now on if they are married, and Moslems caught drinking alcohol will receive up to 80 lashes, Pakistan President Gen. Zia Ul-Haq announced last Saturday. The two Moslem holy books, the Koran and the Sunna, gradually will replace the laws inherited from the British legal system, he said.

But the Koranic punishments for adultery, theft, false witness and the drinking of alcohol will be applicable immediately. Zia added in a televised speech before members of the diplomatic corps and political and government leaders. The new Pakistani penal code will resemble that of Saudi Arabia.

But the cases of mutilation and public executions by stoning are likely to be limited to only a few a year because of the Koranic provision that many witnesses are required to give evidence in cases of adultery and theft, observers said. While married people will be stoned to death under the new regulations, the punishment for the unmarried is 100 lashes. People found guilty of bearing false witness can receive 80 lashes. Thieves could have their right hand or a foot cut off. Observers here said Zia obviously was inspired by the Saudi Arabian judiciary and penal system.

CHURCH AGENCY OFFERS GUIDES FOR ECUMENICAL DEBATE ON HOMOSEXUALITY

NEW YORK, NY - Guidelines for ecumenical debate on abortion and homosexuality have been approved by an agency of the National Council of Churches and commended to churches and individual Christians. The Commission on Faith and Order is the nation's most broadly representative group of Christians working theologically for Christian unity. It includes 56 representatives of "mainline" Protestant, evangelical Protestant, Eastern Orthodox and Roman Catholic churches.

According to Dr. Jorge Lara-Braud, executive director of the commission, "We have watched with dismay the growing division of Christians on the questions of homosexuality and abortion and have formulated these guidelines out of an ecumenical sensitivity which aspires to a more reasonable handling of opposing views on homosexuality and abortion."

The guidelines issued by the commission are believed to be the first of their kind. They do not take any position on abortion or homosexuality. Rather, the guidelines "are offered in the hope that Christian unity may grow and be maintained" during debate of the issues, according to the commission's statement. The commission supports the right of churches to influence public policy, declaring that "political activity, which seeks to bring the social order into line with ethical convictions, based on religious commitment, does not violate the separation of church and state." The guidelines add, however, that "when extensive theological and moral differences preclude consensus on issues of public policy, it is unwise for individual Christians and denominations to advocate the closing of debate through restrictive laws."

LEADER OF GAY CHURCH VOWS TO START OVER DESPITE ARSON BLAZE

SANTA ANA, CA. (DataBoy) - "All I know is we're going to start over," said Rodger Harrison as he stared at the charred remains of his fire gutted church. Early in the morning of February 7, an arsonist set fire to Harrison's Metropolitan Community Church in downtown Santa Ana - reportedly Orange County's only church for homosexuals. Built in 1896 by Unitarians, the redwood and stone church housed Orange County's first synagogue from the 1940's until 1960. Harrison's 30-member congregation made a down payment on the building five months ago, but now, officials from the Santa Ana fire department say the building is a total loss and damage is estimated at \$172,000.

It was the eighth Metropolitan Community Church building worldwide to burn since the church was founded a decade ago. (MCC/Phoenix was fire bombed just last year and is presently building a new church on recently purchased property).

"It's definitely arson," said a department spokesman. "It was an inferno, a Roman candle when we got here about 1 a.m. Wednesday." But Harrison suggested that the arsonist was "someone who knew precisely the nature of the church." He did not elaborate. Harrison described the fire as a, "crime against the integrity of Gay people who have worshiped in peace for over eight years. I hope this is not a state-that Gay people are not welcome in Santa Ana."
