### JUDGE UNDER FIRE FOR USE OF WORD "FAGGOT"

#### Empire Ball response overwhelming

PHOENIX - As time draws near, Regal Productions reports that ticket sales are zooming for their upcoming "Empire Ball" scheduled to be held on Friday, October 31, 1980 in the Grand Ballroom of the Adams Hotel. With ticket sales going fast, those wishing to attend the costume gayla are urged to contact John Godtschmid or Jim Howard at 271-9125 Monday through Friday between the hours of 8 a.m. and 5 p.m. for reserved seats. Tickets may also be purchased at Sammy's Steak House, The Grand Camel and Farrah's Lounge in Phoenix or from Eddie Flores and Chelsea Laine in Tucson.

The doors of the Grand Ballroom will open at 7:30 p.m. for cocktails and dancing with the brilliant "Galaxy Review" and costume contests and parades starting promptly at 9:00 p.m. Five categorical contests will be held for the King and Queen of the Empire; the Most Original Costume and the "Adonis" and "Sappho" awards. LOS ANGELES, CA - U.S. District Judge A. Andrew Hauk has been criticized by two judges and a deputy city attorney for referring to homosexuals as "faggots" in a case he handled nearly two months ago. The dispute arose after a profile story on Hauk appeared in the *Los Angeles Daily Journal*, a newspaper for the legal profession. A week earlier, the story said, Hauk had sentenced a Mexican citizen who crossed the border illegally to see his child. "And he isn't even a fag, like all these faggots from Cuba we're letting in," Hauk was quoted by the newspaper as saying in court.

Los Angeles Superior Court Judge Stephen M. Lachs and Municipal Judge Rand Schrader wrote to Hauk saying they were deeply "offended and dismayed after reading the insulting and injudicious statements attributed to you....." They wrote that Hauk had demonstrated an insensitivity to the special demands placed on members of the judiciary to act in a manner which is both fair-minded and dignified. The judges asked Hauk "to recognize the intemperance" of his remark "and to publicly withdraw it." Hauk responded by calling the letter "presumptuous and arrogant." "The judge's appropriate obligation," he said, "is to apply and enforce the law as it is, not as altered or amended by the attempts of activists to legalize passing fads or fancies, which result in perversions and deviations in the law....."

S. Thomas Todd, a deputy Los Angeles city attorney, wrote Hauk calling the judge's remark "disgraceful." "As a homosexual," Todd said, "I am highly offended....With increasing frequency, cases involving the civil rights of homosexuals are coming before the court. Yet you have demonstrated a clear personal prejudice toward the homosexual minority in this country. I urge you to apologize publicly." Hauk also answered Todd's letter, this time saying he found it "intolerably presumptuous and arrogant." Your personal life-style preferences are of absolutely no concern to me," Hauk said.

Judge Lachs, an avowed homosexual, said there have been no further exchanges. "I felt that we had made the point with Judge Hauk....and either he would understand what we were trying to convey or he wouldn't," Lachs said. "And apparently, from his reply, he didn't." Todd said the matter "is still alive in the sense that it will be remembered" and used to promote federal legislation that would subject judges to censure for improper statements. "Hopefully," Todd said, "Judge Hauk won't be around too much longer because he is nearing retirement age. If it was a younger man who was going to be on the bench for years....I'd be more inclined to make a bigger issue of it." Hauk, 67, will become chief U.S. district judge in Los Angeles.

#### Falwell in Phoenix Oct. 28

PHOENIX - Rev. Jerry Falwell is coming to Phoenix. Falwell, leader of the Moral Majority which is a national campaign to politicize Christians into electing leaders who are willing to stand up against abortion, taxing church properties, sex education in schools, homosexuality, Equal Rights Amendment, etc. Moral Majority has scheduled a rally at the State Capitol on Tuesday, October 28.

A protest rally is in the works headed by Gay Christian Outreach Services (GayCos). There is no further information available at press time. Watch next weeks issue for full details. Volunteers will be needed to help with distribution of literature at the rally. A meeting of volunteers will be held at Casa de Cristo, 1029 E. Turney on this coming Tuesday, October 21 at 7:30 p.m. All interested parties are encouraged to volunteer.

# News Briefs

## GAY STUDENTS HALLOWEEN PARTY PLANS SET

TUCSON - The Gay Students Organization (GSO) of the University of Arizona last week announced their plans for their annual Halloween Party. In the final planning session, it was decided to hold the party from 9 p.m. until 1 a.m. instead of after-hours. The party will still be held in a private residence and the general community is invited to attend. Invitations will be handed out to those wishing to attend by members of GSO. Mixers, or a punch will be provided. The party is a BYOB event. For further information contact Brian Weede, GSO Co-Director at 623-6566.

## NO SLURS IN SAN FRANCISCO

SAN FRANCISCO, CA (GayLife) - The Civil Service Commission has adopted a far-ranging and apparently unprecedented policy under which city officials and employees may be demoted or dismissed for using a "slur" while on duty. The controversial policy prohibits slurs against any person "on the basis of race, color, creed, national origin, ancestry, age, sex, sexual orientation, or disability." Examples of slurs that were cited were, "old coot," "dumb broad" and "chinks." Use of slurs, as defined by the policy, could result in an employee's dismissal. They expect, however, that the incidents will simply be made part of the employee's record and be used in judging his/her overall fitness for the job.

## A MORE ACCURATE HISTORY

NEW YORK, NY (GCN) - An irate reader has written an angry letter to Ms. magazine, pointing out the magazine's failure to report on the Lesbian content of an 1879 time capsule uncovered in San Francisco. The letter, published in the September, 1980 issue, points out that the full text of Laura De Force Gordon's message published in the "Gazette" section of the May 1980 issue reads, "If this little book should see the light of day after its 100 years' entombment, I should like the readers to know that the author was a lover of her own sex, and devoted the best years of her life in striving for the political equality and social and moral elevation of women." Apparently the words "lover of her own sex" were omitted when Ms. originally published the item.

"Many of us," write the reader, "are working very hard at writing a more accurate history of women than patriarchy has bequeathed us. Part of this history includes strong active women who loved other women. Please do your part in accurately reporting this history."

"Do not sign my name or city to this letter should you include it in your letters column," the writer adds. "Linkage of my name with this issue will 'damage' my position in an upcoming child-custody suit. Homophobia still keeps women apart and anonymous."

## MARY WHITEHOUSE IN DRAG !!

LONDON, ENGLAND (GPU) - Confused police thought they had arrested England's famous anti-Gay crusader, Mary Whitehouse, for stealing a newspaper to read about the events of the Gay pride parade. At the police station a woman police officer was called to search "her". The embarrassed police soon learned they had arrested Robert Airtton of the Thurrock Committee for Homosexual Equality whose drag impersonation of Whitehouse was very convincing.

## ANOTHER COUNTY OKAYS GAY RIGHTS

MADISON, WI - Dane County has approved a Gay employment rights ordinance by a vote of 28 to 8. Madison, the state capitol, is in Dane County. The only opposing speaker at the public hearing was a Baptist minister, whose testimony caused a few members of the County Board to walk out. Many of those present agreed that the prejudicial attitude of the minister convinced some undecided Board members of the need for the legislation. Milwaukee Catholic Archbishop Rembert Weakland also was helpful with a pro-rights statement.

## MUSIC IS AS MUSIC DOES

MINNEAPOLIS, MN (OUT) - The head of the Drug and Alcohol Abuse Program at the University of Minnesota says that the songs of Willie Nelson, Waylon Jennings and Kenny Rodgers may cause bar patrons to drink more than they should. Dr. James Schaefer has made a study of country music joints, and he believes that the music combines with the overall setting to promote tolerance for drunken, disorderly behavior.

Schaefer says that dim lights, small dance floors, macho decorations and the lyrics of the songs all seem to work together to reinforce excessive drinking.

## GAYS CAN BE DRAFTED IN GERMANY

HAMBURG, WEST GERMANY (GayLife) - It is not possible any more to claim to be Gay to get an exemption from the German military service. Until now a Gay recruit could go to a physician and ask for a special document, which he could take to the military authorities. The system was in effect because Gay activists and doctors argued that a Gay person could not receive a promotion as an officer according to his merits, and thus equal treatment was not possible, and hence Gays should be exempt. Military authorities in Hamburg have reversed this policy. But Gay activists are still arguing that Gay soldiers are discriminated against, therefore Gays should not be expected to serve.

NEW YORK, NY (GayLife) - In his address to the Democratic National Convention, Mel Boozer, openly Gay Vice-Presidential candidate, stated: "I know what it means to be called a nigger and I know what it means to be called a faggot, and I understand the difference in the marrow of my bones. And I can sum up that difference in one word: NONE!"

## STATE DEPT. CITES GAY EXECUTIONS

WASHINGTON, DC (GayLife) - An inconspicuous statement in a 340,000 word government document marked the first time the U.S. government has included violations of Gay people in its annual human rights monitor. The U.S. State Department reports that Gay people had received "cruel, inhuman and degrading treatment" under the Iranian government. The document reads, "More than 700 executions by firing squads took the lives of political and military figures identified with the previous government who were accused of killing or torture; counter-revolutionaries accused of plotting to overthrow the new government; and persons accused of violating Islamic ethical norms (alleged prostitutes, homosexuals, drug dealers). Their conviction followed summary trials with virtually no regard for due process."

## CONSERVATIVES UNITING

NEW YORK, NY (GayLife) - The New York Times has reported on the building of a loose coalition of conservative single issue groups in the wake of Ronald Reagan's Presidential nomination. These groups are working against abortion, the ERA, the drafting of women, pornography and homosexuality. The general term they use to describe their goals is "pro-family".

## Bauman won't end House bid

Easton, MD (AP) - Rep. Robert E. Bauman, accused of soliciting sex from a 16-year-old boy in Washington, admitted to "homosexual" tendencies but said he had no intention of dropping out of his congressional race. At the same time that Bauman made his statement, James E. Regina, of Fishing Creek, MD, 26, was arraigned in federal court in Baltimore on a charge that he attempted to extort \$2,000 from Bauman in exchange for keeping quiet about a homosexual relationship he allegedly had with the congressman. Questioned about the alleged blackmail scheme, Bauman said he initiated

a federal investigation, but that he was not being blackmailed and he did not know the subjects of the probe.

The 43-year-old Republican is seeking his fourth term in the House despite the sex charge, and his statement that he is an alcoholic. He pleaded innocent to the solicitation charge and agreed to enter an alcoholic-rehabilitation program. Earlier, the Republican National Committee announced it would not give Bauman any campaign money. Bauman has already received \$8,300 from the House GOP campaign committee.

"I have something to offer the district and the Congress," Bauman told reporters in a news conference here in his hometown on Maryland's Eastern Shore. Before the sex charge, Bauman was considered certain to be re-elected from the conservative 1st District. But three conservative groups have since called on him to resign from Congress.

## Rios will stay on ballot

PHOENIX, AZ - State Rep. Marjory "Marge" Ollson, D-San Manuel, who lost a close primary race to challenger Peter D. Rios last month, also has lost her attempt to throw Rios off the ballot. She had charged that Rios had not been a resident of District 7 for the required one year. Maricopa County Superior Court Judge David J. Perry ruled that Mrs. Ollson hadn't proved that Rios had failed to meet the legal residency requirements.

Unless Mrs. Ollson appeals Perry's decision and wins, Rios and Democratic incumbent Richard Pacheco of Nogales will face Republican George Kline of Eloy for the two House seats Nov. 4. The district is heavily Democratic, and winning the party's nomination is tantamount to election. Mrs. Ollson is well known to the Gay communities of Arizona for her anti-Gay stance during her elective years in the Arizona House of Representatives.

Dear Congressman Udall:

Through a mailing of the National Gay Task Force, of which I am a member, I have learned that you did not vote on the amendment to the Legal Services Corporation appropriation bill, proposed by Larry McDonald, which prohibited the use of legal assistance funds in promoting, defending or protecting homosexuality.

As a Gay person, I pay taxes the same as anyone else so my tax money will go toward the legal assistance fund, but I am excluded from receiving any aid from this fund to which I will have contributed should I need such aid. It seems to me against the whole spirit of the Legal Services Corporation act to deny legal services to any group of people, regardless of sexual orientation, if they cannot afford such services on their own.

Although I am a registered democrat and have always supported you, I feel that I must ask for some explanation as to why you did not vote on what I feel is a crucial human rights issue for approximately ten percent of the people in this country.

I would appreciate hearing from you on this matter and on your intentions regarding any similar measures which may arise in Congress in the future.

Thank you for your letter about the amendment offered by Congressman McDonald to the Legal Services Corporation Act. This amendment prohibits the use of funds by the Legal Services Corporation to provide legal assistance in promoting, defending or protecting homosexuality. It was offered and passed by the House on July 22nd.

Unfortunately, I was not in Washington to vote on this issue. I was in Tucson during the entire week of July 21st as a result of previous commitments. I could not have foreseen this amendment being offered and was unable to return to Washington when it came up on the House floor.

You should not take my absence at the vote as a sign of support for this amendment. I am very much against that change in the legislation and feel its passage is a setback to all civil liberties.

Again, I am sorry that I was unable to vote against the amendment. I will oppose similar moves in the future. Thank you for sharing your concerns with me and I hope you'll keep in touch.

**News Briefs****CHAINS FOR ERA**

SAN FRANCISCO, CA (GCN) — noting that the time has come for more militant efforts to ratify the Equal Rights Amendment, on August 26, several members of this city's chapter of the National Organization for Women (NOW) chained themselves to the door and windows of the Pacific Coast Stock Exchange, while others engaged in brief scuffles with an overzealous security guard who attempted to prevent the protesters from carrying their 90-foot banner to the top of the stairs. Stock exchange guards cut the chains almost immediately, but the banner was permitted to remain at the entrance for two more hours of picketing, chanting and speeches. There were no arrests.

The Stock Exchange was chosen as a symbol of corporate opposition to ERA. The non-violent action and demonstration, held on the 60th anniversary of women getting the right to vote, was intended to show, (1) that ERA is an economic issue, (2) that because of women's economic poverty they are unable to control the political power as corporate monies can, and (3) provide a role model for increased militancy across the country. Independent of this action, 12 women chained themselves to Republican National Committee headquarters in Washington to protest that party's dropping the ERA from its platform.

**ONE FROM THE SOCIOLOGISTS**

NEW YORK, NY (GCN) — At its annual business meeting held here recently, the American Sociological Association passed a set of resolutions condemning discrimination against Lesbians and Gay males. The association went on record as "firmly oppos(ing) the discriminatory policy of the United States Government which excludes Lesbians and Gay men from entering or immigrating to the United States."

It also urged that the President "direct that there be no discrimination on the basis of sexual orientation by any branch of the United States Government." Finally, the association affirmed that denial by universities of students' rights to form Lesbian and Gay student organizations on campus "is inimical to the kind of environment necessary for effective conduct of social science education and research," and condemned any university that refuses to allow the formation of a Gay students' association on campus.

**NEW YORK GROUP GETS GRANT**

NEW YORK, NY (Blade) — The Gay service group, Senior Action in a Gay Environment (SAGE), recently received the first grant ever given to a Gay organization by the Greater New York Fund/United Way. SAGE has been called the "country's first, and so far only, private or public agency exclusively devoted to helping older Lesbians and Gay men deal with the problems of aging in a homophobic society and an often cruelly youth-worshipping Gay culture," by the National Gay Task Force. SAGE was started in September 1979.






