## Endean resigns from GRNL

Washington, D.C. — On Saturday, October 15, the Executive Committee of the Gay Rights National Lobby, while meeting in Chicago, received the resignation of Executive Director Steve Endean . . . with regret and sorrow. "While we understand Steve's reasons for resigning, we are convinced that the organization will sorely miss his committed and inspiring leadership," the Committee stated in the press release issued that day. Endean said that, ". . . my decision was one that was reached reluctantly and with considerable sadness." Endean will continue as Executive Director of the Lobby for three to six months which gives the organization time for an orderly transition.

The Executive Committee immediately formed a Search Committee to select a new Executive Director. Additionally, Jerry Weller, GRNL's Deputy Director will assume greater administrative duties and Endean will assist all GRNL staffers in dealing with greater responsibilities until a new Executive Director is named. Endean is also determined to reach his goal of 84 co-sponsors for the Lesbian and Gay Civil Rights Bill, H. R. 2624, by January 31, 1984.

Endean's resignation statement in part said:

"I believe that the attacks on me during the past nine months can largely be attributed to a political vendetta combined with a quest for power and control of our movement. Most of these attacks were characterized by half-truths, distortions and flat factual inaccuracies. Although there certainly have been legitimate criticisms of myself and GRNL, as with any leader and group, the atmosphere has become so poisoned, I believe, that any attempts on my part, or those who have supported me, to address legitimate issues and criticisms were rendered increasingly difficult, if not impossible.

"It's ironic that just a short time ago my strongest detractors were praising my performance and lauding my accomplishments at the Lobby

and the Campaign Fund. Today, they describe my unwillingness to take their 'marching orders' as 'incompetence'. To my deepest dismay, many in our community have appeared to quickly forget both past and recent accomplishments and believe these allegations. Perception has, for many, replaced reality.

. . . "I entered this movement years ago to fight for gay/lesbian rights and to make a difference in the lives of gay people. I did not get involved to either fight other gay people or spend my time and energy defending myself and my staff. If self-defense becomes the highest purpose, it is time to go.

"While I obviously leave with strong emotions stirring within me, I also leave with a sense of peace. Frankly, neither the criticisms of detractors nor even the kind words of praise from colleagues are necessary for me to judge both my accomplishments and shortcomings.

. . . "But today I can look back with the conviction that I've been able to make a difference . . . Few endeavors could have been so rewarding and satisfying. I thank the gay and lesbian communities for the opportunity of having served them."

The Executive Committee listed many of Endean's accomplishments in their response to his resignation stating:

"Steve Endean's record in his five years as Executive Director of GRNL is a remarkable one. He inherited an organization that was, for all intents and purposes, moribund, and he transformed it into a dynamic, nationally-respected organization that has effectively and forcefully fought for the rights of lesbians and gay men. Under Steve's leadership, the number of House co-sponsors of the federal Gay and Lesbian Civil Rights bill has increased to a record seventy-three, the bill was introduced in the

### AIDS in Britain

London (IGNA) — The death of a hemophiliac in Bristol from AIDS has led to further calls for the British government to allocate more money to fight the disease.

Another hemophiliac in Cardiff is among the 20 confirmed cases of AIDS in Britain. Both men are believed to have contracted the disease from contaminated supplies of the clotting agent Factor VIII imported from the United States. The U.S. currently supplies over half of Britain's Factor VIII, and the government cutbacks in funding mean that the U.K. will not be self-sufficient in blood products at least until 1985. Although the British Hemophilia Society (BHS) has contributed around £25,000 (about \$37,000) toward research to find a way of insuring that supplies of Factor VIII are free of AIDS, Social Services Secretary Norman Fowler has refused to increase government funding of the project.

At a meeting in late September junior Health Minister Lord Glenarthur told the hemophiliac organization that the government was unwilling to expand its AIDS research because this would mean that other medical research projects would have to be cut.

The hemophiliac group now plans to join the gay groups, organizations concerned with intravenous drug users, and health service trade unions to form an AIDS Action Committee.

This Action Committee aims to put pressure on the Department of Health and Social Security to treat the AIDS problem with more urgency and to counter inaccurate reporting about AIDS in the media.

Julian Meldrum, secretary of the gay Hall-Carpenter Archives, has already made a detailed complaint to the Press Council on newspaper coverage of the disease. The committee intends to issue a regular newsletter to organizations representing all groups that are particularly at risk from the disease.

### AIDS rumor brings \$30 million law suit

A \$30 million law suit has been filed in San Jose, CA on behalf of a man who claims that he was forced to quit his job because his supervisors spread false rumors that he had AIDS. Waheed "Larry" Ghilzai, an Afghani refugee, left his job as a chemical technician at SEEQ Technology, Inc., in June after what he says was a year of harassment and intimidation by superiors and co-workers. He was subject to continual ridicule and threat, he says, moved to an isolated and unhealthy work station, and denied access to his personnel file in violation of California law. Coming from a Moslem culture that strongly disapproves of homosexuality, Ghilzai also claims that his being publicly identified as gay has done irreparable damage to his family's reputation in the Afghani refugee community. Representatives for SEEQ Technology have refused comment on the case.

### Gay group is first approved for Olympic housing

When 400 members of the press and the Los Angeles Olympics tourism community met recently at city hall, they were momentarily startled at an announcement that Gay Housing L.A. '84 was the first rental housing agency to receive official approval from the California Department of Real Estate, qualifying them to accept advance fees to list rental properties for Olympics visitors. The initial moment of silence was followed by applause, according to Jean O'Leary, co-director of the firm.

The approval came on the heels of orders to four other housing agencies to cease their activity of taking payment for advance listings from home and apartment owners, when they are not licensed real estate brokers, or have demonstrated the capacity to attract visitors through adequate promotion.

O'Leary said Gay Housing L.A. '84 is conducting a multi-media campaign to obtain visitors from the U.S. and nine foreign countries. They will be making an outreach to 200 gay travel agents, and advertising in all gay papers, gay radio and cable TV programs.

One minor snag in their plans has been the refusal of Gentlemen's Quarterly (G.Q.) magazine to run an ad

with the word gay in it. The response to their ads has been tremendous everywhere else, according to O'Leary. Their media plan includes several metropolitan magazines such as Miami, New York, Chicago and San Francisco.

G.Q. told Gay Housing L.A. that the word gay never appears on the pages of their magazine, they refuse it in ads, or any symbolic references to gay. They claimed they had no idea (or interest in knowing) if any of their readers were gay, according to O'Leary.

Perhaps some of those readers will let G.Q. know. "Unfortunately, this kind of discrimination is still legal," said O'Leary, "as oppressive and outdated as it may seem to be."

### S.F. killer gets jail without parole Case may set a precedent

San Francisco — As the result of a recent murder trial in San Francisco, killers who prey on gay men may face a rougher day in court. Such crimes have frequently gone lightly punished because of claims by the killer that he acted in self-defense after being sexually molested by his victim.

That is what defense attorneys claimed happened to Dana Holley. In July 1981, Holley, then 19, murdered 51-year-old banker William Sink in Sink's posh San Francisco apartment where the two had gone after meeting in a bar. The former boxer contended that the older man was attempting to force him into having sex. According to public defender attorney Peter Keane, Holley behaved as though he were being raped which drove him into a rage. Keane also demonstrated some sexual confusion in Holley that, he claimed, set off a panic in the young man. The result was the beating and stabbing to death of William Sink. Holley also admitted to previous attacks on gay men.

The jury, however, didn't buy Keane's arguments which were dubbed the "homosexual panic" defense. Holley was convicted of first degree murder with special circumstances—due to the brutality of the killing. On July 29th, he was sentenced to life imprisonment without chance of parole.

Though it is expected that Holley's sentence will be appealed, Ron Huberman, investigator for prosecuting attorney Paul Cummins, stated that the case sets a precedent nonetheless that could alter the legal profession's handling of such cases. "They tried the 'homosexual panic' defense and it didn't work. Once a defense like that begins to fall apart, it simply becomes less effective and all defending attorneys take notice."

The case had from the start pitted San Francisco's gay community against the public defender's office over the issue of homophobia being exploited in the case. At first, the defense claimed a \$15,000 survey showed that a fair trial was not possible in San Francisco with its large gay population. After change of venue was denied, the defense then attempted to dismiss gay men from the jury. Defense attorney Keane denied that it was a move against gays as a group, but did admit that "gays were excluded from the jury because of the publicity this case had received." After seven gay men were dismissed by the defense—not because they were gay but because they said they had read accounts of the killing in the local gay papers—prosecutor Cummins protested. Though the judge approved of Keane's questions to jurors, said Huberman, who is himself gay, "the point was made and the issue of excluding gays from the jury went into the trial record." One gay man was then seated on the jury.

Chief public defender Jeff Brown, who has long been respected and supported in gay political circles, denied that Holley's defense was "homophobic". He justified the actions of his office, saying that "it is my duty to defend a client to the full extent of the law." Part of that practice, he said, involves "looking for a jury receptive to the defense and not a jury who can identify with the victim." He stated that in cases in which the death penalty is a possibility, as it was for Dana Holley, an attorney is especially required to use every means at his disposal to defend his client.

At any rate, in light of the courtroom challenges to jury selection and Holley's subsequent conviction, killers of gay men may no longer go routinely unpunished.

sheriffs and gays, prior to the October 9 event in this highly concentrated gay neighborhood of Los Angeles. The sheriffs were concerned about defacing public property, and the gays of what sounded like an anti-gay group in the making.

That was not the case according to the group's founder, Larry Carpenter, a West Hollywood graphic designer. "We just want to see a balance in our community," said Carpenter. "West Hollywood has become a gay Disneyland attracting a lot of outsiders into hanky codes and unusual behaviors. The financial and political forces here strongly lean towards the gays. There are no bars or restaurants here for us straight people."

Carpenter spoke with the hurting pangs of an isolated man in an all-gay ghetto. "We need to set up social alternatives for heterosexuals in West Hollywood," he said. "I would like to see a bathhouse for straight people, for example. We don't mind coexisting with gays, we just want to see a balance. The gays have stepped out of their closet, now we want to help the straights step out of their front doors, but many are frightened. A lot of them fear and hate fags. Gays affront the sensibilities of a lot of elderly people here. Many parents are concerned about their teenage kids being propositioned on the streets. They tell me they're tired of seeing faggots in the alleys and all over the park. I understand their concerns, and I think the West Hollywood Heterosexual Society can help lighten them up."

The rally turned out to be more of a social outing. A buffet lunch was served, a couple of speeches were presented, and three rock bands, plus a woman musician, provided entertainment. There was also an information table, and a softball game to round off the event. Two hundred people were on hand, buttons and T-shirts were sold and a newsletter, The Hetero Herald, with several gay community advertisers, was distributed free.

"Straight people are part of this community, too," said Carpenter, "that's why we've already approached the Gay Pride organizers to have our own float in next year's parade. As far as I know, they said we'd be welcome."

## Health Fair Scheduled

Phoenix — Maricopa Tech is hosting what promises to be a popular annual event entitled "Careers In Health." **Celebrity Series to open  
with Pinchas Zukerman**

Phoenix — The Phoenix Symphony Association will present the first in a series of four "Celebrity" performances on Sunday, November 13 at 8:00 p.m. in Symphony Hall. Appearing in a solo recital will be world-renowned violinist Pinchas Zukerman with pianist Marc Neikrug.

Zukerman has selected a varied program of music that spans three centuries. The first half of the concert

will include J. S. Bach's *Sonata in E minor, BWV 1023* and Cesar Franck's *Sonata in A Major*. The second half of the program will open with a new work, *Duo*, composed by pianist Neikrug. The remaining works will include J. S. Bach's *Partita in D minor for solo violin, BWV 1004*, Camille Saint-Saens' *Romance, Op. 37*, Piotr Il'yich Tchaikovsky's *Melody, Opus 42 No. 3* and *Dance from La Vide Breve* by Manuel de Falla. The Tchaikovsky work was substituted for the same composer's *Serenade melancolique, Opus 26*.

Pinchas Zukerman has been accorded more praise and critical acclaim than any musician of his generation. His artistry has been cited on both the violin and viola, and most recently, as a conductor.

In 1967, Zukerman won First Prize in the Twenty-fifth Leventritt International Competition and embarked upon an awesome career that has illuminated the musical world for more than fifteen years. He has become internationally renowned as a soloist with orchestras and as a recitalist. He recently toured America and Europe with cycles of the complete violin and viola sonatas of Johannes Brahms.

As a chamber musician, Pinchas Zukerman has enjoyed collaborations with many of the world's outstanding musical personalities: Isaac Stern, Itzhak Perlman, Jean-Pierre Rampal, and the Guarneri Quartet to name a few. His role as a conductor began in 1970 with the English Chamber Orchestra. In the 1970's he appeared with many orchestras as guest conductor, but did not take on the responsibilities of a Music Director until 1980, when he was named to that post with the St. Paul Chamber Orchestra.

Pinchas Zukerman has been featured in many television specials including the "Live from Lincoln Center" Series and most recently a PBS special in honor of Stravinsky's 100th birthday.

Marc Neikrug is shaping a dual career as a pianist and composer. His music has been performed in concert, on the radio and on television in North and South America, Israel and Europe. Among the musicians who have commissioned and performed his music are Jaime Laredo, Misha Dichter, and Pinchas and Eugenia Zukerman.



### PERSONAL COMPUTING

by John Baumgardner

Personal computers, home computers, desktop computers, portable computers... whatever you call them, they are changing the way you and I live. More powerful than the printing press... more revolutionary than the wheel, these new, powerful and affordable computers are a tool that will allow you and I to work in, cope with and achieve, in the 'information age'.

With that, I would like to welcome you to the exciting world of personal computing. Perhaps you already have one of these machines or maybe you have been thinking about getting one but have been wondering just what you could do with a computer. Well, starting with this article, I hope to shed some light on the entire range of this subject, help you answer the questions you have already and some that you haven't thought of yet.

There is probably no better way to start off than to tell you something about the computer I am using to write this column on. This will hopefully pique your interest if it isn't already. It will also give you some idea of the incredible range of uses for small computers and will probably introduce some terms and concepts that you are not yet familiar with. Obviously, it would be impossible to explain all the terms I am going to use, in this first article, so I hope you will bear with me through this series as we delve into this fascinating world of computing.

You may never have heard of a KAYPRO IV Computer but that is the brand name of the machine I am using to write this article. It is a small portable computer weighing about 25 pounds, light enough to carry from place to place but not to carry around all day... it has a handle but no wheels! As for its vital statistics, it is equipped with a nine inch green screen monitor, a typewriter style keyboard, two floppy disk drives and 64,000 bytes of Random Access Memory (RAM). It has a connector to plug in a printer and another to plug in other accessories such as a telephone modem. And



most important of all, it comes with a number of very powerful programs (software) which are what make the machine 'do its thing'.

Now that I have let go with some computer jargon, let's take a closer look at what all that means. The monitor is similar to a TV set in that it lets you see what the computer is doing, in this case, it is built into the machine which is not true with all computers. Floppy disk drives are devices similar to tape recorders that allow the computer to access information stored on circular magnetic disks which are flexible, thus the name 'floppy'. RAM as I mentioned is Random Access Memory, which is where the computer temporarily stores information that it is currently working on. 64,000 bytes or 64k as it is referred to in the jargon, is just about a minimum standard for small computers these days because the price for this memory has dropped drastically in the past few years. A byte is one unit of information and consists of eight binary digits, or as they say in our ubiquitous computer jargon, eight bits. These eight bits can represent any one of up to 256 different combinations and thereby represent all the letters of the alphabet, digits from 0 thru 9 and all the other symbols on the typewriter keyboard. By-the-way, a half of a byte is called a nibble! Seriously! But more about bits, bytes and nibbles in a future article.

Although most small computers don't include a printer, they usually include a place or port to plug one in. The KAYPRO IV actually has two of these ports, either one of which can be used to plug in a printer, depending upon what kind of printer you buy. You will recall that

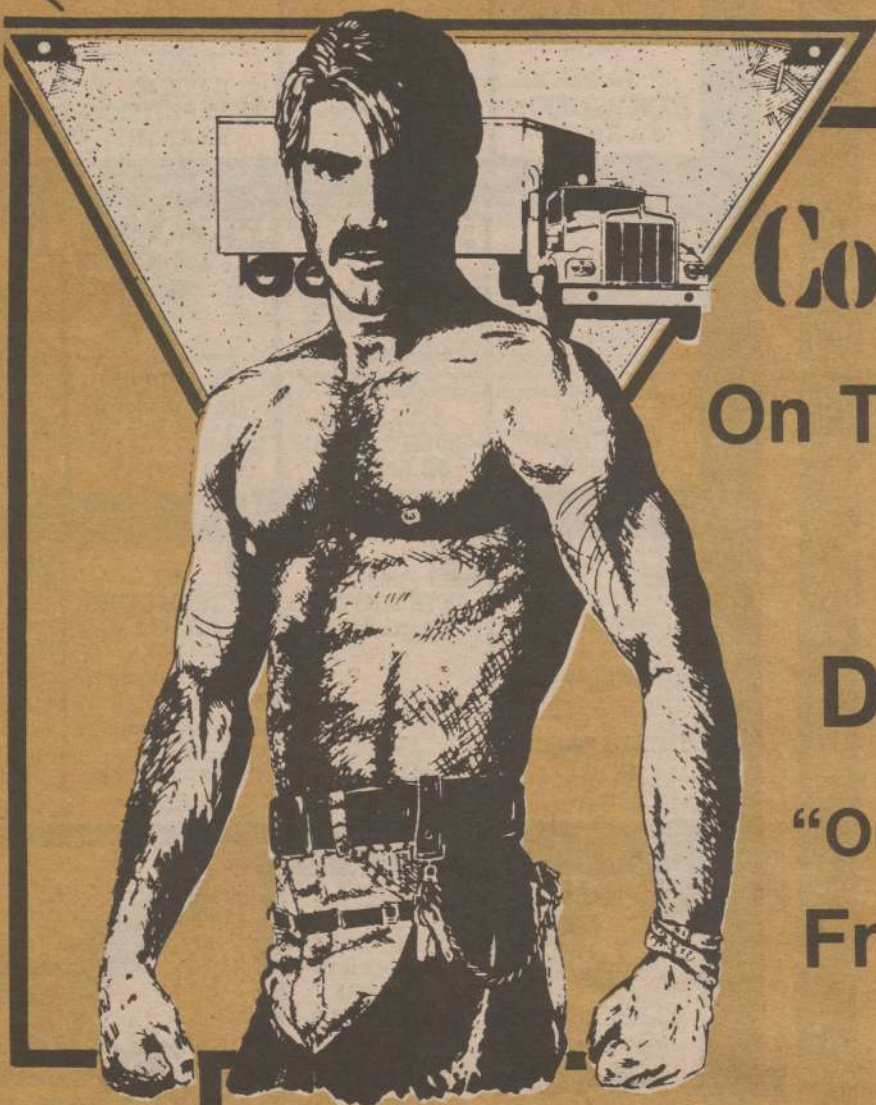

## PATRICK BUCHANAN: ENEMY OF HUMAN RIGHTS

Enemies of human rights have been around since the dawn of mankind. In fact, it has only been in recent years that civilized society has taken the time to stop and really look at the sordid history of human nature with its unfounded prejudices and bigotries.

And what is the end result of that prejudice and bigotry? Hate, violence, and war.

Man's inhumanity to man is a sorry chapter in the history of human relations. Or to put it more simply and individually, if you're different than I am, you're no good.

Humans have traditionally bonded together in groups of people like themselves. They have fought others, even to the point of bloodshed and death, for the simple reason that others were different in some respect or in some way than they were.

We've made some large strides past that primitive threshold.

At least most of us have.

Patrick Buchanan, syndicated columnist and writer for the Chicago Tribune, is an exception.

Buchanan, whose views fall well within the extreme right of the political spectrum, claims his greatest recognition as confidant and special assistant to former President Richard Nixon.

Buchanan's latest fullscale crusade is against gays. He feels that nature is getting even with them through AIDS, calls them immoral and decadent, and distorts the aims and purposes of the gay rights movement to try to blacken its name and incite backlash from the general public.

He taunts Democratic presidential aspirants Walter Mondale, Alan Cranston, and Gary Hart because they support civil rights for lesbians and gays.

Before the New York City Gay Pride March on June 26, he called for all the major New York political figures to cancel the parade on the grounds that it would spread the "AIDS plague" from coast to coast.

This, he said, was the *least* the public officials could do if they cared about gays.

Buchanan has a poor track record of caring for *anyone*. Instead, he uses his pen in a most vitriolic fashion to try and invoke prejudice and fear from the majority of the population who are uneducated and ignorant about lesbians and gays.

To Buchanan and his ilk, gays make the perfect scapegoat. Nero had the Christians, Hitler the Jews, and Buchanan and the New Right have lesbians and gays.

Instead of addressing himself to the issue at hand, which is the denial of civil rights to other human beings, Buchanan muddies the water and refashions the argument to fit the age-old prejudice: they aren't like us, so they must be evil.

Perhaps a little research would be in order for Buchanan and his cohorts on the extreme right. All gay people are different, Mr. Buchanan, just like straights. (By the way, all black people do not look alike or is this still part of your argumentative repertoire?)

Some gays are promiscuous, Mr. Buchanan, like you are so fond of writing, but contrary to your opinions and those of your comrades, most are not. Most lesbians and gays (a reported 90% according to published studies) have never even been to a bathhouse or gay bar in their lives.



What you forget, Mr. Buchanan, is that many heterosexuals are very promiscuous; therefore, certainly you must oppose heterosexuality as well. At the same time the majority of gays are living quiet monogamous lives in the suburbs just like you. They are probably right in your own neighborhood but you figure they can't be gay because they don't lisp, swing their hips when they walk, or wear dresses.

Gays are not asking for you to sanction their lifestyle, Mr. Buchanan. Are you asking us to sanction yours? Maybe we don't approve of the way *you* live and the way *you* act. And if we don't, does that make you immoral and decadent?

No, the rules that you play by are not rules of reason or fairness. Whether I like your lifestyle or not makes no difference to the question of discrimination and prejudice. You, being an American citizen, have rights under the Constitution which the gay rights movement supports and defends.

But *you* balk at letting gays have *their* Constitutional rights. Lesbians and gays are discriminated against worse than you can even imagine because of the basic prejudices and hatred you heap upon us and help to ignite and spread.

The issue is not one of majority vs. minority, Mr. Buchanan. If it was, most all of us would be in trouble somewhere along the line. Should we deny civil rights to Jews, Blacks, Hispanics, Irish, Poles, Asians, Catholics, and yes, Republicans, because they are clearly in the minority?

And yet, you fight against the Constitutional guarantee of basic human rights for lesbians and gays because you say the majority is offended.

We are faced with the inevitable conclusion, Mr. Buchanan: Like your predecessors from a century ago, you oppose basic human civil rights to those you disagree with.

Just twenty-five years ago, Blacks were visited with the same abuse you heap upon gays today. I'm sure you remember: they were shifty, lazy, dirty, uneducated, immoral, and certainly inferior to the white man in every way. After all, they were only a minority. And the political right abused and desecrated them at every opportunity.

Even today, the religious right that you rely on so heavily for your fallacious Biblical views against homosexuality relegates the black person to the back of the bus in every way it conceivably can. But while the Black gets to sit at the back of the bus, you refuse lesbians and gays the right to even get on.

I don't agree with all gays either, Mr. Buchanan, just like you don't agree with all straights. Are you not able to see what kind of philosophy you're perpetuating? Just like the old adage, "They all look alike to me", which was applied to non-white, you lump all gays into one basket. What one says, all say. What one does, all do.

This, to put it bluntly, is prejudice in its rawest form.

But then again, no one ever accused you of being fair toward other people. That is, unless they're just like you.

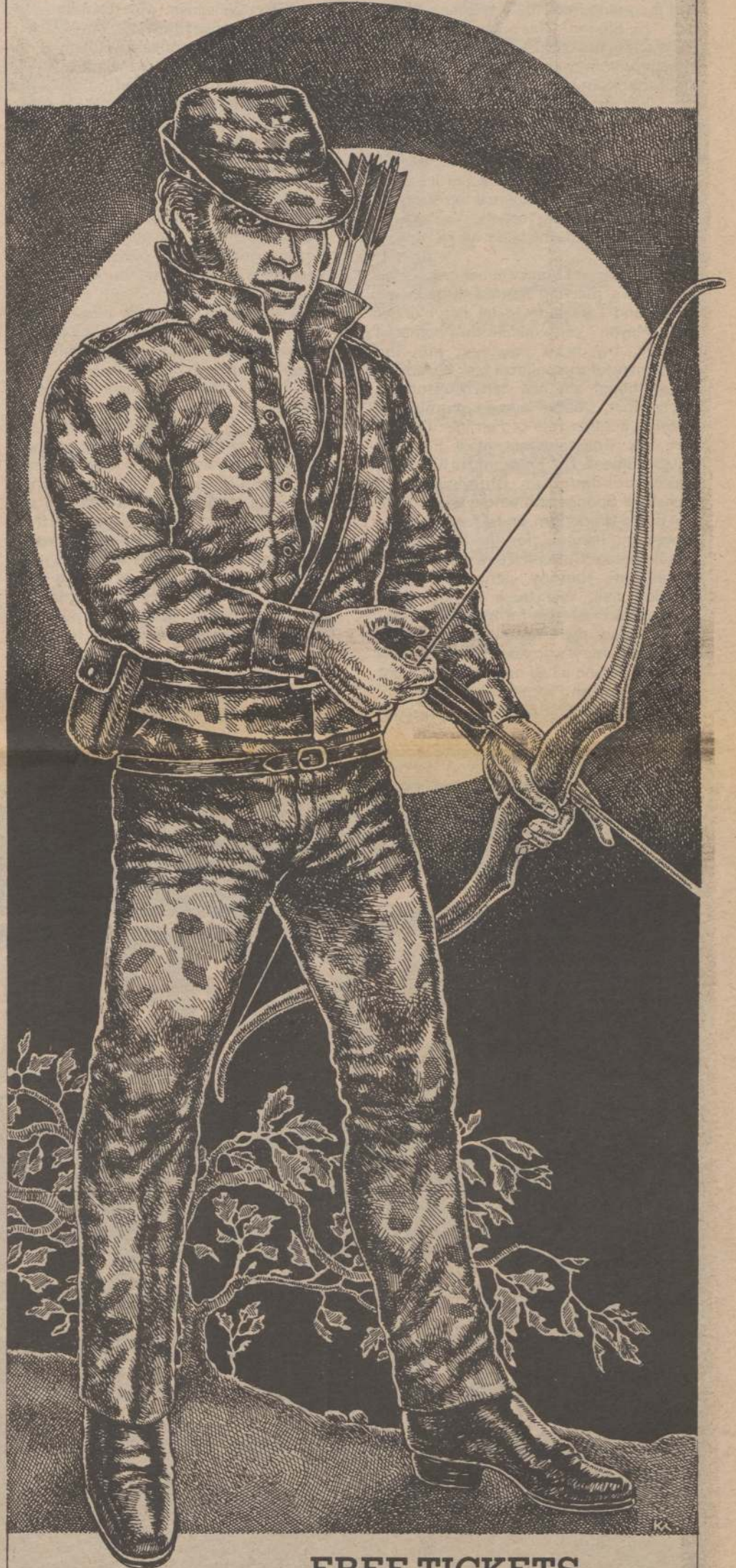

# Moondaughter's Emporium: The Way It Was

Not all relationships start out smoothly, and for us lesbian feminists, politics are often the waves that rock the boat. When I think of all the energy I had to put into raising Louise's consciousness about Feminist Dating, Goddess only knows how I've put up with it all. I could see it coming from the very first day.

"Hi, Sharon? This is Louise, from the Women Against Sexist Things Everywhere meeting. Want to have dinner with me at the Emporium tonight?"

"Yes, yes, yes, yes, yes!" I said coolly. I way put off at her approach, of course. As everyone knows, a proper Feminist Date begins when two or more women simultaneously ask each other out, participating equally in the decision-making process, neither party buying into the Man's game by resorting to macho behavior like speaking first.

An image of Louise in her new vest at last week's meeting flashed through my mind, and I decided to let her blunder pass. Maybe I can educate this woman, I thought, my heart pounding with the excitement of the political task ahead.

Although she had started off on the wrong foot, Louise showed promise by obeying another rule of Feminist Dating: Get Thy Entertainment at a Feminist Establishment. The Emporium's full name was Moondaughter Blood-woman's Menstrual Sponge and Whole Wheat Date Nut Bread Emporium, and it was a popular movement hangout for the six months that it operated. It served as a combination restaurant, therapy center, theater, meeting hall, menstrual sponge warehouse, and crash pad for traveling dykes. On weekends there was entertainment by local performers, who read from their journals in two-and-a-half-hour sets. Tonight was All You Can Process Night, with continuous readings for 24 hours at no extra charge.

We arrived just as the Cooking Collective was dishing up the Savory Separ-

tist Stew (the meat was what had been separated), and generous helpings of Nukeless Noodle Surprise, a casserole with a baked-in anti-nuke leaflet. The Cooking Collective was committed to their motto: "Don't just eat, Educate!"

We filled our plates and helped ourselves to the specialty of the house, the little individual cunt-shaped whole wheat date nut bread loaves. Joining the others sitting on the cement floor in concentric circles, we commenced to get in touch with the woman at the microphone, who was reading her life story and acting out all the parts. Whenever she got to a male character, her primary relationship stood up and led the crowd in booing. By the time we got there at 9 p.m. she was up to her fifth birthday party and the train set she never got.

"Wow, you two really missed something earlier!" a woman sitting near us whispered to me. "There was this great showing of Marge Johnson's art!"

"Who's Marge Johnson?" I asked, always eager to be educated.

"Wow, you haven't heard of Marge Johnson? Oh wow. Marge Johnson was, like, the best artist, like she killed herself in 1955 because she couldn't stand being a housewife, you know, and she was probably a dyke, and like she made all these paintings that male art critics won't recognize as great because they say, 'They're only paint by number, so how great is that?' but, like, her work is so full of female images and places where she purposely didn't go by the numbers! It was so heavy!"

I turned back to Louise to raise her consciousness about Marge Johnson but she was busy looking for an ashtray. I tried to raise her consciousness about smoking, after all, men do it so it must be patriarchal, but she just exhaled a cloud of smoke and stomped off. She corralled a

member of the Cooking Collective who reluctantly produced a small ceramic cunt-shaped ashtray and said reproachfully, "Do you really want to put your filthy ashes into this beautiful thing?" Louise's reply, they told me later, was very low consciousness. The Collective member gave her a dirty look, the ashtray, and five leaflets explaining how smoking is a patriarchal institution used to keep women oppressed.

Just as we were getting settled again and I was telling Louise about Marge Johnson, I noticed that she was looking at me oddly. The more she looked the more I lost my train of process. She had the most beautiful eyes. She's going to need a lot of educating, I kept warning myself as I pushed my hair into place and eased open one button. When she leaned over and kissed me I decided I should start by sharing good literature with her — like the new lesbian sex manual I'd just bought, for instance.

That night we did our first skill sharing. I guess it just goes to show that appearances can be deceiving. Louise turned out to be very well-educated, and as I said before, I'm always eager to be educated.

him in recent months. Many of us have already responded in some detail to the criticisms of Steve and of the GRNL Board. But we would like to at least note here that the criticism has come from two quite separate directions which has made it difficult, if not impossible, for Steve and the GRNL Board to respond to it in a coherent way. On the one hand, David, Goodstein, writing in the *Advocate*, has criticized the Board for not including more individuals who can either donate personally or raise large contributions to GRNL. Larry Bush, on the other hand, has attacked the Board for not being more representative of the grassroots community. We find it hard to understand how we could move in both of these directions simultaneously."

In other business the Executive Committee formed a committee to research alternative actions for the coming years and to recommend solutions or possible structural changes of GRNL in order to strengthen the organization's ability to lobby on behalf of the nation's lesbian and gay community. Named to this committee were: Jean O'Leary, Reverend Troy Perry, Terry Bean, Meryl Friedman, Kate McQueen, and Jack Campbell. The committee will report to the full board at the annual board meeting in February.

Among the many people expressing their support for Steve was Congressman Ed Roybal (D-CA). "It has been a pleasure working with Steve. He has been especially useful in keeping me informed and up to date on developments of the AIDS crisis." Roybal has played a key role in AIDS research funding in Congress.

GRNL Co-Chair Kate McQueen stated, "Steve's resignation is an appropriate time for GRNL to reflect on our accomplishments and to discuss possible changes in the organization's structure."

"Steve's resignation makes for a difficult time for the GRNL staff, but we're pulling together and as a group, are prepared for additional responsibilities during the transition period," stated Deputy Director Jerry Weller. "The staff is highly committed and quite able to cope with this regretful situation and we are very optimistic about an orderly and smooth transition," continued Weller.

Senate for the first time and now has eight Senate co-sponsors, and the push for Congressional support of AIDS funding has significantly strengthened. Organizationally, Steve has expanded GRNL's constituent network throughout the country, established a system of field representatives that has given GRNL a solid grassroots base, assembled and supervised a small but excellent staff, and played a major role in the formation of the Human Rights Campaign Fund. We believe that no one in our movement can equal Steve in vision or in the understanding of Congressional issues, and that with his resignation, all of us will be poorer.

"It would be impossible to respond to Steve's resignation without some acknowledgement of the enormous pressure that has been put on

## Chef at D.W.'s brings experience of a lifetime of cooking

Phoenix — Peter Rod is 38 and has been in the United States for only 13 years, having left his native Czechoslovakia at the age of 25 already with considerable culinary skills developed. Circuitously he arrived at D.W.'s with a great deal more experience and that touch of a professional in any given field, the ability to organize, set up and get it going.

In Czechoslovakia, Peter explained, "You have to do everything if you are in food. You cook, wait, draw beer and clean up. Everybody knows how to do everything there is to do." The idea that this is a best form of training was obvious.

From there to the United States, landing in New York and going immediately to Connecticut to work in the estate of Don Linsly, an antique dealer, and Giuseppe Santoro, a renowned photographer. As the two travelled a great deal and were otherwise involved when home it was necessary to have a chef on hand for personal pleasure and entertaining. Here Rod developed an Americanization of his European cooking skills which eventually would develop to the point that he would answer "No" to the question of whether we detect any Czechoslovakian influence in his cooking (more about sauerbraten later).

When thoughts of opening a restaurant didn't pan out, Peter found himself on his way to Paradise Valley, Az. and the Alamos Resort owned by the Stouffer Corporation, famed for their prepared foods and for other hotels. Arriving shortly after opening of the now famed resort, Peter was named Banquet Chef, no easy job and one requiring a great deal of organizational know-how. A couple of short off-resort season stops at other local restaurants brought him to an interview with Dale Williams who was then contemplating opening a better, full-food, full-service restaurant at Taylor's.

The two hit it off. Peter's expertise and experience, easily detected, and Williams' dedication to the project were what created a match-up. John Wertz was placed as restaurant manager, in charge of staff and whatever happens outside the kitchen door. The three set out and within a

comparatively short time Phoenix was treated to a restaurant opening in September.

If it is not Czechoslovakian, then what does Peter Rod prepare? As is so much 'Americanized' food there is no set description other than to be based on the knowledge and experience of the chef who prepares it. Is it wrong to use soy if you're not cooking oriental? Is it wrong to use garlic if you're not cooking Italian? Of course not. That's American cooking and developed from people such as Peter. Variety of menu for interest and variety of the tastes of different foods for the satisfaction of the patron are his primary concern. As an example: with already ten items in the entree section of the menu of D.W.'s, the day of this interview, six off-the-menu specials were being prepared for the evening, including two salmon dishes, two lamb (including Peter's favorite, Rack of Lamb), walleyed pike, and the aforementioned sauerbraten, created from Peter's training in Czechoslovakia and at the special request of a patron of D.W.'s who appreciates Peter's ability.

Peter Rod has introduced a special feature in the restaurant; with two to three days advance notice you can order a special dinner, specially requested foods and prepared in a special way. He invites the challenge.

By the way, when you dine at D.W.'s you probably won't see or get to meet Peter. Nevertheless you can be sure that he is hovering over the whole preparation of your meal. In a given evening his eyes do not stop roving around the kitchen and he himself roves around doing anything needed to assist his staff of five.

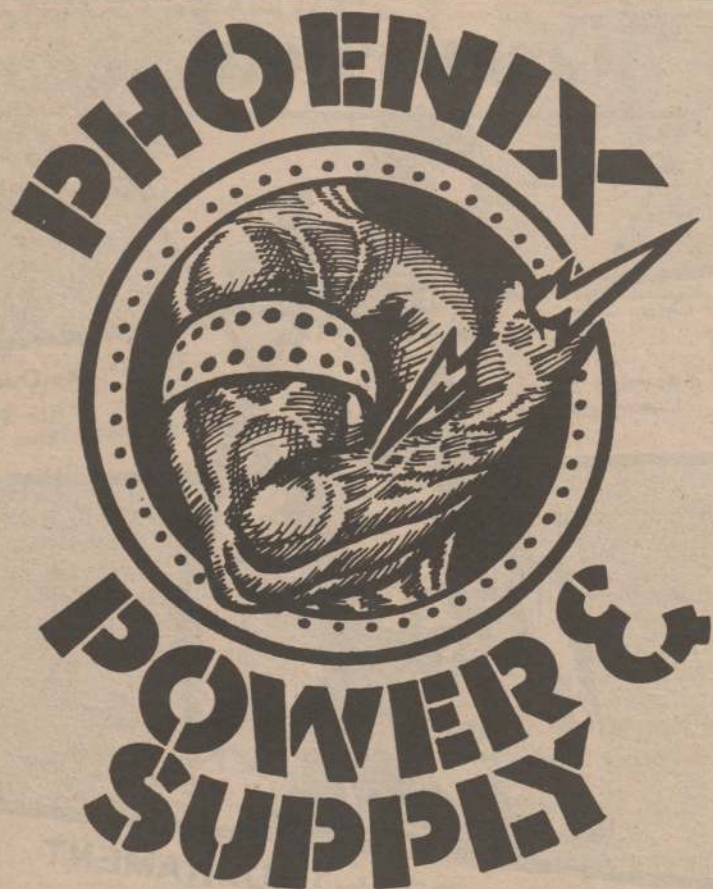

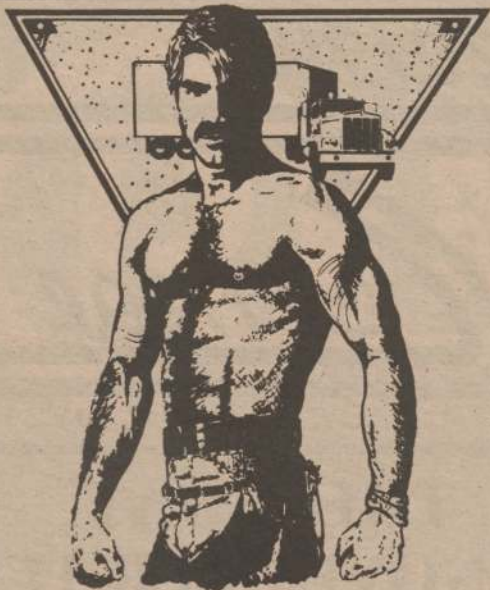

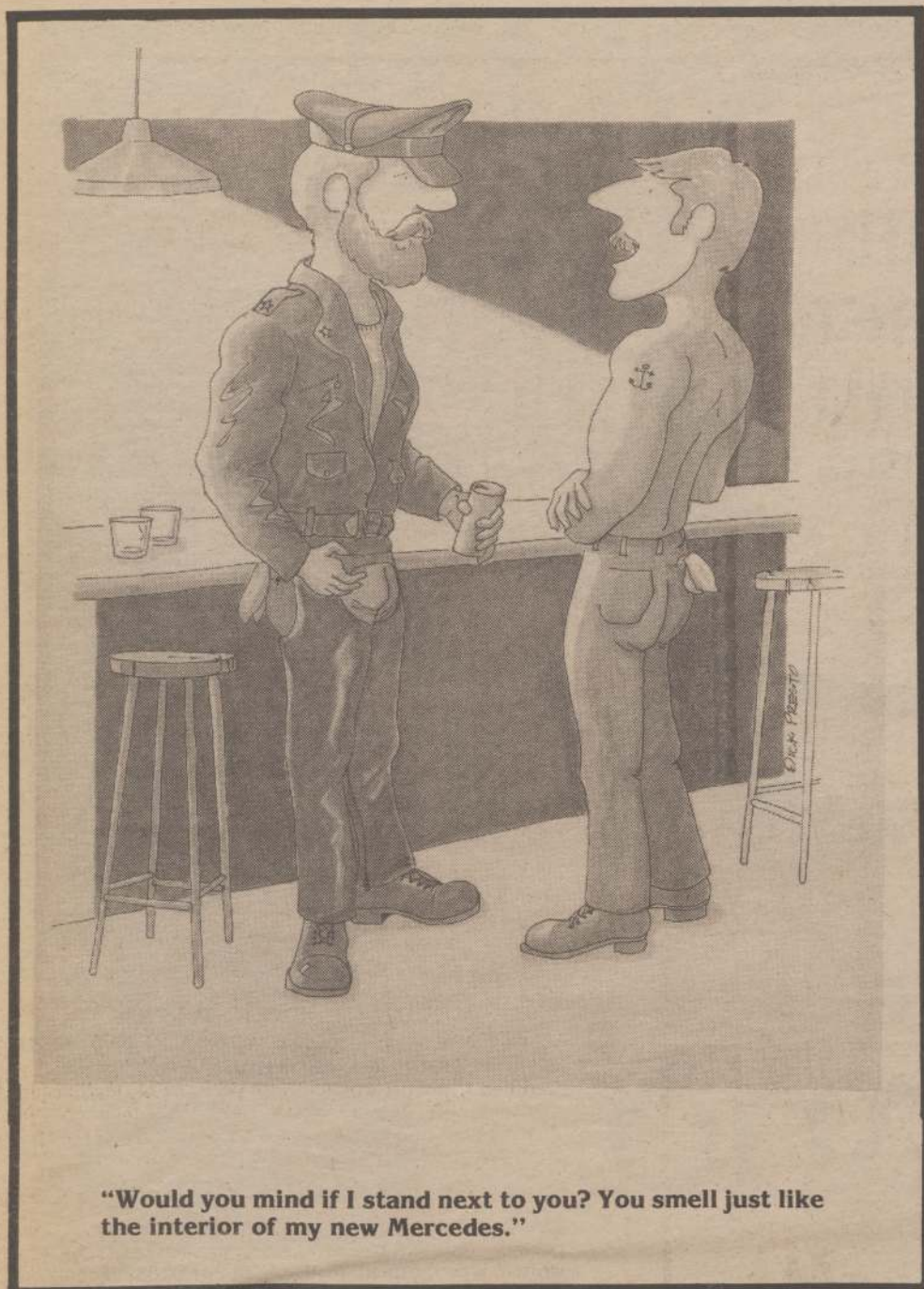

I also mentioned something called a modem which is an acronym for 'modulator/de-modulator' and is the device that you use to connect your computer to Ma Bell's phone lines in order to talk to other computers.

I am sure that many of you have seen at least one episode of the new TV show this fall called 'The Whiz Kids', or have seen the movie 'War Games' which came out early last summer. Though both of these shows were a bit far fetched at times, at least from my viewpoint, they did show a lot of the parts that make up an elaborate computer system and how they fit into the scheme of things when the computer is being used. Both of these shows also served to illustrate the power and versatility of small computers and I am sure that if you saw one of these shows you were impressed. Anyway, I have strayed slightly off the subject, but suffice it to say that I will cover many of these concepts in future articles.

Now, for the really important part of the computer system, the software. The KAYPRO IV comes with about a half dozen programs that allow you to do such things as word processing, spelling correction, financial modeling and planning, information management, several programming languages if you want to write your own programs and even the ability to play games. The program I am using to write this text on is a very powerful word processor called WordStar™. This program lets me do such things as enter text, move it around at will, insert, edit, delete, change formats and many other things, all on the monitor screen without ever having printed a word on paper. I can combine one document with another or just parts of several documents together to make the text read any way I wish. Then, when I am satisfied with what I see on the screen, I can print out a copy for final editing, submit the whole thing to the spelling checker which will point out and correct my spelling errors and then print out the final version of my 'masterpiece'. Once you have tried one of these word processing programs, you will give up typewriters forever.

Before concluding this first edition, I would like to mention one other thing which will be of particular interest to our gay community. That is the Gay Press Association in New York. The reason I men-

tion them is because they have installed a microcomputer, similar to the one I am using and have established a 'Gay' wire service which can be called up via the telephone by any member newspaper. These members can then look at the stories that are available and have them transmitted directly into their computer ready for printout and typesetting. This is how authors such as myself can get our articles published in Gay newspapers around the country and provide you with the kind of information you want. As more and more Gay oriented publications join this network, chances are good that you will receive more accurate and timely information.

Thus, the establishment of this network and others like it especially in our community is going to go a long way toward increasing the communication between us and I think, to ultimately put us in the forefront of those coping with and achieving in, the 'information age'. Hasn't it been the widespread and nearly instant dissemination of information in the past few years that has allowed us to achieve things we never dreamed possible just five or ten years ago?

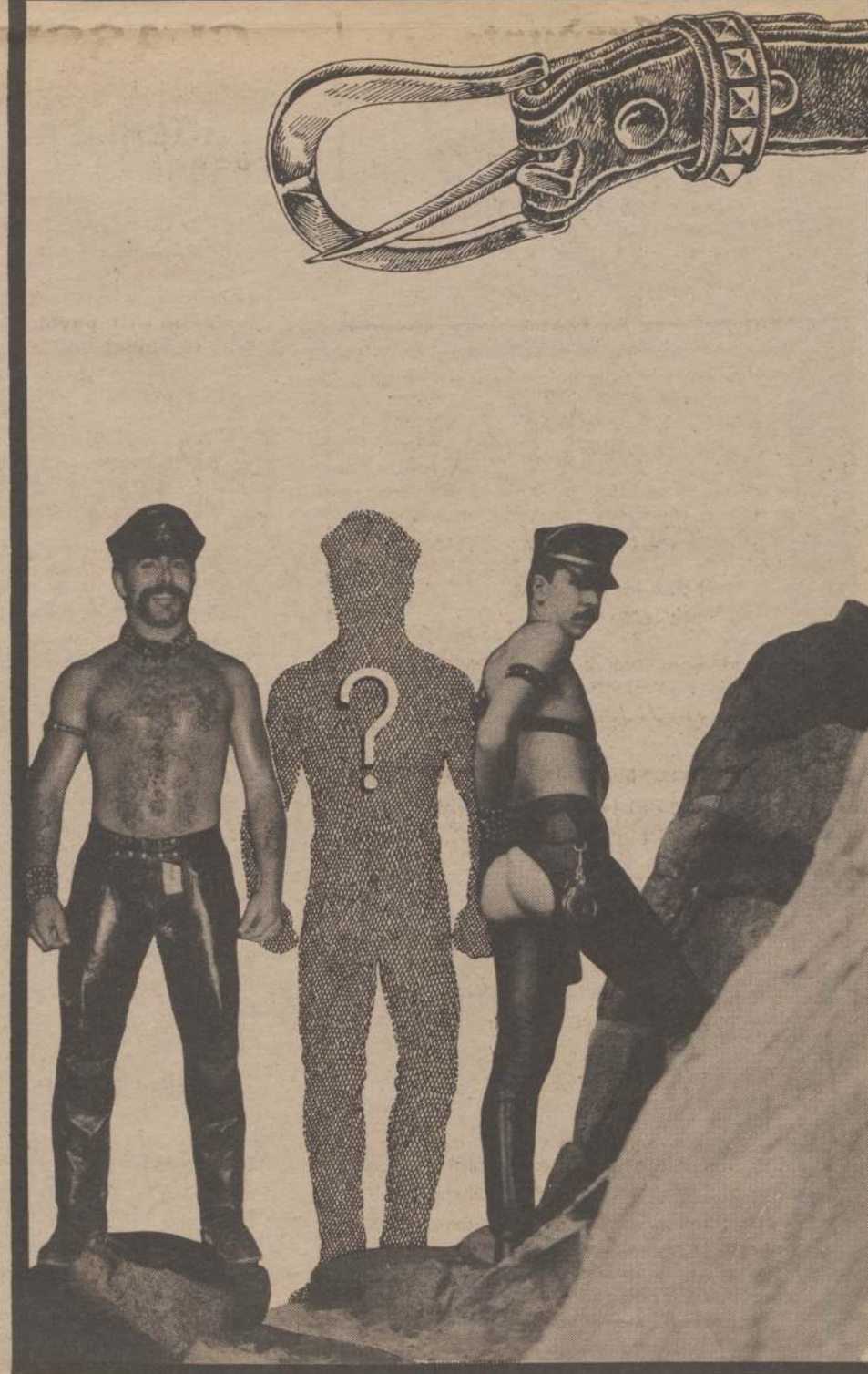
As you can probably tell by now, I am a real fan of computers, but then I have spent most of my working lifetime involved with them, everything from large mainframe machines, right down to the pocket size computers. And now that these tools are relatively inexpensive and available to just about anyone, there is a real need for as much information as possible about these machines and what they are capable of doing for us in our daily lives. So, I hope that as this series of articles progresses, you will gain a better understanding about computers and that it will help to answer some of the major questions you have been asking, especially if you have been thinking about purchasing a personal computer.
