## NGTF assails congressional response on AIDS . . . . .

### Jointly proposes confidentiality legislation with Lambda Legal Defense

Washington D.C. — on August 1, before the U.S. House of Representatives Subcommittee on Intergovernmental Relations and Human Resources, Virginia Apuzzo, Executive Director of the National Gay Task Force, condemned the federal government's "policy of gestures" in response to the Acquired Immune Deficiency Syndrome (AIDS) epidemic. Apuzzo told Subcommittee Chairman Ted Weiss (D-NY), "A detailed look at the federal government's response to the AIDS crisis leads unavoidably to the conclusion that in this Administration, there is a sharp contrast between the rhetoric of concern and the reality of response." She cited six areas of failure by the federal government — "the failure to expedite funding for AIDS research; the failure to provide proper methods of funding for AIDS research; the failure to educate the public to stem hysteria about AIDS; the failure to address the specific question of the safety of the blood supply; the failure to include affected groups in decision-making; and the failure to recognize rights of confidentiality and privacy."

To rectify the last of these shortcomings, Apuzzo announced that NGTF and Lambda Legal Defense and Educa-

tion Fund are proposing that Congress enact legislation which will extend privacy protection of medical, surveillance and research documents to all persons who are part of a federally funded research or surveillance program.

Addressing the question of funding methods, the NGTF Executive Director noted that the Administration was diverting funds from other important health care programs to work on AIDS that is inadequate at best. "There is no excuse," she asserted, "for the United States government, faced with medical emergencies, to force choices between groups who need help."

Citing an NGTF survey which showed that gay/lesbian community organizations had budgeted \$6.8 million for AIDS-related work in 1984, Apuzzo noted, "The tremendous outpouring of support for voluntary efforts within the gay/lesbian community has been in sharp contrast to the federal government's response... This administration claims to be committed to rekindling the volunteer spirit in America. Our community has responded to an unprecedented degree."

In her concluding remarks, Apuzzo predicted that the gay/lesbian community would emerge stronger from the AIDS crisis. "We will not forget what we have learned about health care in the United States," she warned. "We will use our growing strength to return to the halls of Congress and of the Executive Branch again and again, until the deficiencies revealed to us over the past few years are remedied — for all Americans."

## Gays and Feds lock horns at Weiss hearings

Homophobia is blocking adequate money for AIDS research. That was the testimony of many witnesses at last week's House Committee hearings into the federal government's response to the AIDS crisis. But an administration official denied the charges, saying that over \$166 million was programmed for AIDS research this year and even more would be spent next year.

The hearings were called by Rep. Ted Weiss (D-N.Y.) before his Subcommittee on Intergovernmental Relations and Human Resources. Among the first witnesses were three men with AIDS who testified what the disease has done to their lives. "It's a matter of day-to-day waiting for something to happen," said Roger Lyon, 34, from San Francisco. "I came here with the hope that my epitaph will not be that I died from red tape."

Twenty-eight year old Michael Callen from New York City testified that he was diagnosed as having AIDS in 1981. "I called my parents and told them I'm going to die. A lot of people are simply waiting — waiting for a life-threatening disease, waiting to die . . . That's my story, waiting for infections."

Virginia Apuzzo, Executive Director of the National Gay Task Force, told the committee that "a detailed look at the federal government's response to the AIDS crisis leads unavoidably to the conclusion that in this Administration, there is a sharp contrast between the rhetoric of concern and the reality of response."

Steve Endean of the Washington-based Gay Rights National Lobby called the level of federal spending for AIDS research "a cruel joke."

This led Rep. Weiss to observe, "After

listening to the witnesses who testified before the subcommittee, I have grave concerns about the federal government's response to the AIDS emergency."

The role of defending the federal record fell to U.S. Public Health Service head and assistant secretary for health, Dr. Edward Brandt. "As long as these human beings are suffering from this illness," he told the committee, "we are going to solve this problem — and solve it as soon as we can."

He said that this year the government has budgeted \$166 million for AIDS research, although he conceded that only a fraction of that money is being spent directly on AIDS, about \$20 million. Most of it, he said, is going for research on the body's immune system. He also said that the Public Health Service budget next year will have \$9 million more for AIDS.

"We have approached this disease in the same way we have approached all others," he said. He also said that charges of discrimination were insulting and that furthermore "at no time have biases or prejudices influenced our decision making."

But promises for money didn't seem to halt criticism. San Francisco health director Mervyn Silverman said almost twice as much money should be spent directly on AIDS research. Brandt replied that what was needed was more ideas, not more money.

Stanley Matek, former president of the American Public Health Association, said the government has no organized plan for dealing with the disease. He suggested that outside scientists be called in to write one.

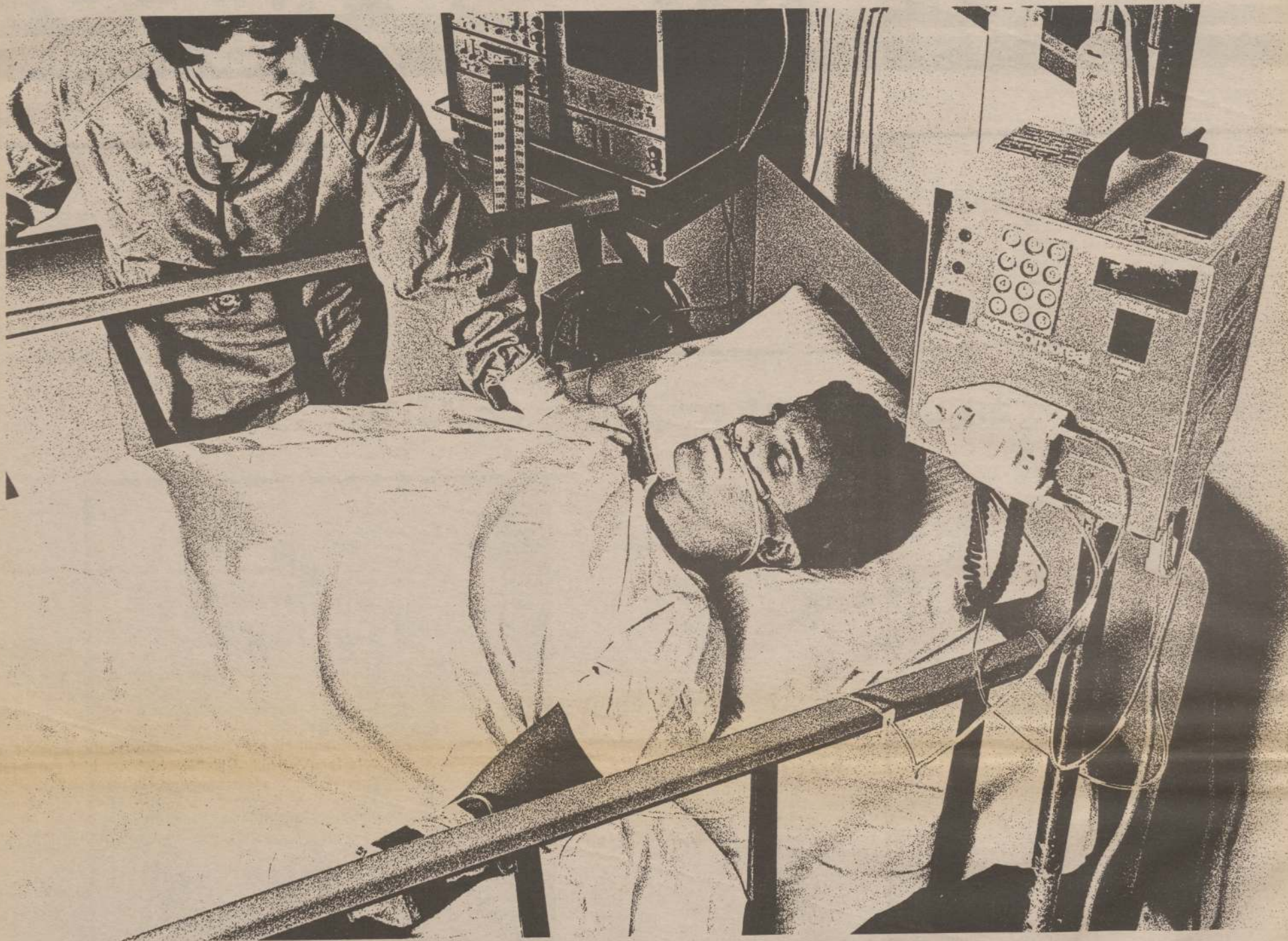

Studies showed that the vaccine protected against infection caused by hepatitis B virus in 85% to 96% of those who received the required three shots.

Hepatitis B virus is an important cause of viral hepatitis, a disease mainly of the liver. Even mild forms of this disease may lead to serious complications and aftereffects, including liver cancer. There is no specific treatment for viral hepatitis.

Vaccination is recommended for persons who have a higher risk of becoming infected with hepatitis B virus because of frequent, close contact with infected people or exposure to body fluids from such people. It will not protect against hepatitis caused by viruses other than hepatitis B virus.

Because of the long incubation period for hepatitis B, it is possible for unrecognized infection to be present at the time the vaccine is given. The vaccine may not prevent hepatitis B in such patients.

In three studies involving 3,350 persons, the overall rate of adverse reactions did not differ significantly in those given vaccine and those given placebo (an inactive substance). As with any vaccine, broad use often reveals rare adverse reactions not observed during clinical trials.

Over 200,000 people are estimated to have received the vaccine since its release, and the vaccine continues to be generally well tolerated. Hepatitis B has a long incubation period, and unrecognized infection may already be present at the time the vaccine is given. Thus, reported cases of hepatitis are to be expected and do not appear to be caused by the vaccine. Reactions such as fever, nausea, vomiting, headache, and local pain have occurred. Joint pain has been reported; rash has been reported rarely. Serious illnesses affecting the nervous system—including Guillain-Barré syndrome—have been reported rarely, but no cause and effect relationship has been established.

## International Report

### Gay Atheists attend world meet

Helsinki (IGNA) — For the first time in history there was an openly gay presence at the World Atheist Meet, held in late June in Helsinki, Finland.

According to Jeffrey Vowles, president of the Gay Atheist League of America, writing in GALA REVIEW, the gay delegates did not have to "beg for admission" the way the Universal Fellowship of the Metropolitan Community Church has been forced to do to obtain its not yet granted membership in the National Council of Churches.

One of the resolutions passed by the world meet members was that religious repression of human sexuality should come to an end. Two others were secular education at public expense and fair access by atheists to news media.

Media coverage of the event consisted of spots aired on the national television evening news, with the Russian delegate speaking in his native language and Madalyn Murray O'Hair speaking in English.

Vowles said that a major difficulty at the convention was the "lack of a common language or a professional translation/interpretation service." Speeches sometimes had to be translated several times and often inadequately.

Vowles said that his experience with the Russian atheists convinced him that "unbelievers from countries with established monotheistic religion can expect little or no help from the bureaucratic atheists of the Soviet Union." He was far from impressed with Victor Garadja, the Russian delegate who heads the government-financed Atheist Institute in Moscow. Vowles' complaint was about Soviet reticence and passivity, especially considered in the light of Ms. O'Hair's verbal attacks on the sanity of President Ronald Reagan.

One of the highlights of the meet was a demonstration by the Indian atheists to expose the fraud of holy men.

Vowles said that the next Atheist World meet would be held in the United States.

It is expected that gays will continue to demand and receive acceptance in the atheist movement "while still maintaining a separate identity and contribution."

## National Report

### NGTF urges people with AIDS to apply for Social Security benefits

The Social Security Administration announced on July 15 that it had made permanent its temporary April 26 directive authorizing people with AIDS to collect social security disability benefits.

People with AIDS may qualify for a variety of government benefits. Supplemental Security Income (SSI) is a needs-based grant program available to people with limited income and resources. Title II "early retirement income" grants, on the other hand, are available to FICA contributors who are no longer able to work because they have AIDS.

Because the great majority of people with AIDS who are no longer employed are eligible for SSI or Title II grants, NGTF urges people with AIDS to apply for benefits. To find out if they qualify financially, people with AIDS should contact the nearest Social Security Administration office. Applicants who meet the SSA's economic criteria must then contact a state Disability Determination Office, where they or their health care provider will be asked to provide objective medical verification of an AIDS-related opportunistic infection (including, but not limited to, Kaposi Sarcoma and pneumocystis carinii pneumonia) before they can receive benefits.

Despite the widespread availability of social security benefits, the number of people with AIDS who have applied to date is surprisingly low. Although approximately 2,000 cases of AIDS have been confirmed by the Center for Disease Control, the Social Security Administration reports only 230 applications for benefits as of August 5. SSA officials add that fully 96 percent of these applications have been accepted.

"We are extremely concerned that so few people with AIDS are applying for benefits to which they are clearly entitled," stresses NGTF Executive Director Virginia Apuzzo. "Once again we see a critical need for a government-funded public education campaign about AIDS." NGTF encourages people with AIDS who have questions about benefits to call its crisisline at 1-800-221-7044 (212-807-6016 in New York State), and further urges AIDS service organizations and the gay media to continue their efforts to inform people with AIDS about available benefits.

## Dan White parole can't be halted

Sacramento, CA (IGNA) — The governor cannot legally delay the January, 1984 release of convicted assassin Dan White, the state's attorney general has decided.

Responding to a formal inquiry from George Deukmejian, Attorney General John Van de Kamp said that White must be released from prison next January 6 because he was sentenced under California's determinate, or fixed-term, sentencing law.

Van de Kamp drew a distinction between White and murderer Archie Fain, whose prison release was blocked by the governor. Fain had been sentenced under the older indeterminate sentencing law and thus the governor could revoke his parole.

The distinction between the cases is that Fain's parole is discretionary and thus can be cancelled by the governor if the public outcry warrants it, but White's parole is mandatory.

Deukmejian may ignore the attorney general's legal opinion, but usually officials follow such advice.

The opinion drew a protest from John Wahl, the lawyer representing the estate of the late Harvey Milk. "Dan White has received special treatment from the beginning," Wahl said.

He added: "There is no basis for making a distinction between Fain and White. Basically this is a tortured opinion; the logic is tortured."

Wahl is also pursuing a campaign to have the U.S. Justice Department file charges against White in federal court under Title 18, United States Code, Section 245, which allows the government to prosecute anyone who "by force injures any person who is or has been engaged in campaigning or qualifying for elective public office."

Wahl claims that White's murders "intimidated others . . . from attempting to run for office," and adds: "Under the circumstances of these killings and the absurdly light sentence, a prosecution under Section 245 is clearly necessary to secure substantial justice."

Fain's "indeterminate" sentence was life in prison, while White's "determinate" sentence was for seven years and eight months.

## Sheriff endorses Gay Rights

San Francisco (IGNA) — The sheriff of the city and county of San Francisco has sent a letter to the members of the California Senate who will soon be voting on a proposed gay rights law.

Sheriff Michael Hennessey urged the Senators to vote for Assembly Bill #1, which would prevent job discrimination against gays and lesbians.

Hennessey's letter said in part: "As a professional in law enforcement I know all too well how much actual discrimination goes on in the hiring and employment of gays in this field."

Hennessey further clarified his knowledge of actual discrimination: "I go to a lot of statewide and national law enforcement meetings and seminars. I know the comments and the behind-the-scenes activity which surrounds the hiring of gays and lesbians. Personally I find this to be extremely distasteful and highly unprofessional. Unfortunately, these attitudes and actions have their base in ignorance and in a fear of the unknown."

The sheriff pointed out the openly gay deputy sheriffs in the San Francisco Sheriff's Department. "These individuals have proven themselves to be able deputy sheriffs in the same fashion as all other employees in the department."

Hennessey did not feel compelled to overstate gay performance, but said, "True we have had some gay and lesbian deputy sheriffs not perform up to standards and they have been treated just like other employees who have not performed up to standards."

The sheriff took the trouble to write the Senators because he does "not feel that time alone will erode the discrimination that takes place in the hiring and treatment of gays and lesbians and that is why I feel the passage of legislation is necessary."

The sheriff invited the legislators to meet with the gay and lesbian sheriffs in his department — "Democrat and Republican, black and white, liberal and conservative, excellent employees and marginal employees."

## Lawyer referral for gay people

Los Angeles (IGNA) — A grant of funds from Los Angeles county has allowed the establishment of a Lawyer Referral Service at the Gay and Lesbian Community Services Center.


In addition to the Lawyer Referral Service, the center operates a free legal clinic with volunteer attorneys daily from 5-6 P.M.

The grant of \$25,000 was made possible from Supervisor Ed Edelman's Third District Community Development Block Grant.

Attorney Susan Sholley has been hired to direct the program. "By establishing this referral service, we are making it easier for those in need to protect their legal rights," said Edelman.

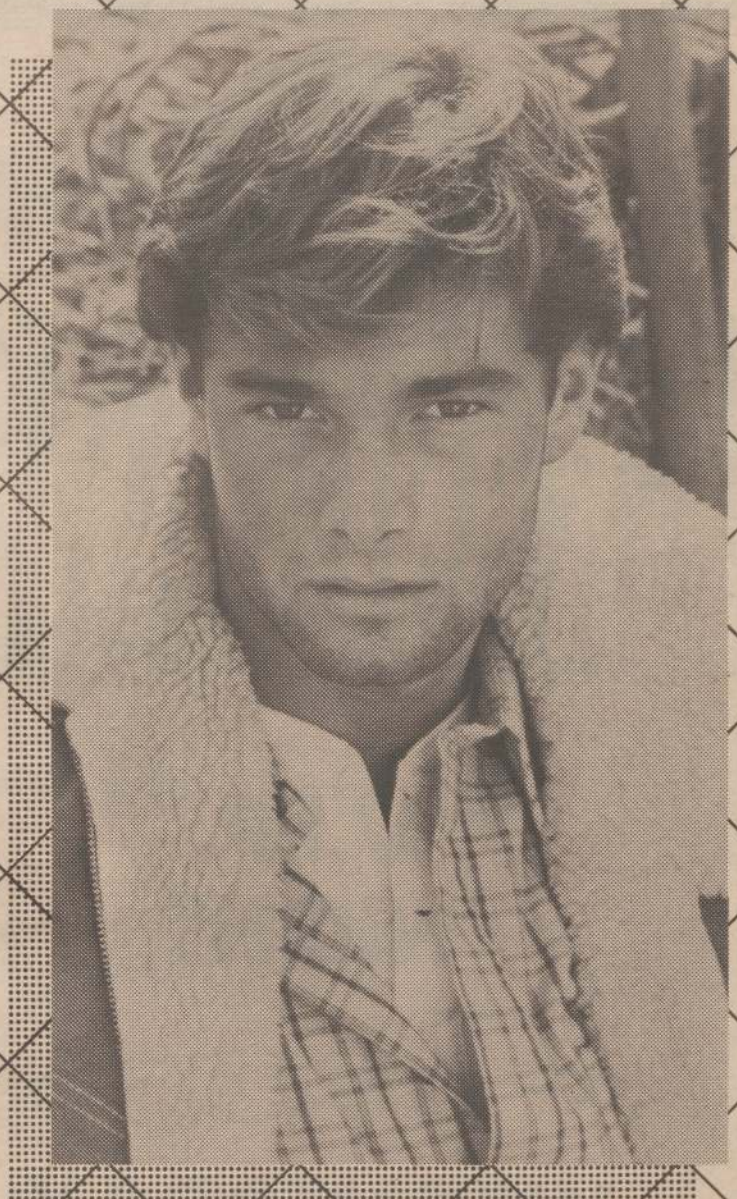

The song ends. "Turn off those cookers," Divine hollers, pointing to the stage lights while makeup runs down her face. A catcall from the crowd rings out: "Turn 'em all off!" Divine looks at the heckler and smiles that you-know-what-

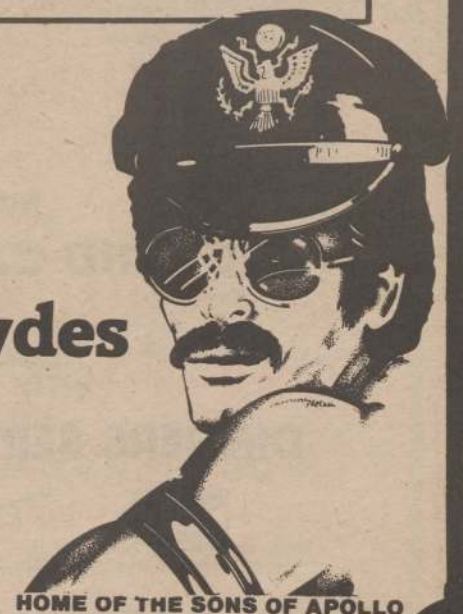

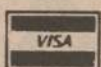

Apparently a number of participants gave their money or check for deposit to other places or other people, assuming it would be turned over to this agency for immediate credit. These funds were not turned over to us by the stated deadline time and therefore hotel room blocks and other services were necessarily released by those establishments and persons suffered financially by an increase of \$10 in the air fare by P.S.A.

You have probably heard or read about the Bar and Business Employees Society — or B.A.B.E.S. I'm very proud to be a part of this group of devoted individuals.

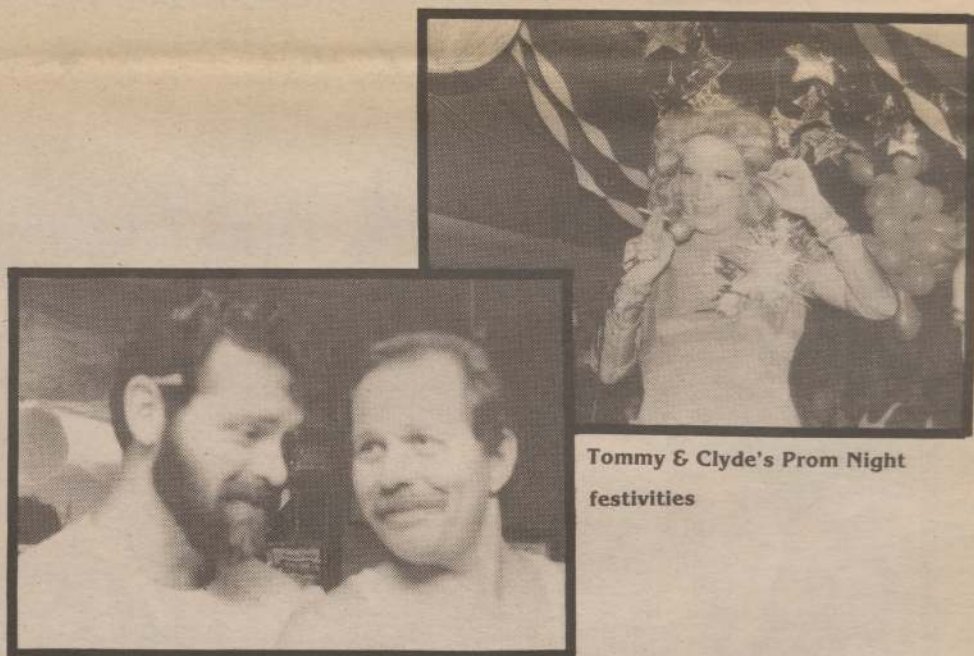

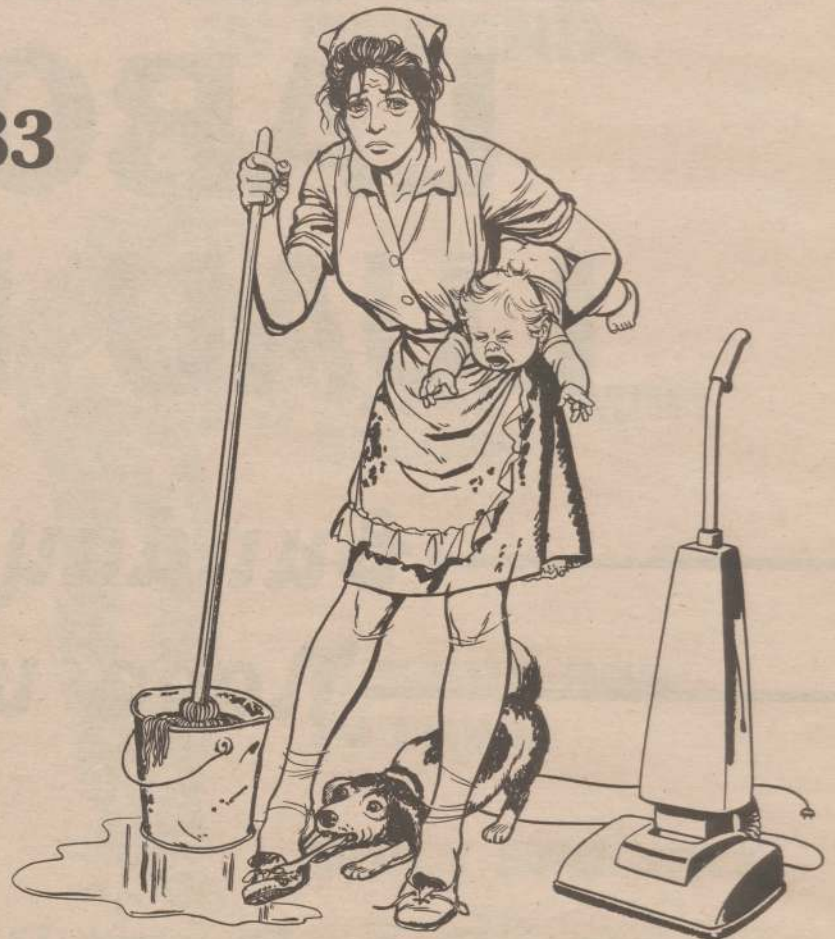

eating grin and snarls, "Fuck you! Fuck me later!" The crowd roars.

"I just got back from England," she rubs the mike under her armpit, "and I wanna tell you about the royal family. There's Princess Margaret, the dyke; I know, I had her last week, and the newest and most hated member of the family, Princess Di — the royal nit-wit. She's the one that fucked Charles and had the baby, right? Now, they're so afraid the baby will fall out of the crib and one of the Queen's Coky dogs would come along and think it was a dog yum-yum and eat it up. And they'd be looking everywhere for the Crown Prince, and where is he? Out in back in a pile of dog shit, and they're gonna call me up to come and find him." Deafening applause from the crowd is greeted by the toothy grin and another song.

Backstage, Divine steps out of makeup and wardrobe and becomes Glenn. He grew up in the suburbs of Maryland, the only child in an upper-middle-class family. John Waters, his cult-status film director friend, was a neighbor. "We grew up together. And went to high school — not the same high school, but we went to high school at the same time together. Every day I used to have a different hair color, and John told me that when he made movies, he would make me a star." Pipe dreams for some, perhaps, but not for Divine.

"John was at NYU taking filmmaking courses when the college kids kicked him out for marijuana. It was a very big deal then. I think they caught him with a half of a roach on him, and they all freaked out and kicked him out."

"So his parents bought him a movie camera and told him to make little movies and be a good boy. We all got together on Sundays because it was the only day of the week that we didn't have school or work or whatever. So, we made movies!"

Those movies were Waters classics like *Eat Your Make-up* (1968), *Roman Candles* (1968), *Mondo Trasho* (1969), *Multiple Maniacs* (1970), and *The Diane Linkletter Story* (1971). Divine and Waters made it to the big time with *Pink Flamingos* (1973).

We make *Pink Flamingos* for \$12,000. It was our first color talking film, and we were so proud of it. It has grossed over several million dollars at last count, and is still a favorite on the Midnight Movie circuit. John wanted the film to be a trip through decadence, and we promoted it as the most disgusting film of all time."

Did Divine mind eating dog excrement? "Well, I thought about it a lot, but I checked with doctors and they said it wouldn't hurt me or do anything to me. It was done strictly for shock value. I threw up afterwards, and then I used mouthwash and brushed my teeth. There wasn't any taste, or should I say after-taste. I just didn't think about it. It made me a star."

"Our next big budget film at \$27,000, was *Female Trouble* (1974). That was blown up to 16mm. Then I went to London to do a play, *The Moon Behind Bars* at the Whitehall Theatre in the West End. That ran for six months and helped me grow as an actor. I think that shows in *Polyester* (1981). My Francine Fishpaw is a real person with depth and character. I loved that part."

There is a new John Waters script that Divine is reading. Glenn would not divulge any information about it, including the name. "John is in Cannes right now, trying to raise money for it. It will be a big budget, compared with *Polyester*, which cost about \$300,000. This one will be about a million."

"It looks like I'm going to make a new movie in Hollywood called *Beverly Hills*. I'm not the star of it, but it's a Hollywood production and has some big names in it. For me, it's a big break and a good one. One that I've looked forward to."

Divine has been up for Hollywood films before, met with producers, directors, and gone through the process of screen tests and readings. "I haven't gotten parts, but I was quite flattered that they thought of me and called me up."

"I was just made up for male role and lost the part to Orson Welles. That was about a month ago. I was flattered that it was between Orson Welles and

and lesbian community has been in sharp contrast to the federal government's response. This administration claims to be committed to rekindling the volunteer spirit in America. Our community has responded to an unprecedented degree."

The claims of homophobia rang true during the hearings. One congressman suggested that the best way to halt the disease would be for gay males to change the lifestyle which seems to have spread the disease. His idea was rejected by a doctor who told the congressman that doing that would force people to deny their sexuality and would be too great a cost even to slow AIDS.

Apuzzo was critical of the way some of the federal AIDS research money was obtained — by cutting back other programs. This practice, she said, forces choices between various groups who need help.

She also took the Administration to task for not recognizing the large amounts of money for AIDS raised from within the gay and lesbian community — \$6.8 million has been budgeted by gay and lesbian community organizations for next year.

"The tremendous outpouring of support for voluntary efforts within the gay

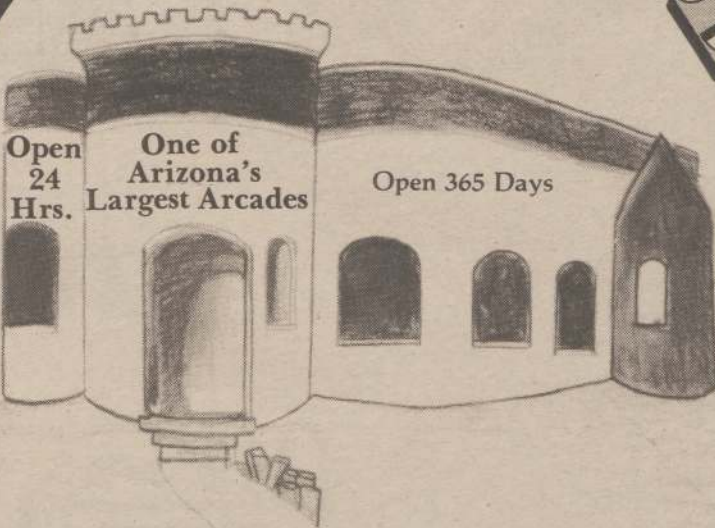
