Anderson promises help for Gays

SAN FRANCISCO - "I'm opposed to discrimination on the basis of sexual preference. And I think that if rights are to mean anything in our society they ought to be codified." So states Republican presidential hopeful John Anderson in an exclusive interview in the forthcoming issue of *The Advocate* (May 15, 1980). In the interview Anderson also tells *The Advocate* that he is willing to co-sponsor both bills dealing with Gay rights currently before the House of Representatives. He strongly backs the first of these, H.R. 2074, which would add "sexual orientation" to the categories covered by the 1964 Civil Rights Act. Anderson announced that he will co-sponsor H.R. 6303 which would stop the Immigration and Naturalization Service from excluding suspected homosexual foreigners. The Illinois congressman also said he would "be willing to sign an executive order to remedy the situation."

Anderson is the only Republican candidate who has faced criticism for voting for a House bill that benefited Gays, and is the only Republican candidate who has endorsed a proposed Gay rights plank in the 1980 Republican Party Platform.

Security ruling prompts suit

SAN FRANCISCO, CA (AP) - The American Civil Liberties Union has filed a suit on behalf of an illustrator whose government security clearance was revoked because he is a homosexual. The lawsuit, filed in U.S. District Court against military officials, is believed to be the first court test of whether the clearance known as "SCI," which is higher than "top secret," can be revoked by the National Security Agency without "due process." It also is believed to be the first test of whether security agency investigators can demand details of government workers' sex lives and then revoke their security clearance if the holder is homosexual.

The case involved Warren Preston, 41, of Atherton, a graphics designer who said he held an SCI clearance for 10 years at Sylvania in Sunnydale, California, where he worked under an Army contract. When Sylvania got a contract from the Navy for another project, he came under a new security investigation.

The suit asks reinstatement of Preston's clearance and \$20,000 in damages for lost wages, injury to reputation and emotional distress from each of the defendants, including the Department of Defense, Department of the Army, Secretary of Defense Harold Brown and Secretary of the Army Clifford Alexander as well as Mayor Lynn Pochert who recommended that the clearance be revoked. During a lie detector test, Preston said that he was a homosexual. He also answered specific questions about his partners and his activities with them.

In May, 1979, the Army revoked Preston's SCI clearance, saying that he "clearly demonstrated his unreliability, untrustworthiness and unsuitability for access to classified information." "I was demoted and humiliated, given time off without pay and then further demoted to part-time work - all of this when I had done nothing wrong," Preston said. In contrast to the Army, the Department of Defense said that Preston's homosexual activity was legal under California law and that it was consistent with the national interest for him to keep his security clearance.

NEW YORK, NY - Citing questions of church-state separation and the spectre of implicit government sanction of Anita Bryant's anti-Gay crusade, the National Gay Task Force has protested the cooperation of the Defense Department officials in the production of Anita Bryant's television program, "Anita Bryant's Spectacular -- My Little Corner of the World." In a letter to President Jimmy Carter, NGTF Co-Executive Directors Charles Brydon and Lucia Valeska wrote, "We are deeply disturbed and dismayed by the cooperation and participation of elements of the Department of Defense in the television program produced by and on behalf of Anita Bryant Ministries."

Noting the military's past and present record of antipathy toward Gays, and the active participation of government in this religious-sponsored production, Brydon and Valeska questioned the adequacy of official guidelines and the judgment of military officials who elected to extend government assistance. "Beyond this and of immediate and paramount concern to this nation's 20 million tax-paying Lesbian and Gay male citizens is the implicit government sanction extended through this cooperation and participation to the virulent and anti-human rights crusade directed against Gay people by Ms. Bryant and for which she has a national identification and reputation," wrote Brydon and Valeska. Pointing to the anti-Gay activity of Anita Bryant Ministries, Inc. and its link with Protect America's Children -- both entities have the same executive director, Edward Rowe -- Brydon and Valeska concluded their letter to the president with a challenge --

"The central question in all this is government cooperation in Ms. Bryant's self-promotion -- cooperation we see as inconsistent with the human rights policies of your administration. This issue -- the willingness of your administration to actively apply the same value to

DULUTH REVISES RIGHTS ORDINANCE

DULUTH, MN (GCN) - The City Council here considered a revised human rights ordinance at its regular meeting, March 24, after bowing to community pressure and striking protections for sexual preference. The ordinance as originally proposed, included protections to areas of sexual preference in banning discrimination in housing and other community services.


However, initial hearings found vociferous objection to the sexual preference protections, and the council, on March 20, ordered an amended version with references to sexual preference deleted, to be submitted to the council for action next week. Objectors had threatened recall action against city councilors if the ordinance passed as originally proposed.

BUENOS AIRES BAR RAIDED ILLEGALLY

BUENOS AIRES, ARGENTINA (GPU) - Pato's, the only Gay bar in this city, has been raided by Federal Police, who arrested 123 men for homosexuality, despite the fact that homosexuality is not illegal in Argentina.

DALLAS BATH SUES POLICE

DALLAS, TX (GPU) - The Club Dallas has filed a \$200,000 damage suit against the Dallas Police Department, claiming that its vice squad is harassing its customers by making repeated and unlawful arrests. The suit alleges that police have arrested 39 members of the Club Dallas as part of an effort to drive its owner, J.W. Campbell and Associates of Texas, Inc., out of business.

The federal suit alleges that 30 persons have been arrested for public lewdness at a private club, where prospective members are advised in writing that it caters only to Gays. The suit goes on to challenge the state's lewdness law, claiming that its definition of a public place is unconstitutionally vague. Defendants named in the suit include Dallas Police Chief Glen Kinga, Police Captain Donald Milliken and Dallas County District Attorney Henry Wade.

JOEL GREY AS HARVEY MILK?

NEW YORK (GCN) - If actor Joel Grey has his way, he will portray Harvey Milk, the nation's first openly Gay elected municipal official who was assassinated along with San Francisco's pro-Gay mayor George Moscone by former supervisor Dan White in Nov. 1978, in a made-for-TV movie to be underwritten by ABC or CBS.

New York magazine reports that Grey is researching Milk's life and short political career, with the help of such of Milk's friends as author Franck Robinson, writer Randy Shilts and political strategist Jim Rivaldo. According to the magazine, several Hollywood producers are vying for material for a Milk movie, but the late politician's friends are supporting Grey because he has assured them of the integrity of his project. Other producers, however, have reportedly planned to downplay Harvey's homosexuality which New York quotes Shilts as saying, "is the main point."

FATHER CAN VISIT SON BUT WITHOUT TRICKS

RALEIGH, NC (GPU) - A Gay father, Sammy Woodruff, has been granted rights to have unsupervised overnight visits with his 4-year-old son. The ruling by the North Carolina Court of Appeals upheld a lower court ruling that such visits were permitted so long as no "boy friends" were spending the night while the son was there. The former Mrs. Woodruff had objected to the all-night visits because of Sammy's "open and Gay lifestyle."

ADVERTISE FOR POLICE CLERKS IN MINNEAPOLIS GAY PAPER

MINNEAPOLIS, MN (GPU) - Some eyebrows have been raised here by the decision of employment recruiters to advertise for police jobs in a Gay paper, the GLC Voice. Civil Service officials have stated that the ad does not represent any special effort to recruit Gays for police jobs, nor a special effort to calm tensions between Gays and police following a recent police raid on a Gay sauna here.

Captain Jack McCarthy, head of the Minneapolis Police Department's Personnel Department, notes that the department has no official policy on or against hiring Gays. "The only way we know if someone applying for a job is Gay or not is if they make an issue out of it. We don't know, and we don't care."

MATSUI #53 CO-AUTHOR OF HR-2074

SACRAMENTO, CA (GPU) - Congressman Robert Matsui has become the 53rd co-author of HR-2074, which would amend the Civil Rights Act of 1964 to include Gay persons. By co-authoring the bill, Matsui has fulfilled a promise which he made speaking to a group of Gay rights advocates in the spring of 1978 when he first ran for the Democratic nomination for Congress.

"It has been twelve years since the enactment of the Civil Rights Act of 1964," Matsui noted, "and yet numerous classes of Americans including Gays, are still fighting to be freed from unwarranted and arbitrary discrimination. The time is long overdue to provide the necessary legal safeguards for Gay people in Sacramento, as well as the estimated 20 million nationally."

Matsui, who is running for re-election this year, has hired Gay rights supporter Clint Reilly to head his campaign. Libertarian and anti-Gay candidate Robert Lynch, former member of Los Rios Community College Board, announced earlier that he would run in opposition to Matsui, but has since dropped from the race. Political observers here claim that Matsui has a safe seat for re-election.

TUCSON - On May 2, 3 and 4 and again on May 9, 10 and 11, at the Invisible Theater, comes a play that should be of special interest to the Gay community. "From Monogamy To Menagemy" is a play dealing with the Lesbian sensibility, written and directed by Linn Lane, a Tucsonan. The play deals with the lives of four women, who deal with their own responsibilities to problems, brought on by group peer pressure, as determined by a set of standards given to them before coming out.

The possibilities given a structure like this are almost endless, and that it's been done with style, wit, and an easy grace, make this two-act play a must see. But what makes this even more delightful is that it was written by a local Lesbian. We are given a rather precise view of life that some of us may have no concept of. All too frequently, works of literature dealing in this theme are written by men who seem to want to titillate the heterosexual audience instead of presenting the real and complex views of lifestyles that are as true to the human condition as Food.

Written, directed, staged and acted entirely by women, is reason enough to go and participate in the joys of theater. "From Monogamy To Menagemy" premieres May 2 and all theater-goers are welcome. More on Washington for Jesus

WASHINGTON, DC - An organization called "One Nation Under God" is making a serious effort to pressure Congress this year. It is led by a group of right-wing ministers, many of them religious broadcasters, who seem to regard the political program of the New Right as a necessary part of religious life. They are urging Congress to pass severe restrictions on abortion, divorce, unmarried couples, women's rights, Gay rights and even public education and foreign policy as a matter of religious necessity. They are calling on members of Congress to regard themselves as

"Servants of God first, and then servants of the people." Their program comes close to setting up a theocracy in this country.

They are now engaged in a direct mail lobbying effort. On April 28 and 29 they plan to bus over a million people into Washington for a series of events (marches, rallies, lobbying in person) which they call "Washington for Jesus." This group is large and well financed. It commands the resources of three television networks (The Christian Broadcasting Network-700 Club, the P-T-L Network and the Trinity Network) and a professional direct mail organization. Their political power in some states, Virginia and North Carolina for example, is acknowledged by politicians there.

Interchange, an alliance of several concerned groups set up to monitor and respond to the New Right, is working to inform Congress and the press of four basic facts:

1. "One Nation Under God" does not hold a monopoly on religion; most American Christians disagree with its aims.
2. The organization is political.
3. Their program is repressive, and abhorrent to most Americans.
4. They are powerful enough to be dangerous.

Part of the Interchange effort is a major press conference in Washington for April 29. Several speakers, including Rep. Don Edwards, Father Joseph O'Rourke, and noted civil rights advocate James Farmer will attend. A statement of the issues with the implications of the activities of the New Right will be read, together with names of organizations who agree with it. Gays help in crime cleanup

SAN FRANCISCO - Gay merchants and homeowners in the Castro-Market area have been quietly working with police for weeks in what now seems to be a successful effort to rid the area of rampant trafficking in drugs and other crimes. More than 80 arrests involving drug charges have been made in the area in the last three months by police, who said that only "only a handful" of drug arrests had been made in previous months. There has been a marked decrease in muggings, armed robberies and other crimes, they said.

Police Captain George Jeffery said, "We've been successful in the cleanup and a lot of the credit goes to the people in the area. They may have a different sexual lifestyle, but they are essentially middle-class people with great investments in their homes and businesses and they want protection just like anyone else." Some Gays had charged that part of the crime problem was caused when Supervisor Harry Britt insisted last year there be no uniformed patrolmen in the area. Asked about the charges, Jeffery said they were initially true. "At first he thought that would be a popular issue but he's matured a lot in the job," the captain said. "Once he realized the Gay community is no different from any of the others, he's become somewhat a supporter of police presence in the area. "The big cry now is that they want more police strength, not less."

Britt, however, said he has always favored more uniformed police strength in the Castro, with one exception. "People can't get this thing sorted out in their heads that the only time I ever objected to police being in the Castro was on May 21, the night of the City Hall riots, when I said at that particular moment in time the police had not business there," Britt said. "But we obviously need more police on Castro because it's a dangerous place. We need them on foot and not in cars so they can develop a rapport and sensitivity to the community."

Steve Stegman, president of the Eureka Valley Merchants Association said, "There were pushers and a bunch of young straight kids harassing Gays and all kinds of problems for a while. Then the merchants took it upon themselves to do something about it and with the help of the police we did it. The vice squad came down and did an incredible job. We now have one of the cleanest streets in the city."

Tucson Gay Pride Committee Formed

TUCSON - On Monday, April 14, representatives of eight "community" organizations together with numerous individual Gays and Lesbians met to form a Tucson "Gay Pride" Committee.

The Committee drafted a list of prospective activities for consideration of inclusion in the June 22 through June 29 Tucson "Gay Pride Week" observance. It was unanimously agreed that the activities should center on a theme stressing the humanity, spirituality, creativity and productivity of Gays and Lesbians as we move into the 80's. Four standing sub-committees were formed to deal with the Publicity, Security, Gay Pride Picnic and an Evening of non-denominational Spiritual Expression. Four exploratory sub-Committees were established to investigate areas of An Evening of Women's Expression, An Evening of Youth Expression, An Evening of Political Encounter and a Film-fest.

The finding of the 4 exploratory sub-committees will be presented for evaluation in the Tucson "Gay Pride" Committee meeting scheduled for 7:30 p.m., Monday, April 28 at 739 East 5th Street (Near Euclid). Hopefully, the four sub-committees will be converted to standing sub-committees representing feasible activities for inclusion in the week-long observances. Two factors to be concluded in this meeting will be determination of a promotional "theme" and formation of a sub-committee on Finance.

Bryant tax return tells all

HOLLYWOOD, FL - Anita Bryant Ministries for Counseling Homosexuals has filed federal income tax statements indicating that she spent only \$150 for counseling from \$968,000 she raised in her 1978 morality campaign. The IRS documents made available through a Freedom of Information Request indicate that Anita Bryant Ministries, Inc., instead spent over \$454,000 in "direct fees for raising contributions" and bankrolled over a half a million dollars of the remaining contributions.

Under IRS regulations, information on the recipients of the fundraising fees are not made public. But IRS officials concede that all of the \$454,000 could have gone to Bryant herself for promotion of her organization. Bryant's group received a temporary approval for tax exempt and tax deductible status in 1977 pending her ability to show her organization actually engaged in charitable activities through the 1978 tax year. IRS officials refused comment on whether the returns would justify granting permanent tax advantages to Bryant, but did indicate that as a new organization the returns would be subject to full audit.

In total, Bryant reports that her group spent only \$56,000 on programs with only \$150 of that going to counseling. The bulk of the expenses of the \$56,000 were for a "documentary," and both press and photo expenses as well as "Christmas gifts" exceeded actual counseling costs. Bryant also reported spending no funds for either direct or indirect political activity although IRS permits up to 20 percent of the funds from such organizations to be used for those purposes. However, no record of separate incorporation for Protect America's Children could be immediately located at IRS offices, raising questions about a possible overlap of the two groups in conflict with IRS rules and the tax filing.





Magazine misleads in rights fight

SAN JOSE, CA - In August 1979, the Board of Supervisors of Santa Clara County and the San Jose City Council each passed ordinances prohibiting discrimination in employment, housing and public services based on an individual's sexual orientation. A small but well-financed and well-organized group of anti-human rights zealots and religious fundamentalists circulated petitions forcing both ordinances onto the June 3rd ballot. These same fanatics are also committed to driving each elected official supportive of Lesbian and Gay rights out of office. Now, though coincidence or on purpose U.S. News and World Reports magazine printed a very erroneous report on monies being raised. The following press release was received from the Santa Clara Valley Coalition for Human Rights. (Contributions may be sent to SCVCHA, P.O. Box 2066, San Jose, CA 95109):

"The U.S. News and World Reports has seriously hurt the Santa Clara Valley Coalition for Human Rights campaign by publishing misleading information about the campaign. WE ARE DESPERATELY SHORT OF MONEY. This is despite what the magazine said in its April 14th issue, on page 93, in an article entitled, "A New Big Push for Homosexual's Rights." The damage is done in the first paragraph as follows:

'When citizens in San Jose, Calif., organized to repeal a law that banned discrimination based on sexual orientation, homosexual groups quickly raised \$250,000 to fight the June vote.'

"We have not raised quickly any money. The money has been slow in coming in and isn't a quarter of

the above stated figure. We are often desperate for funds and are now desperate for funds. Our opposition is sending out mailings and appears to be very well financed.

"It appears that U.S. News and World Reports purposely mislead their readers. According to Johnie Staggs, campaign manager, no one from the magazine has contacted any member of the coalition's staff. This paragraph will only stimulate the conservative readers of the magazine to donate to the homophobic opposition and Gay rights supporters not to donate to the Coalition for Human Rights.

"Finally it is interesting that U.S. News and World Report has selected the terms "citizens" and "homosexual groups." All homosexuals in our Coalition are citizens.

Gay rights gains support in Texas

HOUSTON - The Texas Human Rights Foundation (THRF) has announced its support of a suit filed in November attacking the Texas Homosexual Conduct Law, Penal Code Section 21.06. Section 21.06 penalizes sexual relations between consenting adults of the same sex in private. The suit filed in Dallas Federal District Court by Dallas civil rights attorney James C. Barber, was on behalf of a Dallas man.

Arizona Gay News

The Texas legislature in 1973 adopted the Model Penal Code of the American Law Institute and added to it Section 21.06. The model code endorsed by the institute does not recognize homosexual activity as criminal. Since 1960, 23 states have eliminated laws similar to the Texas Homosexual Conduct Law. In 1974, the American Psychiatric Association passed a resolution supporting the repeal of criminal statutes singling out homosexual acts by consenting adults in private. In addition more than 30 professional, social and religious groups have endorsed similar statements, including the American Bar Association, American Medical Association, National Council of Churches, United Church of Christ, National Federation of Priests' Council and the Young Women's Christian Association.

A Louis Harris survey, conducted in December 1978, found that 70 percent of the public believed that homosexual relations between consenting adults should not be penalized by law. More than 120 corporations have amended their anti discrimination policies to include Gay men and Lesbians. Included in this group are Exxon, Bank of America, IBM, Proctor & Gamble, Adolph Coors Co., and American Airlines.

While people in Texas maintain a much lower profile than their counterparts in Boston, San Francisco or New York City, they are more and more coming out of the proverbial closet. Steven H. Shiflett, president of Houston's Gay Political Caucus and a member of that city's Gay executive and professional association, was quoted as saying, "Gays are the epitome of capitalism" in a recent

issue of *Business Week*. Shiflett cites Gays' representation across the spectrum of business, with a special emphasis on real estate.

The suit seeks to have Section 21.06 declared unconstitutional and barred from enforcement on the grounds that it violates the individual's right to privacy, due process and equal protection of the laws guaranteed by the first, ninth and fourteenth amendments to the U.S. Constitution.

A spokesperson for the National Gay Task Force in New York says, "Today, companies are much more aware that they have many Gay people on the staff - from shipping clerks to the president - even if they can't identify them. Even three years ago, most companies weren't preceiving us as a legitimate or large minority. Many still don't." The Texas Human Rights Foundation, founded in 1976, is a non-profit, public litigating corporation chartered by the State of Texas. Its purpose is to fight discrimination on the basis of sex, race, creed, national origin, age, handicap status and sexual or affectional preference.

DEVELOPING A GAY IDENTITY (PART III)

by Dr. Betty Berzon

THE PHANTOM POPULATION

Let me talk a little bit about why it's important for us to label ourselves politically. We are basically, at present, a phantom population. The politicians are going to continue to say, "there are not enough Gay constituents for me to pay any attention to this Gay legislation that you're proposing I support. It does not have enough significance for me politically because--" and I have heard politicians say this about areas where I knew thousands and thousands of Gay people who are voting citizens, live -- "there simply are no Gay people in my constituency." And as long as we are a phantom population, they'll continue to say that.

The regulatory agencies will say, "Gay people do not comprise a significant component of the community for us to pay that much attention to their needs." Now, that may sound kind of esoteric to you, but it isn't esoteric. The Federal Communications Commission is a regulatory agency. It is bound by law to determine what the significant elements in the community are so that those elements can be represented on the publicly owned airwaves. Now, as taxpaying and voting citizens of this country, we have the right to be included in their determination of what makes up a community.....There's been something of a breakthrough in that regard. But as long as regulatory agencies say, "Well, where are all these Gay people you're talking about?" they don't have to pay any attention to us.

The corporate decision-makers will say, "Well, I don't think there's enough Gay buying power for me to pay attention to how our products are marketed or a product that we might develop or an advertising campaign that might be insulting to Gay people. Well, there aren't that many Gay people for us to worry about." You know? "Where are they all?"

And the social agencies will continue to say, "Well, there's no demonstrated need for us to develop special programs for Gay adolescents. Where are all the Gay adolescents?" Special programs for the aging Gay people? "I don't know about that. Where do you see aging Gay people?" Where do you think they are?

So, as long as we don't tell them who we are and where we are and in what significant numbers we exist, they won't pay any attention to us in a very significant way. We're not going to have the voting power and the buying power and the lobbying power to really make a difference. Now, we can only stop being that phantom population when we start

labelling ourselves. And, of course, that's a decision that each individual must make for herself or himself.

GROWTH TRACKS

Now, I'd like to say some things about being self-determining...Sometimes I say to my clients, "What is your life about?" as Gay people. When I say that to my clients, very often they look at me quite blankly. "What do you mean, what is my life about?" And then when I press them, they begin to get very nervous. Because, for a lot of Gay people - perhaps most Gay people - there's no ready answer, as there is for non-Gay people.

For non-Gay people progress in life is measured by a pre-determined pattern that revolves around the development of the nuclear family. A great deal that happens to you in your life is about, one way or another, becoming a partner in marriage and becoming a parent eventually. That's a major track of modern life, the nuclear family track. And, it even may be something that one decides that one is not going to do, but at least there is something you're deciding you're not going to do. It is a major track along which most people's lives move. And it is the way in which non-Gay people calibrate the progress of their lives.


That's possible because this track has these guideposts along it, they're kind of symbolic markers along the way. We think in terms of who we care about, first dates, courtships, engagements, marriage...These are the kinds of things that give comfort, because you know that someone has passed this way before, that kind of something is known about the journey ahead. And we are surrounded by all kinds of information that tells us that this is what life is all about. You know; you grow up, you get married, you have a family, have children, the children grow up and have a family, and this is what life is about.

And there are all kinds of ritual events that go with these developments. And these ritual events are very important for giving form for the lives of the people who are involved with them. And they provide a framework for identity.

One of the first major traumas for practically everyone when you begin the process of taking unto yourself a Gay identity...is the realization that you have lost this framework...for identity in your life. And, so, then what? So, what is your life about? So, how are you going to know whether you're making progress or not? Unless you deal with that loss, and unless you've come to grips with it, and unless you acknowledge it and admit it, you're not really ready to go in the development of your Gay identity.





News Briefs

OKLAHOMA FAMILY CONFERENCE HO HUM

TULSA, OK (GPU) - A family is parents or a parent and child - not Gay couples not even unmarried cohabitating heterosexual pairs. Such was the conclusion of the Oklahoma Conference on the Family held in Stillwater. Participants included church groups, social workers, grandmothers, nuns, and a strong contingent of "pro-life" groups who brought their infants to the sessions.

A number of professionals who were present expressed grave concerns that the stance of the conference did not meet the needs of Oklahoma families not fitting the traditional molds. Their concerns were voted down.

Other highlights from the conference:

"There's no word sweeter than 'mother' and the nurturing of children is the most important career."

"The place for sex education is in the home."

"Divorces are too easy to get."

In a final orgy of liberalism, the conference pontificated:

"Men should be considered in child custody cases."

BRYANT TO UNITED KINGDOM?

LONDON, UK (GPU) - During a conversation with an English freelance journalist which was later reported in London's Gay News, Anita Bryant's husband, Bob Green, confirmed that the actress-singer was not only coming there with her family for recording sessions, but also that some consideration was being given to moving to the United Kingdom. He added that the family had often considered settling in Oxford. Gays, he suggested, were becoming too aggressive in the States. "They're asserting their power there. They don't act like that in Britain."

During the family's next trip to the UK, Bryant will take part in a low-budget religious television program entitled, "The Controversialists." A 30-minute interview had been scheduled with her for transmission, but the producer of the series was contacted by Bryant's secretary in February and told that she would not be in London on that date. Ms. Bryant even has a favorite pub in Oxford, The Swan. To no one's surprise, it is not listed in any of the British Gay guides.

During his conversation with the freelance journalist, who never raised the question of homosexuality, Green interrupted his volunteered remarks on Gays, stating in a wondering tone, "Why am I telling you all this?" Why indeed?

F O U L !

TORONTO, ONT (GPU) - Ken Campbell, the self-ordained evangelist, fundamentalist minister, and seminary drop-out, has cried foul to the Ontario Human Rights Commission. His claim is that some Gay owned businesses in Toronto are discriminating against self-confessed heterosexuals. In a letter to the Commission, Campbell called upon the Commission to denounce the "anti-social practices" of members of the Lambda Business Council who offer a 10% discount to Gay customers.

Rev. Campbell, known throughout the Toronto Gay community as "Crazy Ken," has been one of the most outspoken critics of efforts to include sexual orientation in the Ontario Human Rights Code.
