**S**o wrote Republican candidate Richard F. Koppe, Jr., of Eloy replying to the 1978 Candidate Poll recently sent out by CCR Lobbyist, Ron Atkins. Mr. Koppe answered affirmatively to the support of decriminalization of private consenting adult sexual behavior and prohibiting discrimination based on sexual or affectional preference. He was undecided on the ERA. Complete results of this Poll will be out soon. The Poll is the second in a series designed and produced to provide the basis for voter information at this critical time for all of us. When asked about the replies to the Poll, Ron said he thought we were all in for some surprises. "The Poll," he said, "along with other data we've compiled, will give us valuable information about where the candidates and incumbents stand. A few of them are *definitely* our friends, but some of them *really* hate us."

Asked when the information would be released, he replied, "Soon — well-before the election. But I'm waiting as long as possible so we'll have a complete view of the candidates. Some of these people are awfully hard to get to. A lot of them even have unlisted telephone numbers. I can't believe it —

running for office and not available for comment. I don't think I can trust a man running for office who can't be reached..."

Some of you are about to stop reading, saying, "Here goes some more of that political crap...I sure am tired of it. Why do they insist on spending so much time boring us with this stuff?" Well, DON'T STOP READING! You need to know these things, or can't you understand? Perhaps I should explain it all again:

In Arizona, we Gays are in trouble — and most of us don't even know it! Our legislature has already tried once to "put us in our place" with the Proposed Criminal Code Revisions last year. What that group of pompous old fundies tried to do was unforgiveable. You and I and 200,000 other Gay people in Arizona could virtually have lost *everything* had that atrocity become law. Under that thing a Gay person even breathing might as well be a felony.

#### INTOLERABLE!

We did something about that. 600 of us—out of 200,000?—made ourselves known and stood up for our — your — rights as taxpaying citizens. That feeble attempt at mass demonstration at the State Capitol caused such a furor in those lofty buildings that they compromise those laws. We were heard. It worked. Were you there with us — I didn't notice you...

Oh, but that's not the end of it. Out of the wood-

work comes the *Orange Crone*, Anita Bryant. And among the straws in her broom are people like John Briggs (more about him later) and half the membership of the Southern Baptist Convention.

Over the moon she flew spewing forth dirty words about Gay people; about their "sin", and dubbed all "child-molesters". Anita even came so close as Tucson. Oh yes, we went there too, and battled the fundies (there's that word again). No one won that time. But we did get a taste of the bad side—of the REAL hate, the furious chanting of those spell-bound drones—the fundies. You weren't there... Figures.

Across the country, precious laws are being plucked from the leather-bound books of rules, and

Anita smiles — she's found her unsuspecting targets. It took years of hard work, the expenditure of more time and money than you can imagine to ensure equal rights (not *special rights*) for Gays in those cities. And in moments, hypnotized by religious and moral fervor, people — like your neighbors? — went to the Polls and TOOK AWAY the rights of Gays...not just in a couple of places, but ALL OVER the country. And Anita smiles...

And while Gays everywhere danced to *Macho Man*, John Briggs and his boys were busy drafting an initiative bill directed at Gay Educators. Not only did they draft it, but with the help of Anita and people like Jerry Falwell who are out to *Save America!* they managed to acquire enough signatures to get it on the California November General Ballot. And her smile becomes a grin.

"California...oh yes...it's over there by the ocean." Yes, it is. But it's also just over our western border. And on bills, as California goes, so goes Arizona most of the time.

But in California, people — Gay people — are busy. Gay people in California are busy being political. They're working to defeat this *New Naziism*. Large sums of money are being raised to educate and inform the voting public and to fight — fight for the very survival of California's Gays. But they got a late start...it may be *too* late.

And then what? Then us. You and me. What? You aren't a teacher? Well, neither am I. But, don't think for a moment that they'll stop with the teaching profession. As the fundies do their brainwashing and gather up their growing forces, other forms of repressive legislation will be passed and enforced. Good-by bars, good-by baths, good-by good times. But worse! Good-by job, good-by right to vote

That was the easy part. The hard part is the work that we all must do. A whole lot of committee work is right now being done by a few, but many are needed, ALL are needed.

If every Gay person in Arizona would stand up together, would vote as a block (that's called *Unity*), and would demand to be among the Non-Persecuted in this state, if we'd do that, then we wouldn't need to worry about all of this. But, because you, reading this, haven't taken that step, we all still have to worry — some of us have to do absolutely everything we can, and worst of all — we may ALL suffer because you didn't care enough to help protect your own human rights!

What a statement! And what a slam at THOSE people — Anita and her fundies — horses in the streets, so easily spooked, and so easily stampeded.

What we're working and hoping for is just that statement, but the By-Line should read, "The Arizona Revised Statutes", not Lady Randolph Churchill!

But the time is now! Right now, you've got to fire yourself up to vote, to work, to care! Afterall, you'll be in jeopardy too, not just us.

If you don't, you can count on it...the days of Gay freedoms and Gay

people in Arizona are numbered. And within two short years you will be feeling it in your own lives. Is that what you want...?



## CCR's "Communistic Position" Revealed?

"When I went to the September 20th meeting, I was shocked to hear the head of CCR say that it was all or nothing — that the members had to vote for the board as it stands or they would all "take their footballs and go home". I had been impressed with CCR until then. I could not believe that a group which calls themselves "Citizens For Constitutional Rights" would present, in my opinion, a Communistic position. They seemed to say, "You, the members of CCR must vote for us all or you will no longer have an organization." Who in their right minds could vote against that? Altho I am not active politically, I feel that we do need a political organization in Phoenix. I only hope that CCR can become that — a political organization."

Somehow, I got the feeling while reading the above in the "Editorial" in Sunday's Childe (October issue) Newsletter (the editorial is a letter from — I mean to — the editor) that I was supposed to be altogether furious over this "slam" at CCR's Steering Committee.

My initial reaction was somewhat-less-than hysterical laughter. "Communistic position," chuckle, chuckle, chuckle... "Who is she (are they) trying to kid?" I mused.

I pondered... "Citizens For Constitutional Rights, holding a copy of the Declaration of Independence, the Constitution (including the Bill of Rights) in its' left hand, and a copy of *The Collected Writings of Karl Marx* in the right..." or should they be in opposite hands...?

No, not quite. Interestingly enough, you'll note that what was said was "Communistic position" and the direct assertion that the Steering Committee members are Communists was never made. But the inference is surely there, and I protest that. I doubt that any of those on that Committee could align themselves with that philosophy, since, for example, the death of homosexuals at the hands of "The Party" is very much the norm among Communists. That reason alone should be sufficient for any Gay person, not the least of whom are the members of CCR's Steering Committee.

Then came a brief "Benefit of the Doubt" time, and I thought, "Perhaps they have some subtle meaning of those words that I am not aware of — better check it out." Off to my Funk & Wagnall's to seek out some obscure meaning to "Communistic position" that would change my mind. Would I find it?

I searched, I read the definitions of every derivation. "communist — communistic — Communist Manifesto — Communist Party." I read them again. "Maybe I need an unabridged edition..." Finally, I thought I'd found it under communism... "...it advocates seizure of power by a conspiratorial political party, maintenance of power during an interim period by stern suppression of internal opposition" and a third usage, this time Communism, "The system in any state based on this theory..." There it was, and clever, too.

By the wildest stretch of the imagination it almost fits. But there are big holes in it: "seizure of power"— No one on the Steering Committee seized power, there being none to seize. "conspiratorial political party"— the Steering Committee neither conspires, nor is it a political party.

"Maintenance of power during an interim period by stern suppression of internal opposition" — Again, there is no power to maintain, nor is there any "internal opposition" on the Steering Committee, only jealousy and back-stabbing on the part of those on the "outside" seeking some type of glory for themselves.

That had to be it. But worse: It was an attempt — another attempt — to malign an already

apathetic community and to undermine the people on the Steering Committee and their endless work on behalf of the Gays in Arizona. When will this end?

The Editorial called the Sunday's Childe Newsletter "the most open, non-judgemental, and honest publication in Phoenix." Striking this kind of malicious blow is just plain dumb. The Steering Committee is doing everybody's work for them and taking everybody's flack. It does not have time for, nor will it tolerate this kind of foolishness. Perhaps "T. Ray" (signator of the Editorial) ought to spend a few days working as the Steering Committee does — against overwhelming odds, and practically single-handedly — doing all the things that nobody else seems to have time for (they're all busy putting out derogative put-downs in newsletter form). If you want something to do, we can provide it. Go walk a few precincts for favorable candidates, join in when we have a mailing to get out, help get people to the Polls on Nov. 7, among others.

We have our eye on Ms. Liberty, not Karl Marx.

NO, not her) I'm beginning to discriminate... "*AND THEY ARE DISGUSTING; ALWAYS PICKING ON CHILDREN, CHANGING THEM INTO QUEERS. IT'S AN AWFUL DISEASE.* Somewhere in the back of my mind

I can hear Johnny Mathis singing "Stand there just a moment darling, let me look at you," but the tune was quickly smashed out with, "*IF I SEND MY SON HERE WILL YOU KEEP THAT 'ONE' AWAY FROM HIM?*" nodding towards the fellow down from me (who is completely straight and making it with just about every female client he has). He noticed we were looking and he swishes over, his gold chains clanging on his wrist, "Hello, Darling!" He addresses my customer and wiggles on past to get a cup of coffee. "*I JUST HATE QUEERS*" she says under her breath. "How old is your son?" I asked, swallowing my anger and a threat from said hamburger. "*FIFTEEN,*" she answered. *Snip, Snip,* said my scissors...

Here I go again, "It's a well-known fact that a person's sexual orientation has been established by the ages of two to five," she obviously could not believe this saying. 

**NGTF Director Voeller Resigns,  
Talks to B.A.R.**

Dr. Bruce Voeller, Co-Executive Director of the most prominent Gay liberation organization in the country, has informed *Bay Area Reporter* of his resignation. He will continue as counsel to the National Gay Task Force, headquartered in New York City, but effective January 1 he will divide his personal time between writing, lecturing, and "in just living."

Eight years ago, Voeller resigned as an Associate Professor at Rockefeller University to dedicate his time to Gay activism. His salary at the university (\$18,000) dropped to zero. While involved in liberation activities in New York City, he became known nationally as a spokesperson for the movement. Later the National Gay Task Force was formed (1973). He became its Director and later Co-Executive Director with Jean O'Leary.

Voeller is divorced and has three children that he pays child support, although he worked for some time with NGTF at no salary and later at \$5,300 a year. He told B.A.R. "that was less than unemployment insurance here in New York." Recently the salary went to \$10,000 and the current \$13,000. There is a projected \$17,000 salary for the position which will begin in April 1979.

"I am really tired of being so poor," Voeller told B.A.R. He emphasized that it has been exciting and rewarding to be part of the growth of the NGTF but he needs "more space" to do a variety of things with a salary that is commensurate with his abilities. (B.A.R. learned that Voeller had turned down two positions in the movement offering \$35,000 and \$50,000 respectively.)

When asked what the "real" reason for resignation was, he replied with humor. "Read my books." The books will include at least two that will be autobiographical and analyze the Gay liberation movement. But, he explained to B.A.R., his major love is fiction because "fiction today about Gays focuses on their 'Gay problems.' I want to focus on Gays who deal with life problems and who incidentally happen to be Gay."

After a brief vacation in January, Voeller will "see what

the tide will bring in." He has signed with a lecture firm in New York City and will be traveling across the nation to speak on Gay liberation and debate three anti-Gay speakers who have signed with the same firm: State Senator John Briggs of California; Mike Thompson, who directed *Save Our Children* in Miami for Anita Bryant; and Harold Voth, a senior psychiatrist at the Topeka, Kansas, "Menninger" clinic. (The firm is Royce Carlton, 866 U.N. Plaza, NYC, 10017 (212) 355-3210.)

Voeller is especially proud of the growth of the Task Force which has grown from two or three people working for no salary (1973) to its present 13-person staff, including 5 CETA (federally funded) workers. NGTF recently moved into expanded facilities at its 80 Fifth Avenue address in New York City.

"I wish to underscore," he explained to B.A.R., "what a wonderful and extraordinary experience it has been to work with Jean O'Leary and that I wish nothing but the very best for the Task Force."

Voeller grew up in Roseburg, Oregon, and later was a Phi Beta Kappa gradu-

ate from Reed College. He earned his doctorate in Developmental and Evolutionary Biology in Rockefeller in 1961. Voeller became nationally known as the President of the NYC Gay Activist Alliance.

O'Leary and Voeller have worked together to make significant inroads in the nation's capital in influencing policy changes that have been favorable to Gay people. In March, 1977, NGTF was instrumental in setting up a well-publicized White House conference of Gay concerns with former Carter aide Midge Costanza.

"Bruce has been a source of enormous creativity to this organization," O'Leary told B.A.R. She stressed, "I am especially appreciative of his commitment to feminism. I will miss him very much as my other half in this team. I am thankful that his advice and counsel will remain with us in the coming years."

Voeller said that he and his lover would be traveling to Los Angeles for a conference in November and briefly stay in San Francisco. His future residency in New York City? — "We are thinking about moving to California." GM

**Comments**

There is a growing boycott of the Atlantic Richfield Company (Arco) and we shout **HURRAY!**

And, lastly, there is no other truly effective way in which consumers can tell a manufacturer or purveyor of goods that it is dissatisfied with that company than by boycotting its product(s).

Corporate donors to political campaigns must know that they will be held accountable for their campaign gifts.

Jews who would purchase goods from a company giving money to anti-semitic organizations ought to have their skulls examined. So too with gay men and women who pull into an Arco station to fill up a tank.

And those who criticize this boycott as they did the orange juice boycott can take a flying leap for all we care.

## BRIGGS—final draft

### Homosexual School Initiative

SCHOOL EMPLOYEES — Homosexuality — Initiative statute. Provides for filing charges against schoolteachers, teachers' aides, school administrators or counselors for advocating, soliciting, imposing, encouraging or promoting private or public sexual acts defined in sections 286(a) and 288a(a) of the Penal Code between persons of same sex in a manner likely to come to the attention of other employees or students; or publicly and indiscreetly engaging in said acts. Prohibits hiring and requires dismissal of such persons if school board determines them unfit for service after considering enumerated guidelines. In dismissal cases only, provides for two-stage hearings, written findings, judicial review. Financial impact: Unknown but potentially substantial local cost to school districts depending on number of cases which receive an administrative hearing.

Looks like Briggs just might have a few Arizonans in his hip pocket...and what are we going to do about it?




#### HOMOSEXUAL SCHOOL TEACHERS

## Reagan Raps Prop 6

Former Governor Ronald Reagan issued a statement Wednesday, September 20, finding the Briggs Initiative redundant and potentially dangerous.

In his statement Reagan explains, "I don't approve of teaching a so-called gay lifestyle in our schools, but there is already adequate legal machinery to deal with such problems, if and when they arise."

Reagan finds no similarity between the recent repeal of gay rights in Dade County Florida, St. Paul, Eugene and Wichita and the Boise measures. Instead, the for-

mer chief officer of California charged that proposition 6 "has the potential of infringing on basic rights of privacy and perhaps even constitutional rights."

The initiative, in Reagan's estimation, is "cumbersome and has the potential for real mischief... Proposition 6 is not needed to protect our children." Reagan in stressing the adequacy of existing laws pointed out that legal experts including Attorney General Evelle Younger, who has taken a neutral stand on prop 6 during his gubernatorial campaign, have found the present "legal machinery" sufficient.

In conclusion, Reagan stated proposition 6 "could be very costly to implement and it has the potential for causing undue harm to people."

## *Adult Bookstores to be Dropped*

## **Master Charge Porno Flap**

The Master Charge emblem may soon disappear from the Olympic Baths in Washington's adult entertainment area and ten adult book stores if a Maryland bank has its way in a brewing court battle.

Executives of the Maryland National Bank say it was all a mistake when its salesman last year sold Master Charge membership to Alpha-Sentura Business Services Inc., which manages the businesses.

Now the bank wants to cancel the membership, which allows customers to charge purchases, because of what the establishments sell. Five are in Washington, five in Baltimore and one in Fayetteville, N.C.

In turn, Alpha-Sentura, based in Baltimore, has filed suit in U.S. District Court there claiming the bank, the state's largest, is making "moral judgments" that harm its ability to compete and violate the constitutional guarantee of free speech.

"No strictly business reasons were offered for the planned cancellation," said David Moeslein of Alpha-Sentura. He said business has increased since the credit card membership was obtained.

The suit, asking for a minimum of \$1 million in damages, also lists as a defendant Interbank Card Association, which owns the Master Charge trademark.

Moeslein said Alpha-Sentura was still receiving Master Charge promotional material when a Maryland National executive told him the membership would be

withdrawn in November because "we don't like the nature of your business and do not wish to continue doing business with you."

Banking officials say credit card use is not uncommon among establishments dealing pornographic books and magazines and at adult-oriented establishments such as the Olympic Baths — which, according to an advertisement, provides "a man's world of pleasure . . . in a private club."

But Bill Moroney, a spokesman for the American Bankers Association, conceded "it's a subject not talked about" much in banking circles. The association had no statistical information on the subject.

"We were unaware at the time the membership was sold what the nature of their business was," said Dan Finney, chief spokesman for Maryland National.

The bank, which has asked that the suit be dismissed, contends that under the agreement either it or the merchant may cancel membership.

One Maryland National official, who declined to be identified, said the bank discovered what Alpha-Sentura was selling when the bank sought to sell the firm a second credit membership in June, this time in VISA.

"The salesman asked where the card machines could be dropped off and was told the Alpha-Sentura office would be closed. When he brought the machines to one of the stores, he found out what the stores were selling," the official said.

## **Berkeley Ordinance Tops Them All**

**BERKELEY** — The new ordinance granting equality to Gay people adopted here last week is the most extensive in the United States. It includes \$200-\$400 penalties for those who discriminate on the basis of sexual orientation.

The legislation was adopted unanimously by the city council. It forbids mistreatment of Gays in employment, education, public accommodations, and housing (except for 2-unit, owner-occupied dwellings).

Matt Coles, Gay Rights Advocates, is the attorney who authored the measure. He was assisted in its passage by Berkeley Gay activists who formed the Committee for the Berkeley Human Rights Ordinance for Gay People. The Berkeley Human Rights Commission held six months of hearings before the final draft was approved.

Jane Niehaus, who helped lobby for the ordinance, told B.A.R. that considerable effort was made to rally public support for the legislation to stave off a possible repeal effort. She said that the committee went to great care to consider the objections of commission members and council

members in order to form a united front of support.

Niehaus was joined in the effort by many concerned citizens including committee members Rock Eckel, Robert Brokl, Gayle Davis and Carol Venbrillo.

She advises others who are considering ordinances to "take the time and build support by educating the public. Berkeley is not as liberal as people think it is. It has not been easy. We have our homophobes too . . . By taking our time, we are happy that we were able to sensitize many that would not have considered the rights of Gays otherwise."

## **Briggs: "I'll Be Hero or Chump"**

California's anti-gay state senator John Briggs told an interviewer for the Escondido *Times-Advocate* that the election results on his Proposition 6 will either make him "a hero or a chump."

"I could well end up being America's newest and biggest folk hero," Briggs predicted.

"Or," he added, "I could very well end up being the world's biggest chump."

The rabidly anti-gay conservative Republican also said his friends have told him that he would be a good challenger to try and unseat Democratic U. S. Senator Alan Cranston if the voters approve the anti-gay school ~~workforce~~ initiative in November. Cranston is up for reelection in 1980.

## They Hate Anita — And Themselves

Last Sunday evening, this writer chanced to dine with Anita Bryant, who is rated in some surveys as the most respected woman in America, in others as the most detested.

Her arrival at the Kennedy Center, for the world premiere of the Chuck Colson story, *Born Again*, was couched in secrecy, as are all her movements nowadays. For, at almost every announced appearance, she becomes the target of filthy taunts from pickets, ugly demonstrations and bomb threats. Her commercial appearances, her bookings at conventions, once so numerous, have been reduced to a handful. The boycott and blackball are working.

\* \* \*

IN CHIC CIRCLES, she has become the preferred subject of contemptuous ridicule from people who would count their party made if it included a visit from that withered, one-time apologist for Stalinism, Lillian Hellman.

Yet the blacklisting of Anita Bryant for her convictions, an act of orchestrated intolerance, seems to have escaped the notice of the civil liberties crowd still keening over the horrid treatment of the Hollywood Ten.

What is puzzling, though, is why Anita Bryant is the subject of such concentrated fear and loathing.

Her most celebrated and controversial opinion — that parents and private school officials have the right not to hire or retain as teachers professed and practicing homosexuals — is an opinion shared by the great majority. It is a view upheld by the courts.

As for the social harassment or political repression of homosexuals, she has never advocated it; nor has she any authority to impose it.

If the activists in the gay rights movement genuinely believe her to be a simpleminded singer, spouting religious superstition in a progressive age, why do they trouble so with her?

\* \* \*

MISS BRYANT is abhorred, I believe, because she takes the issue beyond the realm of the civil rights of parents vs. the civil rights of teachers and over into the realm of morality, of right and wrong.

She challenges one of the pivotal dogmas of the secular humanism that has displaced Christianity as the religion of our governing elite. In this, our new national religion, it is supposedly self-evident that each individual is entitled to his or her own lifestyle; that in matters of sex and procreation, freedom of choice is paramount; that the state and the individual should be utterly indifferent to that choice.

She speaks with a moral certitude formerly heard in church pulpits which are given over today less to discussions of sin, death and resurrection than to the redistribution of income,

the evils of nuclear power and the necessity for non-intercourse with the Republic of South Africa.

Miss Bryant enrages because she insists that there is a Biblical distinction between good and evil, that homosexuality is not an "alternate lifestyle," but a sin against nature and against God, and its practitioners are, pardon the expression, going straight to hell if they do not change their ways.

\* \* \*

THE PASSIONS she arouses among militant homosexuals are the passions associated with a religious war.

What Anita Bryant threatens, then, are not the jobs, housing or constitutional or civil rights of homosexuals — but something more important. She is a threat to their sense of self-worth and self-esteem. Hers is the voice crying aloud that gay is not beautiful, but base.

To the individual truly confident in his political, moral and religious convictions, a contradictory position is a cause for rebuttal, not grounds for ranting and rioting in the street.

This leads me to suspect that "Gay Pride Week" celebrations are not really celebrations at all. They are masquerades where men and women "put on a happy face" to cover up doubts, insecurities or a sadness inside.

### individual Gays.

Gays have media attacks against us more and more. We can't fight back unless we use the boycotting of a particular media.

Gays have been murdered because they were Gay. So few killers of Gays are caught and/or convicted.

Gays have had our rights taken away in city after city. In the federal government-military. And Briggs is now trying to take the right to work away from some Gays.

Anita Bryant wants to open up "camps" for Gays . . . are they to be "camps" like Hitler had for people he did not want?

When does the entire Gay community stand up and say, "Enough! No more!" Do we wait like the Gays and Jews of Europe did — until it is too late?

The question is: "When? When do we say 'enough' and start to do something about it?" Do we wait until the concentra-

## Milk Reveals Briggs' Arguments

Supervisor Harvey Milk has taped a discussion with Senator John Briggs which will be viewed on KPIX-TV at 8:00pm on September 22. The segment, Milk told B.A.R., revealed four basic arguments that Briggs will be using in the campaign:

1. Gay teachers are bad role models because if students like a Gay teacher and learn that he/she is Gay then they might emulate or copy the homosexual lifestyle. (This was a major argument used by Save Our Children during Anita Bryant's Miami campaign.)

2. Homosexuals attempt to recruit children into their Gay lifestyle. (The argument by Bryant was that they must do this because — it was asserted — they cannot have children of their own.)

3. Parents have the right to determine who shall teach their children. Briggs argues that parents' rights are greater than the civil rights of Gay school employees; that closeted Gays may be good teachers but they should remain closeted.

4. Homosexuality is immoral. Briggs was converted to Roman Catholicism after marrying a Catholic. He speaks frequently of "protecting the family" and the alleged immorality of those who are Gay-based-on-biblical teachings. The senator does not quote scripture. His religious comments are general in nature.

happens when a particular point is reached and a lot of Gays have had that point as their individual point is a question that also has to be asked.

I do not have an answer for this. No one has. No one can have an answer. But, the "leaders" of this nation had better start to address that question — now, not after that point is reached.

And what does it mean when we reach that point? Again, there is no one answer. To some it may mean just "coming out" — and to whom. To others it may mean getting deeply involved. # Treadaway cleared in '74 death of boy

Jonathan C. Treadaway Jr. was acquitted by a Maricopa County Superior Court jury Monday of the murder and sodomy charges that put him on death row at the Arizona State Prison more than three years ago.

The verdict came after the 12-member jury spent four days reviewing testimony and evidence presented during a six-week trial.

Treadaway, 24, who showed no emotion when the verdicts were read before a full courtroom, told the jurors later that their decision restored his faith in the judicial system.

"You people have showed me that it can work," said the once-convicted Phoenix man.

He said his first trial in 1975, when he was convicted of both charge in the 1974 death of Brett Jordan, 6, and sentenced to death, had destroyed his belief in the jury system.

Members of the jury, who met with the attorneys after the court proceedings, said they voted to free Treadaway because the prosecutors failed to present enough evidence to convince them that the defendant ever was inside the Jordan home.

The Jordan boy was found dead in his bed by his mother, Rita Jordan, now of Flagstaff, and an autopsy report maintained that he died of suffocation and was a sodomy victim.

"I guess the evidence we presented was just not convincing enough," said Assistant State Attorney General John Todd, who co-prosecuted the case.

At an evening press conference called by Treadaway's father at the family residence, 3140 N. 83rd Ave., Treadaway was asked about the evidence the state had marshaled against him.

"If you didn't do anything, then of

course there'll be no evidence, so certainly there was a lack of evidence on the part of the state," he said.

Treadaway said he did not show any emotion when the verdict was read because he was completely numb. He said the impact of what had happened had not reached him.

Asked about his plans, Treadaway said he intends to attend college and become a journalist.

Defense counsel John J. Flynn, who took over the case after the first conviction, based nearly his entire defense of Treadaway on a claim that the Jordan boy died of pneumonia or bronchitis.

Five out-of-state pathologists, including two who specialize in pediatrics, testified that the youngster suffered from a lung ailment that probably killed him.

"He died a quiet death, probably in his sleep," maintained one of them, Dr. Daniel Stowens, a Utica, N.Y., pediatric pathologist.

The pathologists also said they could find no evidence that the boy was a sodomy victim.

The five said they based their findings on examinations of tissue slides and photographs of the body.

Their testimony was disputed by the two county medical examiners who performed the autopsy the day the Jordan boy was found dead in his bed.

Drs. Thomas Jarvis and Heinz Karntschig said their examination of the body revealed that the boy died from asphyxiation and that he had been assaulted sexually.

The two testified, however, that they did not conduct microscopic examinations of body tissues before reaching their conclusions.

Jarvis said they did view the tissues

## The Treadaway Trial — The Mockery Is Reversed

Anyone in the slightest way interested in Human Rights or the Judicial system in Arizona, not to mention those of us interested in Gay Rights, should have been pleasantly surprised at Judge Robert J. Corcoran's praise for the jury, not to mention the jury's verdict in this case.

Many people had watched for the past few years, and waited to see the outcome of this second trial, considering the first trial a mockery. Justice such as this is long overdue in local courts.

late last year and could find no evidence that would cause him to alter his opinion.

Assistant State Attorney General Stanley Patchell, who also handled the first prosecution, attempted to convince the jury that Treadaway was involved in a similar attack on a boy three months before the Jordan boy died.

Although Treadaway was not charged with the offense, mention of it at the trial was designed to show that the defendant had a propensity for sexual aberration.

The earlier assault involved a 9-year-old boy who was attacked in his bedroom by an intruder who entered through a window. The assailant was chased off by the boy's mother, who awoke when she heard her son struggling.

Patchell tried to link Treadaway to that attack through clothing and a necklace left at the scene by the intruder when he was chased by the boy's mother.

Flynn countered that effort by attempting to show that the early-morning attacker actually was the neighborhood paperboy. He also offered testimony that showed the clothing left at the scene did not fit Treadaway and the necklace may have belonged to a neighbor girl who lost it.

Evidence presented to the jury by Patchell to tie Treadaway to the Jordan death included a palm print found on the outside of the boy's bedroom window and hair samples found on the boy's body, which the state claimed belonged to Treadaway.

Mrs. Jordan, who sat in the courtroom with her husband when the verdict was read, said she was disappointed in the decision.

"It would be easier for me if I could believe my son died of pneumonia. John Flynn did not convince me my son died of natural causes," she said.

The mother said if she could believe the pathologists, she would get down on her knees and beg for mercy for Treadaway.

Flynn called the trial one of his best and maintained that the verdict was correct and just.

Judge Robert J. Corcoran, who presided at the trial, praised jurors and the attorneys, saying that they all performed their duties properly.
