MARION BARRY TO KEYNOTE N.A.B.C. SECOND CONVENTION

Marion Barry, Mayor of Washington, D.C. will be the Keynote speaker at the Plenary Luncheon of the Second Annual Convention of the National Association of Business Councils (N.A.B.C.). The luncheon which will be held at The Capitol Holiday Inn at 550 C St. SW in the nations capitol, will begin at 1 p.m. on Saturday, November 13, 1982.

Larry Bush, the Washington D.C. editor of *The ADVOCATE*, a bi-weekly news magazine serving the United States, has characterized Barry as "... having probably done as much to advance the acceptability of gay civil rights as any leader in the country. And gay visibility in Washington, D.C., creates a ripple effect for reporters in the nation's capital — a sort of de-San Franciscoing of the gay movement."

In addition to the keynote address by Mayor Barry, the Board of Directors of N.A.B.C. has chosen to award the National Organization of Women (N.O.W.) and *NEWSWEEK* Magazine certificates of commendation for their work in the area of gay/lesbian professional development. Eleanore Smeal, President of N.O.W. and Mel Elfin, Washington Bureau Chief of *NEWSWEEK* Magazine will receive the awards.

N.A.B.C. President Arthur Lazere stated, "we give these commendations because we believe in recognizing those who have effectively worked to present us as we are, professional people."

Delegates and observers at the combined Conventions/Board of Directors Meeting will come from over 22 major cities in the United States.

Beginning with a City Hall Cocktail Party at 6:30 p.m. on Friday, November 12, all delegates and conventioners will become totally involved with life in Washington D.C.

While the Board of Directors of N.A.B.C. will meet to do the business of the organization on Saturday morning, November 13, others will have the opportunity to attend two workshops. Bernard Layne, District Director of the U.S. Small Business Administration (S.B.A.) will direct a seminar entitled: "How to use the Small Business Administration and its resources successfully." A second seminar, "Gay Health Issues" will focus on concerns of the gay community. Dr's. Ceasar A. Caceres, Phillip S. Schein and Lawrence T. Hill will serve on this panel of experts.

Immediately following the Plenary Luncheon, N.A.B.C. Vice President Werner P. Kuhn will facilitate a workshop entitled: "Gay People and the Economy: A Post-Election Analysis." William J. Olwell, International Vice President of the United Food & Commercial Workers International Union, and Alan Baron, Editor of *The Baron's Report* will serve on this high level program.

One additional workshop, enpaneled by four presidents of N.A.B.C. member associations, will be named: "How to Build and Maintain a Successful Business and Professional Organization within the gay community."

An informal brunch will be the center of the program for conventioners on Sunday, November 14. A briefing by major gay/lesbian spokespersons will include Larry Bush, Mel Boozer, Tanyan Corman and Tom Chorlton. Delegates will be prepared to meet with Members of Congress and the Senate on Monday, November 15.

MOVE TO BAN PAEDOPHILE ORGANIZATIONS

LONDON — A Conservative Member of Parliament has announced that he will attempt to have the Paedophile Information Exchange (PIE) banned by law. Geoffrey Dickinson, the MP for Huddersfield West, says that when the House of Commons reconvenes on October 18, he will introduce a bill that would outlaw PIE and similar organizations and make incitement to sexual relations with children under 16 a criminal offense.

The legal move follows sensational articles about PIE in two British newspapers. The *Daily Star* ran a story on Charles Oxley, the principal of a Bible College and a close friend of anti-pornography campaigner Mary Whitehouse. The story said that Oxley had infiltrated PIE to the extent that he was invited to join the PIE executive. Oxley claimed that a PIE publication contained the assertion: "If a child has not had a sexual experience by the age of four then it is too late." A PIE spokesperson described this as "sheer invention."

The *News of the World* also published a story, saying that an employee of a firm of contractors working on Home Office property was a member of PIE. The Home Office then told the firm that the employee was not acceptable to do government work.

As a result of the newspaper stories, PIE members have been harassed by the right-wing National Front. (IGNA)

BODY FOUND IN HOME OF EX-CONGRESSMAN

NEW YORK (IGNA) — The body of a house guest who apparently committed suicide has been found in the Manhattan apartment of former U.S. Representative Fred Richmond.

Police said that the man had scrawled a cryptic love message across his chest in blue ink, before taking what appeared to be an overdose of prescription drugs.

The dead man was identified as Gregory Bergeron, 21, of New York. His message was: "I will always love U X O X O X sin angel." The words had been written backwards as if he wrote them while standing in front of a mirror, said Deputy Chief Rudolph Ponzini.

The "x" and "o" letters in the message may have been symbols for hugs and kisses. Ponzini said he did not know if "sin angel" meant "signed angel."

Ponzini refused to disclose the contents of a second note written by Bergeron that also was found in the former congressman's Sutton Place apartment.

Richmond, a self-made millionaire and four-term Brooklyn Democrat, pleaded guilty on August 25 to federal tax evasion and drug charges and resigned from Congress.

In 1978 Richmond was harassed for soliciting sex from a teenage boy.

Bergeron had been a house guest at the ex-congressman's apartment off and on for about a year.

Richmond has not as yet made a statement to the police or the press.

The body was discovered by Richmond's chauffeur in a bathroom in the seventh-floor apartment on Manhattan's East Side.

Richmond, 58, represented one of the poorest congressional districts in the state.

He will be sentenced on tax evasion and drug charges on November 12. He faces up to seven years in jail.

SEXUAL DEVIATION PANEL TO BE PICKETED

LOS ANGELES — A group of protestors, headed by Morris Kight, plans to demonstrate at a two-day panel on "Sexual Deviation: Contemporary Psychoanalytic Views," because the panel has not included a woman and a gay psychiatrist as members.

The demonstration also plans to call attention to the homophobic attitudes and writings of two of the chief panelists: Dr. Irving Bieber and Dr. Charles Socarides.

One panelist, Judd Marmor, has been noted for less homophobic attention to the subject of homosexuality.

In response to early criticisms, the organizers of the event have added a second panel (on Sunday, October 10) in the Grand Ballroom of the Beverly Hilton Hotel. "Further Reflections on Sexual Preferences" will have Martha Kirkpatrick, M.D., who has

studied child rearing among lesbians, and David Kessler, M.D., immediate past president of the Caucus of Gay, Lesbian, and Bi-sexual Members of the American Psychiatric Association.

In its announcement, the Southern California Psychoanalytic Society acknowledged the controversy, but maintained the right to treat patients for sexual deviation. "We see no substantial difference in psychoanalytic treatment with patients who complain about the sexual sphere from those who come with other problems."

The panel can be taken for credit toward degrees for psychologists, clinical social workers, and for certificates for doctors and psychiatrists continuing their education.

Those protesting the panel are angered by the title "Sexual Deviation," because it is a judgmental one. They also object to an atmosphere of "science" which in some cases masks religious biases, cultural prejudices, and punitive attitudes, instead of providing actual mental health assistance to people, gay people in particular.

The organizers of the panel say that "Every effort will be made to provide sufficient time to air all views, to discuss in depth all disagreements, and to allow maximum audience participation." (IGNA)

FUNDS SOUGHT FOR GAY HEALTH NEEDS

SAN FRANCISCO — Supervisors Nancy Walker and Harry Britt have requested the San Francisco Board of Supervisors to appropriate some \$374,000 to fund various gay health projects, including services to victims of Kaposi's Sarcoma and AIDS.

Walker and Britt have requested the funding in response to the recent increase in the occurrence of serious diseases occurring among gay people.

Noting that the Federal government has allocated some \$2.5 million for research into the causes and treatment of KS and AIDS, Supervisor Britt said that "We are seeing alarming increases in the occurrence of these horrible diseases. One hundred San Franciscans are diagnosed as having them right now. But money to make certain these victims are getting medical care and to assure gay people get reliable information and referrals when they need them hasn't been made available."

Britt also accused the city of San Francisco of historically underfunding "the health needs of gay people. What we're doing here today is calling attention to that fact and saying that gay people have to receive more, as fast as possible."

Supervisor Walker said the funding proposal "represents several projects that gay and lesbian health professionals have identified as the greatest health needs of the community, particularly KS, diagnosis of intestinal parasitic diseases, and mental health and outreach services for gay seniors."

The proposal specifically requests funds for the following:

*San Francisco General Hospital's AIDS clinic for medical treatment; the Shanti Project for counseling of patients, their friends and families; the KS Foundation.

*The San Francisco Department of Public Health's amoebiasis diagnosis program.

*Operation Concern's program of outreach and counseling for gay seniors and training to agencies in serving gay senior clients.

For funding to occur, Mayor Dianne Feinstein must send an appropriation request to the Board of Supervisors.

Supervisor Britt said, "I am hopeful we'll see the money come through, and will do everything I can to see that it does." (IGNA)

GAY SOLDIER WINS RIGHT TO RE-ENLIST

SEATTLE (IGNA) — A federal judge has ruled that a 34-year-old career soldier cannot be barred from re-enlistment simply because he is an avowed homosexual.

Sergeant Perry Watkins, a 14-year Army veteran, was told by the Army in 1979 that he could not re-enlist when his current tour expires this month. But U.S. District Judge Barbara Rothstein ruled recently that he is eligible to re-enlist for six more years.

The Army contended that military service is a privilege, not a right, and that homosexuality is a sufficient reason for disqualifying someone.

Judge Rothstein called "patently absurd" the Army's contention that enlistment personnel were unaware of Watkins' homosexuality.

Last May Rothstein ruled that the Army cannot discharge Watkins simply because he publicly talked about his homosexuality.



Contacted by AP at his home Watkins said he was relieved at the latest ruling. But he indicated that he didn't think his fight with the military was over. "There's no telling what they could come up with tomorrow," he said.

Watkins, a Tacoma native, is a personnel supervisor at Fort Lewis near Tacoma.

Watkin's lawyer, Jim Lobsenz, argued in court that the Army never proved that his client's homosexuality harmed his job performance.

Judge Rothstein disagreed with the Army's contention that Watkins knew all along that he risked losing his Army career because of his homosexuality. She said, "Plaintiff declared his homosexuality to the Army from the very beginning, and even if he was not believed at first, (any) doubt that he was in fact homosexual was resolved in 1968 when plaintiff admitted to engaging in relations with other servicemen."

TRANSSEXUAL BIAS CASE

SACRAMENTO (IGNA) — The California Department of Fair Employment and Housing is struggling with the agency's first job discrimination complaint based on transsexuality.

The complaint was filed by Katherine R. Rosen, 35, a resident of Sacramento undergoing treatment to become a woman.

Rosen charges that she was turned down as a security guard for the Rancho Seco nuclear power plant because she is a transsexual.

Bill Rutland, assistant to the director of the agency, said on October 7 that its attorneys are making a decision on the case.

Rosen said that she applied for a job in July with the Vanguard Security Systems of North Highlands, which contracts for the security force at the nuclear power plant.

"I wanted them to know about my Air Force and law enforcement background," Rosen said, noting that she once worked for the sheriff's department of Jackson County, Missouri.

"I knew they'd discover that I'd been discharged honorably from the service due to my transsexuality. I asked the person who interviewed me whether my transsexuality would cause problems in being hired as a security guard. He said absolutely not."

But she was rejected for the job on August 18 and was told all positions had been filled. On August 23, she said, she saw another advertisement for the same job and decided to file her complaint.

One of the questions the state of California must resolve is whether transsexuals are included under a state law that prohibits discrimination based on sex.

Mat Burke, vice president of Vanguard Security Systems, said: "All we can say on this case is that we received hundreds of applications for those positions. I'm not in a position to comment further on one application out of hundreds."

HOT DUDS BURGLARIZED

Sometime the evening of October 16 or the early morning of October 17, burglars forceably entered Hot Dud's men's clothing store located at 842 E. Indian School Rd., Phoenix, and stole a large amount of inventory, personal items and records. While no exact amount is known, the burglary is estimated to have resulted in a loss of 'several thousand dollars'.

According to co-owner, David McCaskill, along with merchandise the perpetrator/s also stole business and personal records of no value to anyone other than he and his partner. Included were photo layouts for advertising, receipts, photos and articles about the business and other related material. The merchandise taken involved all types of clothing and accessories.

JOGGING AND SEX

SAN DIEGO — Are runners more sexual than non-runners?

Apparently yes.

Jim White, the Director of human performance activities at the University of California, San Diego, designed a program to test 115 middle-aged men during a nine month program of exercise.

At the start of the study, the subjects completed a 56-question survey and a 28-day "sex diary," chronicling everything of an erotic nature that happened in their lives. Then they were physically evaluated, counseled, and enrolled in a serious exercise program.



Five days a week they were to do 5 to 10 minutes of stretching, warm-up exercises, aerobic activity, cooling down exercises and stretches.

A control group of seventeen subjects received the same evaluations and counseling but instead of running or jumping, they walked the same amount of time.

According to the results, the myths are true. The runners and jumpers reported more sexual desire, arousal, and orgasms than did the walkers, and they did so in statistically significant numbers.

The frequency of kissing and caressing also went up (from 4.3 times a week to 5.0). Sexual intercourse occurred more often (up to 3.1 times a week from 2.29).

Respondents also reported more extramarital sex (though with which sex, the report did not say). The average extramarital episode occurred every 3½ to 4 weeks instead of the usual every 5 weeks.

White said, "If we publish this data, there won't be a married woman in the world that will allow the husband to get out and do any jogging."

But he added that increased physical activity did not turn men into adulterers, only increased the frequency of those who already indulged in such activity.

The changes in increased sexuality have been attributed to improved physical appearance, hormonal changes, or improved self-esteem, White said. (IGNA)

NEW ORGANIZATION FOR GAY ADVENTISTS FORMED

A new organization has been incorporated to provide religious and social services to lesbians, gays, bisexuals, and transsexuals of Seventh-day Adventist backgrounds. Orion Fellowship Alliance is a nonprofit corporation organized to meet the needs of the international community of Adventist sexual minorities. Orion ministers to the whole being: the spiritual, social, physical, mental, and emotional needs.

The San Francisco based organization is dedicated to providing positive, significant insights about human sexual orientation to aid in decreasing confusion about sexual minorities. In addition, Orion provides alternate social activities for its members and the community. The group believes that its major responsibility is to provide support and services to individuals within the sexual minority communities.

On a smaller scale, Orion is working for the development of a sexual theology within the Seventh-day Adventist church. The board of directors feels this mission of education, advocacy, and reconciliation can best be accomplished through grass-roots approaches. Such approaches include the use of speakers bureaus, publications, and educational materials.

Orion Fellowship Alliance is not the only gay Adventist organization in existence. But Orion spokespersons are quick to note that the other organization is basically a political lobbying group attempting to bring about change within the conservative denomination. Further, board members of Orion are all openly gay persons, while the board of the other organization is composed of a large proportion of closeted people who use pseudonyms. Orion believes it is vital for its

leadership to be visible and identifiable in order to promote positive self-images and affirmation within its membership.

Orion publishes a monthly journal, LIFELINE. This publication is sent to all members. Subscriptions are also available for non-members. KONTACT, Published quarterly for Orion, is a correspondence service and literary magazine for members who have registered for the service. KONTACT aids members in forming networks of support and friendship by putting members with similar interests in touch with each other.



TRAVEL NEWS UPDATE

THE U.S. PASSPORT office will increase passport fees from \$10.00 to \$35.00 for travelers over 18 years old and to \$20.00 for those under 18 years old when it implements a new law boosting the validity of most U.S. passports from five to ten years.

BIVOUAC BONUS BOOKLET for frequent travelers — Beginning in early October, Western Airlines will offer the Bivouac Bonus Booklet to LOS ANGELES — PHOENIX and LOS ANGELES — SACRAMENTO passengers. For one low price, \$799.00, clients on these routes will get a booklet of twenty one-way tickets, plus something extra. Included is a bonus coupon redeemable for a free roundtrip, coach class ticket to HAWAII or any Western Airlines destination in the U.S. The coupons ARE transferable and can be given as gifts.

THE IMPERIAL PALACE hotel in LAS VEGAS will hold its First Annual Automobile Run for antique car buffs from November 18 to 21. Entries are open to owners of 1936 or older cars. On November 20, the cars will begin a 58-mile course that begins at the Imperial Palace, continues through Red Rock Canyon with a stop for lunch at Bonnie Springs/Old Nevada, and returns through Blue Diamond and across the Old Las Vegas Highway to the finish at the hotel. Specially priced packages are being offered for this special event.

GETTING BUMPED FROM a domestic flight will make you late, but it might be worth the hassle. When you have a reservation and are bumped, the air carrier must pay you twice the face value of your one-way ticket (up to \$400.00) if it cannot get you to your destination within two hours of your scheduled arrival. However, on international flights, the airline can take four hours to get you there before paying twice the face value. And just for the record, the bumped passenger is the one entitled to be compensated for the inconvenience. So even if you are on a business trip, no report of the reimbursement will be sent to the boss.

All bars are forced under law to be quite strict about proper age identification. The law states you must have a valid Arizona driver's license, a military I.D. card, or an Arizona age 19 drink card which may be purchased through the Motor Vehicle Department. Please carry proper I.D. at all times.

The A.G.B.A. appreciates your support and cooperation on all these matters. We'll have a better gay community for all if we work together. 



Trotter Brothers is a multi-media entertainment production company which moved to Phoenix this past year from Wichita, Kansas. It's the same Kansas, but Dorothy never dressed this good. Their service listing contains Television Commercial and Motion Picture production, Convention and Industrial Show production and presentation, Point-of-Sale Promotions and that other category, Entertainment Packages, that 'let's stick it there' area which only includes Staged Live Musicals, Magic Shows, Puppet Spectaculars and live Trained Parrot Bird Shows, like it was just some more things for your shopping list.


Trotter Brothers Productions, Inc.

David Trotter Puppets was the foundation for the company, formed in 1940. Joining David in 1949 was Bob Munson and the two hit the road for fifteen years, working their puppets and building an international reknown. They toured with Judy Garland, Edith Piaf and many other celebrities throughout the world. As the times and economy changed so did their act and ultimately their whole career when one day they figured that their stage and puppet experience might very well be the basis for starting a production company. They felt they could provide all the components, of which they were one at that time, to theatres and amusement and theme parks with which whole shows could be formed. Hence *Trotter Brothers Productions, Inc.* . . . And that's it in a very small nutshell.

These people are into so much that probably the best way to explain them and their businesses is to take a tour of their new offices and production studio and retail costume store. As if everything else wasn't interesting enough, the building itself has it's own story. Built at the turn of the century as the first home of what became one of the largest grocery chains, it later served as both a skating rink and an auto garage. At the time it was built it was the largest free standing (non-interior supported) building in Phoenix. This will be the home for the whole enterprise and already houses the costume rental and manufacturing facility which opened October 23. The renovation will make it a fine addition to the rebuilding of downtown Phoenix.

The costume facility isn't your run-of-the-mill costume shop. The majority of costumes are manufactured on premises, all the way from sewing the fabrics to actually molding the latex faces and applying the permanent make-up. Going past the new store's showcase windows is like going on an amusement ride. To go inside is like shopping at Disneyland. These aren't masks held on with elastic strings. The most professionally made faces yet locally available are totally complemented with costumes to match, and all are available for rent or purchase. Got a last minute need? They can make your costume in as short as four hours notice. 'Marco Mars' the official mascot of Trotter Brothers is on hand a good deal of the time to greet customers. Maureen Halterman, Shop Manager, is also host of an astrological program on a local Phoenix radio station, but then that's typical of the type of person at Trotter's. Everyone is multi-talented. In the shop there's also Clown Alley, a complete collection of professional make-up and accessories, and a magician's section, including lessons on how to perform the tricks, which is planned to be second-to-none. The entire retail presentation is geared toward being a total concept. Costume, make-up, accessories and tricks are all part of the customer's unit purchase.

Magic also takes place behind the scenes in the costume production department through the experienced and talented hands of Nancy Romero and Betty Lee, Seamstresses. While they're stitching up the designs of Barry Conyers, Design Producer, for the big contracts with two hands, the other two are refitting and fixing the one's which have been returned from the theme parks and with the other two they're making new costumes for the costume studio and for customer's special requests.



Animatronics - Computer Puppets / Fifty-Five Live, Trained Tropical Birds

So a little something you throw on yourself to achieve that 'something special' you're trying to project for your party is not enough? Want it mechanical? They can do that too and have your character programmed for movement, run by a cassette. These are the same ones you see in the amusement parks that move around, talk, wink, nod, the whole ball of wax. This is where they have them made. Also by Barry Conyers, these designs appear to be large self-standing puppets. Animatronics, based on the importance being given them by Trotter Brothers appear to be a great deal of the overall direction the amusement industry is taking.

Animatronics not real enough for you? Then try Steve Hinrich's live birds. Steve, Animal Trainer and Production Assistant, has been with Trotter's four years, and like Conyers, loves his work. (Both related the great amount of creativity they are freely allowed to exhibit). And no wonder as few people in the country have a collection of birds to equal this, if any. There are forty-two macaws, assorted by color, six cockatoos (the full crested all-white ones) and seven Amazon parrots. Just to see them in one full collection is overwhelming. The riot of color from solid reds to one bird that's rainbow colored to another that's royal blue is more than one can see in a zoo. And unlike zoo birds, these have talent. They dance, talk, play dead, get shot out of cannons, walk the tightrope, sing "Hello Dolly", do addition and subtraction, and can identify colors; and, as if that's not enough. Steve is now designing an act wherein the

Heroines (birds) trapped in a burning hotel will be saved by the Heroes (birds) manning the firetruck - "This act has everything." "It's really a lot of fun and the birds are picking it up very quickly." "It should be ready in about six months." The birds are valued from \$2,000 to \$10,000 each, based on their level of training and ability to learn. Slower ones are sold and traded to assure a continual upgrading of the overall collection. Steve, in whom Trotter and Munson place a great deal of responsibility and trust, obviously, has also worked up an act for Trotter Brothers called "Birds of Prey" which featured an American bald eagle, falcons and hawks. That production is not currently being continued as "It's really difficult trying to find a bald eagle." However they've done it before. The birds will be on display at the new center, back currently from a six months gig at a theme park in Massachusetts and on R&R for a few weeks. Then it's back to the old grind of getting shot out of a cannon six times a day.

Theme Parks and Travelling Shows

Theme parks contract with Trotter Brothers on both a short and long term basis for costuming, puppets, animatronics, magic acts and the birds. Trotter and Munson travel continuously keeping up with their commitments. Conyers, Chandler and Hinrich follow out to set the acts, construct sets and perform general followup. As explained on one day of this interview, "Dave had to fly to Connecticut for the day." Munson said at another point, "Maybe we ought to fly over and check what that store's got." (San Diego), and just as he had thought of it on the spot, it's a pretty good bet that if someone would have nodded they might have been on their way to the airport a little faster than they might have anticipated. As with any business, if it goes with the territory then it has to be done. For some that's work only but for this crews it's enjoyment at work. A few

of those amusement and theme parks they travel to and have contracted are: Maple Leaf Village, Niagara Falls; 'several' Six Flags; Old Vegas; Springlake Park, Oklahoma City; The great Escape, Lake George, N.Y.; Wild World, Washington, D.C.; and Adventure Land, Des Moines. What do they do there? Everything. They build sets, costume entire staffs, produce shows from puppet extravaganzas to full stage productions, and on one occasion did a total conversion, including construction, of a 1930's fun house into Frankenstein's Castle, employing all their most technical new creations. Acknowledgement within their industry is obvious when one reads "Riverside Park (Mass.) Sets Trotters To Produce And Manage Shows", a long article headlined last year in *Amusement Business*, the industry's trade publication. It read: "... Riverside has signed a three-year contract with Trotter Brothers, Wichita, Kan., to produce and manage four shows yearly and has designated the firm to head up a new department called "Concept Design," dealing with new design and execution of it in the park." "We will be working closely with each department head, games, food and marketing," said Bob Munson. "... Trotter Brothers will design a harbor area for the park's new ... electric boats ... and a replica of the park's speedway for the park's new electric cars." "This year's show plans ... include converting (a theatre) into a completely new showplace called Theatre Royale, seating 400."

Puppeteering is their forte and how they got into all this in the first place. And it's obvious it remains their prime interest as even with all else going on, they constantly refer to something about puppets or what they did or what they can do with them. They create a love affair through their puppets with their home bases as well as their audiences. *The Wichita Eagle & Beacon* headlined a section of that paper with "Trotter Brothers Return Home." There was no relaying in that caption of who they were or what they did, just that they were home. Obviously the readers knew who they were. That article related how they returned from nine weeks in Israel with "Bubbles, a 26 year old stripper who sometimes moonlights as a nun, a 10 year old newspaperboy who has a fondness for large lollipops, and a 'Jewish' Santa." These, of course are three of the over fifty children (puppet characters) the duo has 'adopted' during their many years of work. Bubbles, by the way, dresses as a go-go dancer for the children's audiences, however she remains anatomically complete for adult audiences.

A New Home and New Ideas

Now home is Phoenix, Arizona. And do you think that all this producing, building, performing, training, thinking, creating, designing, travelling, etc. is enough? Well, noooo, not actually. There's much more! According to Munson, Phoenix is where they're going to pull it all together, including new plans and divisions for the business. They haven't even fully moved into the new building yet they're obviously close to running out of departmental space. The business seems to create its own growth naturally. One need fulfilled leads to another to be worked on. From puppeteering they went into costuming, then into the latex facials, then into programming the puppets, and that's only one facet of the business. It all seems to have developed along the lines of controlling the whole supply requirement and being open to adding and changing to accommodate the clients needs.

Parrott Pizza Place*, under the guidance of Debby Schiler, Designer. The company was a natural for the developers to look to as they were making a bid for the juvenile market. "Enjoy the zany antics of Paul and his forest of animated computerized puppets. Hours of good family entertainment are guaranteed - as you watch the amusing escapades of these lovable characters unfold into a live storybook performance!", reads their ad. Trotters are watching the restaurant closely with their eye to the possible addition of a whole new concept.

Also in the works is their own new theatre-restaurant in Phoenix called *Widdow Brown's* where the waiters are all the Widdow's former lovers. All the employees will perform and Widdow Brown herself, the 1940's wispy type of widdow, will circulate amongst patrons serving after dinner libations and imparting her anecdotes on a very full life. 

SALVATION ARMY REFUSES \$1,400.00 GAY DOLLARS Gay Switchboard, a Gay Electronic Network

The Chicago Knights, a gay motorcycle/leather club, hosts an annual 'Toys for Tots' fundraiser which historically nets several thousands of dollars, with proceeds going to charities helping unfortunate children. Recently \$1,400.00 was sent to the Chicago chapter of the Salvation Army, along with a request for information on their youth programs, and specifying that the money was to be used for that purpose. When it became apparent that the check had not been cashed after several months, an inquiry was made. Conflicting responses came including one which said they felt they could not accept the donation (presumably due to the source of the money). Another response was that there had been a mis-interpretation of the request for information on the youth program.

After some notariety by columnists such as Mike Royko and several of the local media, the Commander issued several public statements. However, it was not until a week later that an apology was made. Since the charter of the Chicago Knights requires that all funds be disbursed before the new program can begin, the proceeds wre distributed among three to four other charities. One person commented "It seems to me that you would have to stand on a cold street corner shaking a bell for a hell of a long time to collect \$1,400.00 Good luck, Salvation Army . . . you may do a lot of good, but I will feel no guilt in channeling my donations where they will be appreciated."

WHO IS RUSS RAGSDALE?

I first met Russ Ragsdale almost five years ago, when I was a bartender at the Talk of the Town. A quiet, unobtrusive man, you could often find him at Maggie's or the Casa, sitting at the bar. We were both new to the Phoenix Gay Community, drawn to the bars for different reasons, yet both finding new friends quickly. We liked each other instantly.

Sometimes he had a beautiful woman with him; it was soon established that she was his wife, Vicky. They were not looking for lonely gays to exploit; they were not there to judge. They originally wandered into Maggie's and the Talk because they lived nearby. They returned often because of the warm reception they received from the people that they met. The care and trust that they shared with each other soon spread to touch many people. They were a straight couple who were accepted and loved by many who lived in a different kind of world. Some of you may still be wondering who Russ Ragsdale is I'm sure. Take my word for it: when you see him you will recognize him and when you meet him you will like him.
