

LESBIANS WIN CUSTODY IN AZ

Arizona has finally joined the ranks of other states who have allowed lesbians to retain custody of their children over the objections of relatives.

During Feb, 1980, an interracial lesbian couple regained custody of the white woman's two daughters (ages 3 & 5) thru a precedentsetting juvenile court trial.

The lesbian couple, both around 30, met while in Florence on drugrelated charges. They knew each other for about two years before trying to get custody of the girls in July, 1979. Since leaving prison both women have not violated any terms of their probation and are employed full time. The children had been living with foster parents for two years while the mother had been in prison.

Judge Rapp, the court appointed judge, excused himself from hearing the case due to his prejudices against lesbians. Judge Rose, the second judge, agreed to hear the trial and appointed Attorney Vince Libbon to represent the two women in their quest for custody. The grandmother and the foster parents were the main complaintants in the trial.

Altho most juvenile court cases last less than one hour, this one took nearly eight hours. Rose required the state to present an expert witness to testify on homosexual lifestyles. A Phoenix psychologist who works with gays in the valley and who wishes to remain anonymous testified for almost $2\frac{1}{2}$ hours. He was questioned on five main topics: 1. Would the children go gay? 2. Would the parents abuse the children? 3. What kinds of pressures would the young girls encounter from their peers? 4. Are lesbians poor child raisers? 5. What is the stability of a lesbian couple?

The psychologist stated that lesbian couples had as good or better stability record that heterosexual couples. Much of the sta-tistics he used came from the National Gay Task Force Custody files. The Child/Youth and Family Administration of the Dept of Economic Security and the Attorney General's office stated that they encouraged the court to allow the women to obtain custody. The drug rehab counselor who the women had been seeing in Phoenix and the psychologist at Florence also testified on behalf of the lesbians.

In August, 1980, a final hearing will be held to review the progress of the family. At that time custody will be made permanent and the names of the involved people can be released.

This was the first case in Arizona where lesbianism was an issue and the GAYS won.

U.S. CENSUS

Mark April Fool's Day on your calendar. That's the day you will receive an official census form. It is extremely important that you fill out the form and mail it back. If you do not get your form by April 2, please call 261-6812.

The census information will determine amounts of Federal and State funds to be allocated to Arizona and Phoenix, assures us of due representation in Congress, facilitates planning for job training, education and police protection. Census information is kept strictly confidential. The city of Phoenix guarantees no personal census information will be used by city government in the enforcement of local ordinances. Census information will not be used in an improper or harmful manner or for enforcement of any national, state or local law.

Every 10 years since 1790, Americans have dealt with the census. In 1975, more than 100,000 Phoenix residents were not counted. Don't be a fool on April 1 - - fill out the form and mail it back.

NEW 9-DIGIT ZIP CODE

The US Postal Service has set Feb. '81 as the target date for implementing its 9-digit zip code scheme. The 9digit zip code, announced in Sept. '78 after a two year study, consists of existing 5-digit codes plus four more digits to designate individual street blocks, buildings and businesses within established postal zones.

The Postal Service hopes the new codes will speed automated mail sorting and estimates that with such use, 7 employees will be able to do sorting work now requiring 20 persons.

Because the 9-digit codes are not mandatory, the Postal Service does not expect rapid, across-the-board compliance, though they hope to have 80% compliance by 1985. Presently, 97% of all mail posted carries a 5-digit zip code.

RCA HONORS WOMAN

Yvonne C. Brill of RCA Astro-Electronics has been named "Engineer of the Year" by the Central Jer-

sey Engineering Council. The award cites accomplishments in jet and rocket propulsion, her involvement in several professional societies and her contributions to the local community.

A propulsion engineer with more than 25 years experience, Ms. Brill is Manager of NOVA Propulsion for RCA. In the past, she has worked in a wide range of projects including rocket, ramjet and turbojet technologies. Since joining RCA in 1966, she has been responsible for the analysis and design of a number of spacecraft propulsion systems for use in communications, navigation, scientific and meteorological applications. She received an RCA Engineering Excellence Award in 1970 for work in defining the orbit adjust propulsion subsystem (OAPS) for the Atmosphere Explorer spacecraft.

In 1974, she was granted a US patent for her design of "A Dual Thrust Level Monopropellant Spacecraft Propulsion System" which enables a spacecraft to change its orbit in space.

"D.C. FOR JESUS" Washington, DC--A National, anti-gay, March on Washington for "righteousness and morality" has been set for April 29, 1980. According to the Gay Rights National Lobby (GRNL), the March--known as "Washington for Jesus" and "One Nation Under God"--may have very serious implications for the Lesbian/Gay movement and other human rights movements.

"Washington for Jesus" appears to be gaining widespread support in the fundamentalist Christian community. Literature indicates that their goal is 1 million people for the event. Informed sources indicate that over 100,000 people have already made reservations to attend.

While an ordinary religious revival in the nation's capital should not be of major concern, this particular event does not appear to be just a simple religious revival. A number of progressive organizations have concluded that the heavy hand of the "new right" is behind the rally. These groups believe that the rally's real goals are not religious but political. Many fear that the rally's organizers will attempt to use the cover of a religious event to try to impose their own brand of political "morality" on elected officials and that they will attempt to influence the Congress on a wide variety of issues, including civil rights for Gays, prayer in public schools and abortion. S.F. MEMORIAL

Although 5,000 to 10,000 were expected, around 40,000 people marched down San Fran-

cisco's Market Street to City Hall carring lighted candles as a memorial to Harvey Milk, the gay City Supervisor who was gunned down by Dan White, an ex-Supervisor, on Nov 27th, The march was peaceful. 1978. Various singers and speakers shared their sentiments with the crowd, who applauded and raised their candles to show approval. MC Cleve Jones (a former Phoenix resident), spoke movingly and forcefully of the anti-gay hatred that was the basis of Dan White's murder of Harvey Milk and how ending such hatred was what Harvey Milk stood for. The San Francisco Gay Men's Chorus sang several songs, and Jones commented that although Harvey Milk "Lived and died an atheist," he didn't think Harvey would mind a little gospel according to Sylvester, whereupon recording star Sylvester closed the evening with "Jesus Loves Me." The crowd dispursed quietly, and the police riot squad stationed nearby had nothing to do but watch.

The week it was re-HOLLYN leased, CRUISING was **Rick Casillas** the most popular picture in the country, But making over \$5 million. attendance was cut almost in half the second week. The same thing happened the third week, by which time most theatres had either dropped the film or added, a second feature. At this point the movie appears destined to lose money. It's too soon to say the same for WINDOWS, which until March was only being shown in the largest cities. But WIN-DOWS has not had even the initial success that CRUISING had. Unlike CRUISING, WINDOWS has been officially boycotted by the

Also too soon to be sure about is what part the gay media and activists have played in the success or failure of these films. One United Artists spokesperson claimed that CRUIS-ING would have been forgotten in ten weeks if it hadn't been for the protests. As it is, the film may be forgotten before that. But every press release 6 for the film mentioned the protests in the first sentence, and the management of theatres showing CRUISING received promotion-1 al packages that cited the protests as free publicity. It can't be doubted that the makers of CRUISING were trying to manipulate the gay community, and to the extent that anyone, gay or straight, went to see the film because of the protests, the moviemakers succeeded.

But the week of it's release, CRUISING was the most popular film in all but three major cities -- San Francisco, Boston and gave NIJINSKY an 'R' rating due Washington, DC -- where the protests were heaviest. )) showing CRUISING have notices posted in the box office, that in the opinion of the

theatre chain the picture should be rated 'X' and that no one under 17 will be admitted. In Chicago, however, the city's Board of Film Review allows everyone to see the picture, regardless of age. While reported violence against gays is on the rise, no specific instances have yet been directly related to either of these films.

In an unusual move for a foreign film, LA CAGE AUX FOLLES has been nominated for 3 Academy Awards -best director, adapted screenplay and costume design -- in regular competition with American movies. It wasn't eligible for Best Foreign Language Film, since France had another official entry in that category, but LA CAGE has already won the Golden Globe Award as Best Foreign Film. These are believed to be the first Oscar nominations for a movie with a gay theme.

On March 20 in Los Angeles and in New York ten days later, celebrities such as Jacqueline Onassis and Barbara Streisand were hosting the premiere of NIJINSKY, Paramount's movie biography of the turn-of-thecentury ballet star who died in an institution, torn by conflicts over his bisexuality. Director Herbert Ross claims it is the first major American movie in which a homosexual relationship is portrayed as a normal one. and that sneak preview audiences rooted for the relationship to The Motion Picture Assucceed. sociation has denied Paramount's official position that the MPA to the homosexual content.

JERRY BROWN GOES TO HELL?

A Christian Fundamentalist paid \$4000 for a full-page ad in the Los Angeles <u>Herald-Examiner</u> to say that Gov Jerry Brown is wrong to support gay rights. Vergil Grove used the headline: "No, No, Mr. Brown! God's answer to Gays is Nay, Nay!" plus reproductions of recent news stories that show Brown's appointment of a gay judge and his pro-gay political stand.

In a letter that is part of the fullpage ad, Grove tells the governor that he is "headed straight to hell unless you allow God's grace to save your needy soul..."

He warned Brown that "over 50 million Christian people in America of all faiths" would not "allow such a person as you to become their commander-in-chief, to be their leader when your own life is one of confusion."

GAY FOSTER HOMES FOR GAY KIDS In New Jersey, the Department of Human Services says it has placed 5 to 10 male and female teenagers in lesbian-headed foster homes in the past four years. These children were experiencing behavioral problems. The program, officials admitted, was almost an accident, but was continued when it was proven that there are increasing numbers of gay teenagers. The teenagers were placed in the lesbian foster mothers care with the approval of their natural parents, and the full understanding of the teens. Although no further study has been made, spokeswoman Anne Burns admits that the placements seem to be working out well. Seattle is another city that places gay teens into gay homes routinely. DUPCOMING LEGISLATION

The following are bills which are presently in either the House or the Senate. Some of these bills are discriminatory and you may wish to respond to them. You may request copies of any bill by calling 255-4133. This is a free service for taxpayers.

HB 2377 (Ollison) — Prescribes that the course of study adopted by the State Board of Education shall not include sex education in common, high and unified schools.

HB 2332 (Barr)--Provides a 20% discount to non-profit <u>religious</u>, charitable or govermental organizations on the rental of the AZ Coliseum and Exposition Center.

HB 2248 (Carlson)--Prohibits the sale of any drug-related article (machine, instrument, tool, equipment, contrivance, or device) to minors, and requires a record of sale for all cigarette papers sold.

HB 2417 (Kromko)--Prohibits the sale on school property of sugar products, including candy, confectionary and sugar substitutes, cocoa and cocoa products, soft drinks and soda.

HB 2025--A judge must require the surrender of the drivers license of a person under 19 years of age who is convicted of drunk driving.

HB 2026--Effective Jan 1, 1982, motor vehicles would not be registered by the state until the owner filed proof of owning auto insurance.

HB 2239 (Goudinoff)--Relates to cities, towns or counties which prescribe the establishment of age restrictive zones. This bill prohibits age restrictions in senior citizen communities, making them open to families with children. This bill is retroactive.

SB 1031--Vehicle emissions testing would be repealed.

SB 1127--Is an abortion harassment bill titled Child Protection Act. The bill would force doctors to lie about the risks involved in abortion, restrict hospitals from performing abortions unless to save the life of the woman, restricts funds for family planning, would require burial or cremation of the aborted embryo.

SB 1037--Requires the repeal of the 55 mph speed limit.

SB 1117 (Camping) -- This bill was originally introduced to out-law "sexual devices" (dildos, etc), anyone selling sexual devices would be subject to arrest. The "sexual devices" portion of SB 1117 was removed Feb 25th. Since that time Sen Camping has re-amended this section so that it includes, not only, sexual devices, but also sexual stimulants (such as Rush). The bill was re-amended at a 22-6 vote and has passed the Senate.

If enacted the bill will effect the bars and other establishments and individuals selling amyl nitrate.

HB 2131 (Camping)--Outlaws <u>all</u> sexual conduct, including homosexuality, heterosexuality and masterbation. It also out laws vibrators, condoms and flavored douches.



The long-awaited trial of a new vaccine against Type B Hepatitis Virus (HBV) has begun in Los Angeles, San Francisco, St Louis, Denver and Chicago. The HBV vaccine developed by Merk & Co will be tested during the next two years. This marks the first time a vaccine has been developed for a sexually transmitted disease and is being accomplished with the active participation of one of the highest risk groups--gay men. April 2: Mirabeau, French statesman and writer who made public the homosexuality of Frederick the Great's brother, Prince Heinrich, the man who had been offered the kingship of America when Washington rejected it, dies at forty-two, 1791.

April 8: The membership of the American Psychiatric Association upholds the decision of its board of trustees to drop homosexuality from its list of mental disorders, 1974.

April 14: Composer George Frederic Handel, who almost singlehandedly started the rage for Italian castrati in England and who, though biographical evidence is scanty, was almost certainly gay, dies in London, 1759.


April 18: Vice President William Rufus De Vane King, rumored to be the First Lady of bachelor President James Buchanan and referred to in his day as "Miss Nancy," dies at Cahawba, Arkansas, 1853.

April 19: Bruce Edgar, an 18 year-old freshman at the University of Wisconsin, is turned down for a job as a Bunny at the Lake Geneva Playboy Club, 1978.

Ross just finished another movie involving homosexuality. "Nijinsky", about the life of the famous Russian ballet dancer. "He loved and lived with Sergei Daighilev, the director of his dance company, and after an argument Nijinsky married one of the girl dancers and Diaghilev refused to speak to him. Nijinsky went mad and spent the rest of his life in and out of sanitariums."

Ross's intention in this film "is to explain the mystery of that madness and his agony over his bisexuality in a sensitive and sympathetic way." (DATA-BOY OCT 19, 1979)



If there were any questions about where the leader of Iran stands on the issue of gay rights, a recent interview in the <u>New York Times</u> Magazine by Italian journalist Oriana Fallaci makes it abundantly clear that the Ayatollah Khomeini's thinking is still in the 7th Century.


In a new low in journalism, <u>Spotlight</u>, a newspaper based in Washington, DC, ran

a distorted reactionary article on the March on Washington (Oct 14, 1979).

Some "highlights" from the article are: "Organizers of the perverts' National March on Washington, claim that the mob of homosexuals will be larger (than 100,000); this claim is difficult to assess because homosexual militants are always inflating their figures ... The purpose of the demonstration will be to pressure Congress to enact a law granting special legal privileges to sex deviants: homosexual leaders have often said that they want the right to have sex with children (intergenerational sex is their euphemism)".

Spotlight wrote of Coor's "open support for, and advocacy of, the perverted homosexual way of life".

Proving that old ideas die hard, the newspaper went on to say, "... any tourist planning to visit the Nation's Capital should be aware -- particularly if children may accompany you -- for days before and after Oct 14, tens of thousands of sex deviates will be swarming on the streets of Washington. You or your children may be their victims; at other such rallies, the perverts have exhulted in performing sex acts in public. This pattern will likely repeat itself in Washington, as the degenerates begin to stream into the city from thru out the nation and 'cruise' for partners." (DATA-BOY OCTOBER 18, 1979)



s.t. riot damage costs less then expected SAN FRANCISCO', CA--Although the cost of the riot following the Dan White manslaughter conviction of City Supervisor Harvey Milk and Mayor George Moscone on May 21, 1979 had been estimated at \$1 million, recent official figures indicate that the actual total is much less. The city and county of San Francisco are requesting \$226,000 in state aid for damages and expenses incurred during the riot at City Hall. In addition, they are requesting \$57,000 for the extra security during White's murder trial.

According to the request, the cost of police/fire services was nearly \$50,000. \$175,000 was the cost of damage to public property, which includes 12 police cars, a motorcycle and a motor scooter destroyed by arson; 14 damaged police cars; broken glass and iron work in City Hall and other public buildings and parking meters and trash receptacles that had to be replaced.

The request estimates the damage to public and private property at \$250,000, bringing the total cost of repairs to only a third of what had originally been estimated. These figures do not include claims made against the city and county by police and civilians injured during the riot.

sought to become the first admitted homosexual permitted to "Miliserve in the military. tary life is not ... an 8 to 5 job," a Captain explained. "It is a 24-hour job." And with that, he urged the removal of Cutsinger from the service. The hearing board agreed with the captain, voting on Oct. 2, 1979, 2 to 1 recommending an honorable discharge for Cutsinger as "Unsuitable for military service." His commanding officer approved the discharge and the young soldier was on his way out!

"They said being a homosexual was incompatible with military service ... but I proved that un-"But true," Cutsinger said. they ain't going to get away with it. I'm going to court, and I've got a good chance of winning reinstatement." Cutsinger's discharge has set the stage for a major legal test of the military's policy against homosexuals ... a policy that is coming under scrutiny in the nation's courts. The outcome of legal assaults like Cutsinger's could have a far-reaching impact on the armed services.

According to the Department of Defense, in 1977 -- the last year for which information is available -- 1,311 enlisted personnel were discharged as homo-(In addition, a spokessexuals. person adds, a "statistically insignificant" number of officers were discharged.) But the military's prohibition against homosexuals is based on the grounds that their presence would impair discipline, morale and security --particularly in the intimate atmosphere of the barracks and in the intense time of combat, where mutual trust and confidence is imperative.

WHY CARTER IS WINNING FROM WASHINGTON Have you noticed how President Carter is winning most of the primaries without campaigning in those areas? While all the other candidates are visiting with the people and making speeches, Carter sits quietly in Washington. Yet, Carter is still winning. The inflation rate is high, there are 50 American hostages in Iran, Russia invaded Afganistan, the ERA is not law, gas is over a dollar a gallon - - yet Carter is winning. Why? According to COMPUTER-WORLD (2/18/80), Carter is not just sitting still in the White House. Since the day after Thanksgiving, Carter-Mondale Presidential Committee (CMPC) staff members have been directing computers to send out "tens of thousands" of letters urging Americans to support the incumbents in the White House.

The process is called "political persuasion", and it can only be done effectively with computers that do everything but lick the stamps. According to Glenn Cowan, Deputy Director of voter contact for CMPC, "The impact is much greater in sending a personalized letter."

By "personalized", Cowan means "massproduced to look personalized" - the apparent key to success in winning political and monetary support for candidates in the modern age. CMPC sent out thousands of "personalized" letters per day to Democratic and Independent voters in New England in Feb. and March prior to the primaries in those states.

Cowan explained that the letter thanks the supporters for their support, encourages their continued support, reminds them when election day is and encourages them to vote. "We personalize all of them, and produce them at a rate of two per second," according to Cowan.

CMPC gets names and addresses from two sources: voter registration tapes and the phone books - - "All very public information," Cowan noted.

Carter's direct-mail staff indicated \$400,000 has been raised thru directmail methods. In contrast, Kennedy's direct-mail efforts have netted about \$700,000 thru similar but less sophisticated methods.



In charge of Kennedy's direct-mail fund-raising effort is the Craver, Matthews and Smith Co. The firm deals mainly with such citizen's groups as the American Civil Liberties Union, National Organization for Women (NOW), Common Cause, National Abortion Rights League and Planned Parenthood - - and has about 50 clients. Most, but not all of the political clients are democratic and all are "on the left side of the aisle".

In overall contributions from such sources as fund-raising dinners, however, Carter leads Kennedy with \$6.7 million, almost double Kennedy's \$3.4 million.

CHILDREN OF LESBIANS Beverly Hoeffer of the University of California at San Francisco's School of Nursing says, that kids of lesbians are different from kids of straight women.

She found that 40% of the sons of lesbians tested using the "Sex Role Concept Scale", scored as sex type feminine, meaning they were gentler and more concerned with other people's feelings than other boys. None of the sons of straight mothers did. 50% of the daughters of lesbians scored as sex type masculine, with stronger qualities of leadership and outgoingness; again none of the daughters of Straight mothers did. 17 (Lesbian Tide, Mar/Apr, 1980) transpeople in belfast

Men who cross-dress as women are given special identity. 010 cards to help them. avoid arrest when they travel on the streets wearing female clothes. The identification is issued by a Belfast clinic that deals with men who want

- to become women.

One regular at the Windsor House Clinic at Belfast City Hospital said, "Identification is vital in Belfast, where there are regular body searches in the streets."

The card states their name and shows that they are with the Windsor House Unit, a unit specializing in nervous illnesses. "I suppose not many people would think there was much wrong with our nerves," said one patient, "It takes a bit of nerve to go around Belfast and allow women searchers at security gates to search and frisk you."

Transsexuals and transvestites * have special problems because of the troubles in Northern Ireland. Police and soldiers often mistake them for bombers or gunmen disguised as women.

MEXICO---Homosexuality is far from a taboo subject in the Mexican media, and in fact may be a more

common one than in the US. By watching Mexican TV, it is clear to see that gays are a favorite topic of humor and ridicule. A few examples of TV shows are "Los Polivoces" ("The Poly-Voices), "La Cosquilla" ("The Tickler") and "Siempre en Domingo" ("Always on Sundays").

In Mexico, homosexuality does not constitute a crime when carried out in private and between consenting adults. However, police raid the bath houses, bars and parties. The harassment of homosexuals appears to have two principle functions, 1) simple extortion, 2) create a "favorable" image to the public. Legal grounds for prosecution of homosexual acts exists in only one type of case mentioned by the Penal Code, Article 201, "Corruption of Minors". It imposes imprisionment of 6 months to 5 years for such a crime. The crime is defined as "acts of corruption which when practiced repeatedly causes the minor to acquire the habits of alcoholism. the use of drugs or toxic substances and prostitution and homosexual practices".

NEWS BRIEFS

HELSINKI, FINLAND--The SETA, a Finnish Organization for Sexual Equality has filed discrimination charges against the Finnish Goverment. The charges stem from the gay minority and violation of the United Nations Human Rights Charter. Although homosexual acts are no longer a criminal offense in Finland, Law RL 20:9:2 makes it illegal to discuss homosexuality in public, except in a negative manner. SETA feels the law curtails freedom of speech for Finish gays.


